Residency Requirements for noncommercial lobster and noncommercial scallop: Any individual who has been domiciled in Maine for the past 6 months preceding the date of application is eligible for a resident license. A corporation is eligible for a resident license if it has been created and exists under the laws of Maine and it has existed in Maine for 6 months preceding the date of application. A firm or partnership is eligible if all of its officers or partners have been domiciled in Maine for 6 months preceding the date of application. For the purposes of this license application, a resident is a person who:

- A. If registered to vote, is registered in Maine;
- B. If licensed to drive a motor vehicle, has made application for a Maine motor vehicle operator's license;
- C. If the owner of one or more motor vehicles located within the State, has registered at least one of the motor vehicles in Maine: and
- D. If required to file a Maine income tax return on the previous April 15th, filed a Maine income tax return.

Note: According to Title 12 MRS Section 6421(5), a noncommercial lobster and crab fishing license may only be issued to an individual who is a resident.
