

2025 Lobster Industry Survey Results

At the Lobster Advisory Council (LAC) held on April 28th, 2025, the Council unanimously voted to collaborate with the Department to poll Maine's lobster industry on current and future management. The goal of this survey was to collect input on Maine's lobster resource and fishery, as well as help inform the Department's discussions at the Atlantic States Marine Fisheries Commission (ASMFC). The survey was sent to 4,697 industry members with response rate of 29%. The LAC and the Department greatly appreciate your participation in this survey.
