Bait Information from Primary Bait Dealers

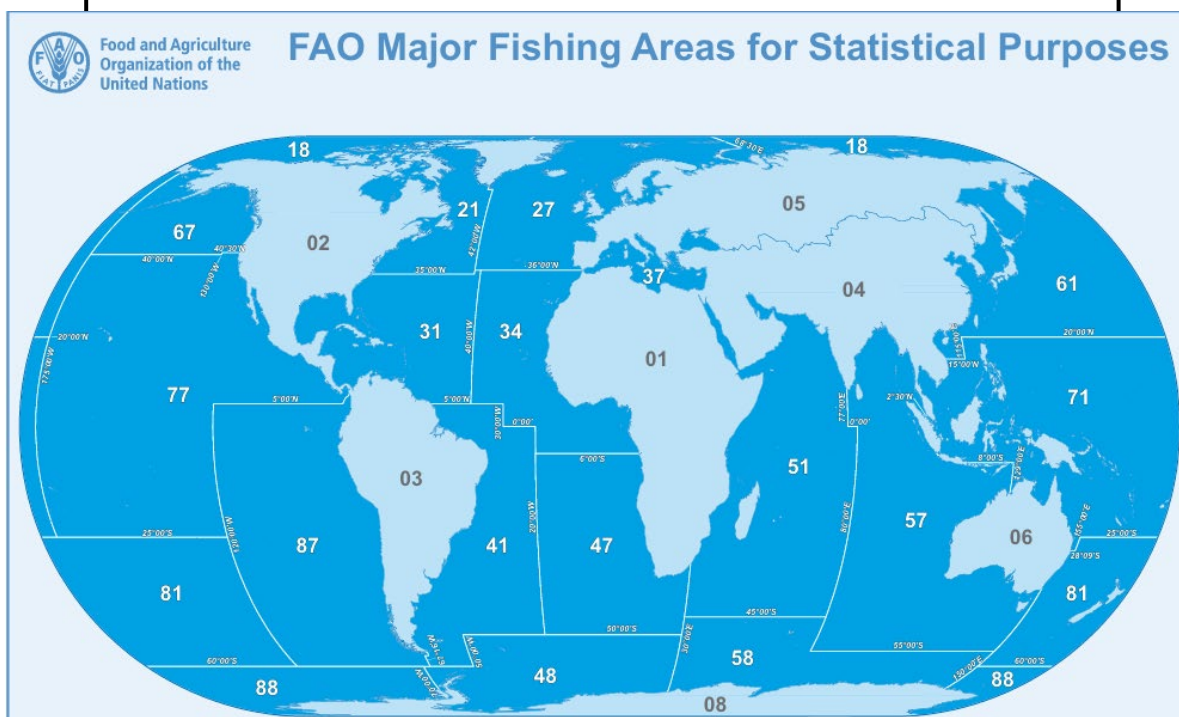
Directions: Check off what bait you have caught and sold in 2025. Utilize the map below to help you identify what region the bait is from.
