 Describe the type and amount of aquaculture to be conducted during the new lease term:

Same as previous term. Crassostrea virginica cultivated in surface bags from seed to market size, full lease area utilized. Each year farm is re-seeded with 20-40k oyster seed from Muscongus Bay.

Describe the amount of aquaculture conducted on the lease site during the previous lease term, including but not limited to seeding, cultivation or harvest of organisms:

Lease was transferred from DLW Enterprise to Long Cove Sea Farm in 2022. I believe previous lease term involved annual reseeding of Crassostrea virginica with ~20k 2.5mm seed from Muscongus Bay and tended to in surface bags until harvest (2-3 years). Harvesting took place throughout the summer and fall season. Bags containing oysters were consolidated and sunk to seafloor during winter season.

3. Suspended culture gear can attract birds that roost on the gear and defecate, potentially creating a pollution source impacting shellfish held within gear. In order to comply with the National Shellfish Sanitation Program (NSSP) Model Ordinance (MO), if the lease site is permitted for the culture of shellfish in suspended gear, please include a description of mitigation or deterrent measures to minimize the potential pollution impacts of birds at the lease site. Examples may include:

- Suspended gear submerged at depth sufficient to deter roosting for at least two weeks before harvest
- Attaching physical dterrents (i.e. zip ties) to gear
- The lease site is used to culture shellfish seed only
- Only adductor-only shellfish are cultured on the lease site


We will continue monitor the site for bird presence. We will attach physical deterrents (15 inch zip ties) and we will place harvested oysters in submerged bags for two weeks before selling product if gear is attracting birds.


