 Describe the type and amount of aquaculture to be conducted during the new lease term:

South Bay has been operated as a site with net pen culture of atlantic Salmon on a 3 year notation with periods of fallowing between harvesting and Stocking. It is our plan to continue using this site as we have previously.

Describe the amount of aquaculture conducted on the lease site during the previous lease term, including but not limited to seeding, cultivation or harvest of organisms:

This site has been in use since the last renewal. Stocked in 2015, 2018, 2021 and just recently in 2024. Growout is approximately 18-24 months, with fallowing until the next stocking.
