We will grow blue mussels (*Mytilus edulis*), using suspended culture techniques. We anticipate harvesting approximately 100,000 to 150,000 pounds per year.

The lease is 15-acres in size, located east of Hardwood Island in Blue Hill Bay in the Town of Tremont, Hancock County.

2. Describe the amount of aquaculture conducted on the lease site during the previous lease term, including but not limited to seeding, cultivation or harvest of organisms:

We grew blue mussels (*Mytilus edulis*), using suspended culture techniques. We harvested approximately 100,000 to 150,000 pounds per year. We also collected mussel spat, but in the past few years the lease site has not been viable for spat collection.




