Re: Participation Instructions -Registered Participants & Members of the Public

Dear Registered Participant:

You are receiving this communication because you registered to participate in the hearing noted above. The hearing is being conducted remotely via Microsoft Teams. Information about how to access the remote proceeding was provided to you with this document. Instructions about how to participate in the proceeding are organized by registration status (i.e. offering testimony or *not* offering testimony) and provided below. If you are unsure of how you registered there is a table at the end of this document that specifies registration status. The information in sections 3 and 4 apply to all participants regardless of registration status.

It is likely that the hearing will need to be continued on March 29, 2022 (an announcement will be made before the end of the hearing on March 28, 2022 and an update will be posted to DMR's website). Therefore, participants should plan on being available both nights, especially if you have registered to provide testimony. The proceeding will start at 5:00 p.m. each evening and will likely conclude by 9:30 p.m. However, the 9:30 p.m. end time may be extended by the Hearings Officer as necessary.

1. Persons Not Offering Testimony

You may watch the proceeding on your computer/smartphone or listen to the proceeding by dialing-in using a telephone. If you dial-in to the proceeding with a telephone, you will not be able to see any materials that may be screen shared. If you are participating in the proceeding using a computer/smartphone, please keep your camera off and device on mute (persons who call-in should also stay on mute). This helps improve connectivity and avoids the potential for disruption. If you keep your camera on, please note that everyone will be able to see you and anything that might be happening the background.

2. Persons Offering Testimony

You need to participate in the proceeding with a computer or smartphone that has a working camera and audio. This is so we can see you take your oath and hear your testimony. Except when providing testimony, please keep your camera off and device on mute. This helps improve connectivity and avoids the potential for disruption. If you elect to keep your camera on, please note that everyone will be able to see you and anything that might be happening the background. **Testimony Time Limits:** You will have three minutes to provide your testimony. DMR staff will keep time and let you know when your time has ended. The time allotted for testimony cannot be ceded to others. After you provide testimony, you must remain available for questioning. For full consideration, your testimony needs to relate to the criteria DMR must legally consider in evaluating standard lease proposals. If you decide not to provide testimony, you do not need to contact DMR. Testimony should not be pre-filed.

Proposed Pre-filings: Individuals who registered to provide testimony must pre-file materials or documents for consideration as an exhibit no later than 4:00 p.m. on March 23, 2022. Proposed pre-filings must comply with what is specified below:

- No more than two pre-filings can be filed. Each pre-filing cannot exceed more than five pages (single sided) in length.
- The pre-filing must be the document or material (i.e. hyperlinks are not acceptable)
- Pre-filings must be labeled with the name of the individual who submitted the documents/materials.
- Pre-filings must be submitted electronically to: <u>DMRaquaculture@maine.gov</u>. Please also copy the following email addresses: <u>info@acadia-aquafarms.com</u>; <u>Dkallin@dwmlaw.com</u>; <u>scaulk@dwmlaw.com</u>; and <u>plyons@eatonpeabody.com</u>
- Individuals are responsible for screen sharing their own pre-filings during the hearing.

3. Cross-Examination (i.e. asking questions of the parties/DMR)

The parties to the proceeding are the applicant (Acadia Aquafarms) and the consolidated intervenor group (Concerned Citizens of Eastern Bay). DMR is not a party to the proceeding, but staff scientists will offer testimony about the site visit and report.

Questions are an opportunity to ask clarifying questions about the testimony provided. Anyone who registered may ask questions. However, as a collective group, members of the public will have 15 minutes to cross-examine the applicant, intervenor, DMR, and any other official that may present testimony (15 minutes per each party/entity). Individuals should ask no more than one question at a time, so others have an opportunity to ask questions during the specified timeframe. Members of the public cannot cross-examine one another.

Please avoid prefacing questions with comments or other information. Question should be direct and relevant to the testimony provided. The Hearings Officer will limit questions that are unduly repetitious or irrelevant.
