4/1/2023	11/1/2023	<u>Pirates Creek:</u> From the abandoned car on an unnamed point of Swards Neck (northeast of Pirates Creek) south to Hannah Miller Point to the adjacent subtidal.	Closed
9/5/2022	6/21/2023	<u>Mowry Beach:</u> West of a line beginning at the East tip of Mowry Point, then running East to the US/Canadian border to the navigational green can buoy#5, then to the Southwest wall of the Spark Plug(lighthouse), then running west to a red painted post located on the shore at the end of Easy Street.	Closed
5/1/2023	12/01/2023	<u>Lawrence Factory/Birch Point:</u> From the point on the mainland across from Major Island southeast along the mainland to the southeast tip of Birch Point (north side of Birch Point Peninsula).	Closed
6/1/2023	1/1/2024	<u>Globe Cove:</u> West of a line beginning at a red painted post located on the shore of an unnamed point approximately 265 yards southeast from the rough boat landing on Cox Lane, then running northeast to the southeast tip of an unnamed point forming the north shore of Globe.	Closed
6/29/2022	Indefinite	<u>Minzey Place</u> – South and west of a line beginning at a red painted post on the southeast tip of West Quoddy Bar, running southeast to the shore approximately 600 yards east of the intersection of the West Quoddy Head Road and Carryingplace Road. (covers State Pollution Closure ES, R1)	Closed

6/29/2022	Indefinite	<u>Johnson Bay and Lubec Narrows</u> – South and east of a line beginning at the northern tip of Diamond Point, then running northeast to the northern tip of Popes Folly; AND south of a line beginning at the northern tip of Popes Folly then running east to the US/Canadian Border; AND west of a line following the US/Canadian Border south to a point east of Mowery Point; AND north of a line beginning at a point on the US/Canadian border east of Mowery Point then running west to the eastern tip of Mowery Point. (covers State Pollution Closure ET, P2)	Closed
