CHAPTER NUMBER AND TITLE: Chapter 55 Fishing in the Saco River

CONCISE SUMMARY: On June 10, 2023, DMR adopted an emergency rule to expand an existing area on the Saco River closed to fishing. DMR is adopting this same rule as regular rule-making. Consistent with the emergency rule, this rule modifies Maine's Gear Restriction Regulation, Chapter 55.99 to close the waters of the Saco River upstream of the Route 9/Main Street bridge between Factory Island, Saco and Mechanics Park, Biddeford, to the head of tide. This is necessary to prevent high levels of catch and release mortality observed this season and which negatively impacts the striped bass resource.

CHAPTER 55 GEAR RESTRICTIONS

55.99 Fishing in the Saco River above the footbridge Route 9/Main Street bridge between Saco and Biddeford

It shall be unlawful to fish on the waters of the Saco River from the upstream side of the footbridge Route 9/Main Street bridge between <u>Factory Island</u>, Saco and <u>Mechanics Park</u>, Biddeford, upstream to the head of tide, commonly known as the "Cataract Dam".

Basis Statement

On June 10, 2023, DMR adopted an emergency rule to expand an existing area on the Saco River closed to fishing. DMR is adopting this same rule as regular rule-making. Consistent with the emergency rule, this rule modifies Maine's Gear Restriction Regulation, Chapter 55.99 to close the waters of the Saco River upstream of the Route 9/Main Street bridge between Factory Island, Saco and Mechanics Park, Biddeford, to the head of tide. This is necessary to prevent high levels of catch and release mortality observed this season and which negatively impacts the striped bass resource.

Summary of Comments

On June 21, 2023, the rule was posted on DMR's website. Notice was also published on June 21, 2023, in the five major daily newspapers by the Secretary of State; and electronic messages were sent to individuals who subscribe to DMR's rulemaking and aquaculture notices. A public hearing was held both in-person and remotely at 4:30 p.m. on July 12, 2023. The in-person hearing was held at DMR's Augusta office, and the remote component was held via Microsoft Teams. No members of the public attended in-person. The comment period closed July 24, 2023.

DMR Response: Thank you for your comment. Because the proposed rule is focused on the Saco River, we could not expand the current rule-making to include an additional closure on the Kennebec River without reopening the rule for additional public comment. However, we

appreciate this information and will research this situation for consideration of future rulemaking.

After reviewing a lot of info, I would like to add my Public Comment. As far as the Current Emergency Slot of 28-31". It would be GREAT to see this continue. I think Maine should lead the way in Conservation of Striped Bass and also speak to surrounding states such as Massachusetts to have Gamefish status put on Striped Bass.

As far as the Saco River area being closed, this was an amazingly awesome move by the State of Maine to try and stop the poaching, mishandling and so much more that happens in that area. It may even be worth it for the State to look at Banning the use of Live Alewives/River Herring. I sure hope that Maine continues to put the Striped Bass first.

Also a final thought, the recent event in the news about the Large Gill Net that was Killing lots of striped Bass and Sturgeon should be look at as well. This should NOT be allowed going forward. It was clear from the pictures and videos that the gill net holes were large and meant to kill larger fish, these practices are unacceptable. DMR response: Thank you for your comment and concerns about impacts on striped bass. As regards the specific gill net referenced, early media reports were not well informed by the facts of the situation and have since been corrected. The initial reports of significant numbers of dead striped bass and sturgeon were not accurate.

By expanding the area closed to fishing, it is anticipated that catch and release mortality on striped bass will be reduced, benefiting the striped bass resource and improving the likelihood of rebuilding.
