#### NOTICE OF AGENCY RULE-MAKING ADOPTION

CHAPTER NUMBER AND TITLE: Chapter 26: Sea Urchin 2025-2026 Season

#### **CONCISE SUMMARY:**

This regulation establishes open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2025-2026 season. For Zone 1, seasons are established for divers, trappers, rakers and draggers in 2025-2026, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2024-2025 season. For Zone 1, the daily tote limit is nine (9). For Zone 2, 40-day seasons are established for divers, trappers, rakers and draggers in 2025-2026, from which harvesters may only fish up to 30 days of their choosing. This regulation has the same number of fishing days and opportunity days as the 2024-2025 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 12-day season is established for Zone 2 divers, trappers, rakers and draggers in 2025-2026. For Zone 2, the daily tote limit is six (6).

Due to the incorporation of the Flex Harvest option in the previous fishing season, an update to the electronic reporting section for the upcoming 2025-2026 season was made to clarify that the use of the swipe card no longer equates to a fishing day, therefore a portion of the language in Chapter 26.5 has been struck.

#### **26.01** Nighttime Harvesting Prohibition

It shall be unlawful to fish for or take sea urchins during the nighttime hours between sunset (as defined in 12 M.R.S. §6001(46)) and sunrise (as defined in 12 M.R.S. §6001(45)) within Maine's coastal waters.

#### 26.02 Sea Urchin Minimum Size and Tolerance

#### 1. Prohibition

It is unlawful for any person to take, possess, ship, transfer, transport, buy, or sell a sea urchin having a shell measuring less than  $2^{1}/_{16}$  inches in the longest diameter, measuring from the top or bottom of the urchin, exclusive of spines.

## 2. Exceptions to 26.02(1) Prohibition

#### A. Possession Tolerance for All Persons

Any person may possess sea urchins measuring less than  $2^{1}/_{16}$  inches if they comprise less than 5% of any bulk pile.

#### B. Take Tolerance for Harvesters

#### (1) Zone 1 & 2 Divers

Zone 1 & 2 divers may take sea urchins that are less than  $2^{1}/_{16}$  inches if they comprise less than 20% of any bulk pile prior to culling on board.

#### (2) Take Tolerance for All Other Harvesters

All licensed sea urchin harvesters except Zone 1 & 2 divers may take sea urchins that are less than  $2^{1}/_{16}$  inches prior to culling on board.

### C. Sea Urchins Obtained Outside the State of Maine

Any person exceeding the possession tolerance of this regulation for sea urchins measuring less than  $2^{1}/_{16}$  inches shall not be in violation of Chapter 26.02 if that person is in possession of a bill of lading for the amount of the sea urchins exceeding the tolerance amount showing those sea urchins were lawfully obtained from an origin outside the State of Maine. The absence of a bill of lading shall be prima facie evidence that the sea urchins were taken from waters within the jurisdiction of the State of Maine.

#### 3. Tolerance

Tolerance shall be determined by numerical count of not less than ½ bushel taken at random from various parts of the bulk pile or by count of the entire bulk pile if it contains less than ½ bushel.

If any person is found in possession of sea urchins measuring less than  $2^{1}/_{16}$  inches that comprise more than 5% of the bulk pile pursuant to 26.02(2)(A) or 20% pursuant to 26.02(2)(B)(1), that bulk pile shall be considered contraband and subject to seizure.

#### 4. Culling Requirement

Sea urchins measuring less than  $2^{1}/_{16}$  inches must be culled on board immediately after take, and liberated alive into the marine waters.

#### 26.03 Sea Urchin Maximum Size and Tolerance

#### 1. Prohibition

It is unlawful for any person to take, possess, ship, transfer, transport, buy, or sell a sea urchin having a shell measuring more than 3 inches in the longest diameter, measuring from the top or bottom of the urchin, exclusive of spines.

## 2. Exceptions to 26.03(1) Prohibition

#### A. Possession Tolerance for All Persons

Any person may possess sea urchins measuring more than 3 inches if they comprise less than 5% of any bulk pile.

## B. Take Tolerance for Harvesters

#### (1) Zone 1 & 2 Divers

Zone 1 & 2 divers may take sea urchins that are more than 3 inches if they comprise less than 20% of any bulk pile prior to culling on board.

#### (2) Take Tolerance for All Other Harvesters

All licensed sea urchin harvesters except Zone 1 & 2 divers may take sea urchins that are more than 3 inches prior to culling on board.

### C. Sea Urchins Obtained Outside the State of Maine

Any person exceeding the possession tolerance of this regulation for sea urchins measuring more than 3 inches shall not be in violation of Chapter 26.03 if that person is in possession of a bill of lading for the amount of the sea urchins exceeding the tolerance amount showing those sea urchins were lawfully obtained from an origin outside the State of Maine. The absence of a bill of lading shall be prima facie evidence that the sea urchins were taken from waters within the jurisdiction of the State of Maine.

#### 3. Tolerance

Tolerance shall be determined by numerical count of not less than ½ bushel taken at random from various parts of the bulk pile or by count of the entire bulk pile if it contains less than ½ bushel.

If any person is found in possession of sea urchins measuring more than 3 inches that comprise more than 5% of the bulk pile pursuant to 26.03(2)(A) or 20% pursuant to 26.03(2)(B)(1), that bulk pile shall be considered contraband and subject to seizure.

## 4. Culling Requirement

Sea urchins measuring more than 3 inches must be culled on board immediately after take, and liberated alive into the marine waters.

## 26.05 Sea Urchin Drag Regulation

1.

- A. It shall be unlawful to fish for, possess or take sea urchins with a drag, or combination of drags, in excess of 5 feet six inches effective fishing width (by measuring from the extreme outside of the mouth of the drag or drags), within Maine's coastal waters.
- B. Escape Panel Zone 2

It shall be unlawful to fish for, possess, or take sea urchins in Zone 2 with a drag that does not have an escape panel.

- (1) Configuration of Escape Panel
  - (a) The panel shall consist of a single layer of netting in the top of the drag above the chains.
  - (b) There can be no liner or other material or device obstructing any part of the panel.
  - (c) The panel must be at least 2 feet deep (from front to back of the drag) and extend across the full width of the drag.
  - (d) The mesh of the netting must be hung "square", not "diamond", that is, the twines of the mesh going one way must run parallel to the front (mouth) of the drag and the twines of the mesh going the other way must run perpendicular to the front (mouth) of the drag, not diagonally.
  - (e) The meshes must measure at least 2 inches from the middle of one knot to the middle of the next adjacent knot.

#### 2. Method of mesh measurement

Mesh size shall be measured by lining up 5 consecutive knots perpendicular to the front of the drag or parallel to the front of the drag and measuring the distance from the middle of one knot to the middle of the next knot with a ruler or tape measure. The mesh measurement shall be the average of the 5 consecutive measures. These measurements must be made at least 2 meshes away from the edges of the panel.

## 3. Exception

It shall be lawful to fish for, take, or possess sea urchins with a drag that qualifies as a scallop drag under Chapter 11.07 if the drag meets the requirements of Chapter 26.05(A).

## 26.07 Sea Urchin Harvesting Season <del>2024-2025</del> <u>2025-2026</u> pursuant to 12 M.R.S. §6749.

Harvesters may choose 15 of the available days in Zone 1 and 30 of the potential 40 available days in Zone 2.

- 1. Zone 1 [as defined by 12 M.R.S. §6749-N(1)]. Harvesters may choose 15 of the available fishing days.
  - A. One season for divers, trappers, rakers and draggers

The Zone 1 season for all sectors harvesters, who have certified Zone 1 on forms provided by the Commissioner, is open Mondays, Tuesdays, Wednesdays, Thursdays and Fridays in November and December 2024 2025, and January and February 2025 2026, except for Wednesday Thursday, December 25, 2024 2025, which shall remain closed. Divers, trappers, rakers and draggers may fish no more than 15 of these days.

- 2. Zone 2 [as defined by 12 M.R.S. §6749-N(2)]. Harvesters may choose 30 of the potential 40 days.
  - A. Early season for divers, trappers and rakers

The Zone 2 season for divers, trappers and rakers who have certified the early season on forms provided by the Commissioner, is open Tuesdays, Wednesdays and Thursdays in October 2024 2025, with the exception of October 1, 2, 7, 8 and 9, 2025 which shall remain closed; Mondays, Tuesdays, Wednesdays, and Thursdays and Fridays in November, 2024 2025, with the exception of November 28 3, 10, and 27, 2024 2025, which shall remain closed; and Mondays, Tuesdays, Wednesdays, and Thursdays and Fridays in December 2024 2025, with the exception of except December 1, 8, 15, 25 and 26 and 31, 2024 2025 which shall remain closed. December 23 and 27, 2024 shall remain open to harvest. Divers, trappers, and rakers may fish no more than 30 of these days.

B. Late season for divers, trappers and rakers

The Zone 2 season for divers, trappers and rakers who have certified the late season on forms provided by the Commissioner, is open December 17, 18, 19, 23, 24, 30 and 31, 2024 December 9, 10, 11, 16, 17, 18, 23, 24, 30 and 31, 2025; Tuesdays, Wednesdays and Thursdays in January, 2025 2026 and February 2025 2026, except January 1 and 29, and 2 and February 17 and 18, 2025 2026 which shall remain closed; and is open March 4, 5, 6, 11, 12, 13, 18, 19 and 20, 2025 3, 4, 5,10, 11, 12, 17, 18 and 19, 2026. Divers, trappers, and rakers may fish no more than 30 of these days.

## C. Early season for draggers

The Zone 2 season for draggers who have certified the early season on forms provided by the Commissioner, is open Tuesdays, Wednesdays, and Thursdays and Fridays in November 2024 2025, except Thursday, and Friday. November 27 and 28, 2024 2025, which shall remain closed; Wednesdays, Thursdays and Fridays in December 2024 2025, and December 23 and 24, 2024 2025, with the exception of December 25, and 26 and 27, 2024 2025, which shall remain closed; Wednesdays, Thursdays and Fridays in January 2025 2026, with the exception of January 1 and 2, which shall remain closed; and February 3, 4, and 5, 2026 and 6, 2025. Draggers may fish no more than 30 of these days.

## D. Late season for draggers

The Zone 2 season for draggers who have certified the late season on forms provided by the Commissioner, is open December 2, 3, 4, 10, 11, 12, 17, 18, 19, 23, 24, 30 and 31, 2024 2025; Tuesdays, Wednesdays, and Thursdays and Fridays in January 2025 2026, except January 1, and 2, and 30, 2025 2026; Tuesdays, Wednesdays, and Thursdays and Fridays in February 2025 2026, with the exception of February 18 and 19, 2026 which shall remain closed, and March 3, 4, 5, 6, 10, 11; and 12, and 13, 2025 2026 are open. Draggers may fish no more than 30 of these days.

#### E. Designation of Zone 2 early or late season:

- (1) A person who holds a sea urchin harvesting license for Zone 2 may not harvest sea urchins in Zone 2 unless that person certifies on forms provided by the Commissioner that the person will fish for or take sea urchins during either the early season or the late season.
- (2) A person who has certified the early or late season may, between May 1<sup>st</sup> and August 15<sup>th</sup> change that certification to the other time period as the time period in which that person will fish for or take sea urchins.

## 26.10 Log Book

See Chapter 8.10(P) Landings Program

#### 26.12 Tagging

Each bulk pile (tote) of sea urchins must be tagged by the harvester once landed on shore. Each tag must include the date of harvest and the harvester license number. The tag must accompany each tote of sea urchins at all times until arrival at the purchasing dealer's licensed facility.

Exception: A harvester who sells a bulk pile (tote) of sea urchins to a licensed dealer at the landing location is not required to tag the tote provided the licensed dealer purchasing the sea urchins tags each tote with the date of harvest and the harvester license number.

## 26.15 Sea Urchin Harvester License Limited Entry System

Beginning August 1, 2004, no new sea urchin harvesting licenses will be issued, and no lotteries will be held.

#### 26.19 Limited Access Areas

Transiting exception:

Any vessel possessing urchins onboard, may transit the Limited Access Area, only if the vessel has all fishing gear (dredges, drags, regulators, buoyancy compensators, fins, tanks, weight belts) securely stowed. Securely stowed shall mean the main wire shall not be shackled or connected to the dredges or drags, and the towing swivel will be at the block or on the winch for draggers, while regulators, buoyancy compensators and tanks should be disconnected with fins and weight belts removed for divers.

- 1. Whiting and Denny's Bay Area (Zone 2). Harvesters may choose up to 12 days of the following applicable season open days for the Whiting and Denny's Bay limited access area to fish within their 30 days available for harvest.
  - A. Early season for divers, trappers and rakers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by divers, trappers, and rakers who have certified the early season on forms provided by the Commissioner on Tuesdays in October 14, 21, and 28, 2025 and Tuesdays in November and December, 2024 2025; except for Tuesday, December 31, 2024, which shall remain closed.

B. Late season for divers, trappers and rakers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by divers, trappers and rakers who have certified the late season on forms provided by the Commissioner on December 23 and 30, 2025 24 and 31, 2024; Tuesdays in January 2026, and February 3, 10, and 24, 2026 2025, and March 4 and 11, 3, 10, and 17, 2026 2025.

## C. Early season for draggers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by draggers who have certified the early season on forms provided by the Commissioner, on November 7, 14 and 21, 2024 6, 13 and 20, 2025; December 5, 12 and 19, 2024 4, 11 and 18, 2025; January 2, 9, 16, 23 and 30, 2025 8, 15, 22 and 29, 2026; and February 6, 2025 4 and 5, 2026.

## D. Late season for draggers

It shall be unlawful to fish for, take, or possess urchins west of a line starting at the western end of Mahar Point, Pembroke, due south to the nearest point of land on Crow Neck, Trescott, to include all of Whiting and Denny's Bay except by draggers who have certified the late season on forms provided by the Commissioner, on December 12 and 19, 2024 4, 11 and 18, 2025; January 9, 16, 23 and 30, 2024 8, 15, 22 and 29, 2026; February 6, 13, 20 and 27, 2025 5, 12 and 26, 2026; and, March 6 and 13, 2025 5 and 12, 2026.

## **26.20 Targeted Closures**

It shall be unlawful to fish for, take, or possess urchins taken by any method within any of the following closed areas. All directions are relative to True North (not magnetic).

### Transiting exception

Any vessel possessing urchins onboard, may transit these targeted closures, only if the vessel has all fishing gear (dredges, drags, regulators, buoyancy compensators, fins, tanks, weight belts) securely stowed. Securely stowed shall mean the main wire shall not be shackled or connected to the dredges or drags, and the towing swivel will be at the block or on the winch for draggers, while regulators, buoyancy compensators and tanks should be disconnected with fins and weight belts removed for divers.

## 1. Cat Ledges Area:

It shall be unlawful to fish for, take, or possess urchins inside a line drawn from the southwestern tip of Pratt Island, Southport Island, then south to Red Gong "4CL", then northeast to the prominent point on the eastern shore of Christmas Cove.

#### 26.30 Sea Urchin Zone Council Elections

#### 1. Elections and Term

The Sea Urchin Zone Council shall hold its first election for those members specified in 12 M.R.S. §6749-X, sub-§1 by March 2008, and a biennial election thereafter beginning in December 2010, to re-elect or replace the elected members whose terms are expiring. Council members shall have terms of two years.

#### 2. Election of Council Members

Election of council members shall be by a plurality vote of eligible voters participating in the election.

#### 3. Eligibility of Council Members

To be eligible for election as a council member an individual must hold a valid license of a type specified in 12 M.R.S. §6749-X, sub-§1 and be at least 18 years of age. An individual who has been convicted of a marine resources law violation within the previous 6 years is not eligible for election as a council member unless a waiver from this requirement has been granted by the commissioner for good cause as determined by the commissioner in his or her discretion.

## 4. Eligibility to vote

An individual who holds a valid license of a type specified in 12 M.R.S. §6749-X, sub-§1 and is at least 18 years of age shall be eligible to vote to fill vacant council positions representing the same type of license held by the voter. If the license type is specific to Zone 1 or Zone 2, as defined under 12 M.R.S. §6749-N, then the individual shall only be eligible to participate in the election if the individual holds the eligible license in the same zone.

## 5. Election process

Each individual shall have one vote in the election for each seat for which they are eligible to vote. The vote shall be by secret mailed ballot and the ballots shall be collected by the Department of Marine Resources. The ballots shall be tallied, and the results shall be made known to the Commissioner, members of the Sea Urchin Zone Council and the public.

#### 6. Vacancies

Any vacancy occurring in the membership of the Sea Urchin Zone Council including one created by reason of resignation, ineligibility, or death shall be filled by the candidate from the most recent election who received the second greatest number of votes. If no such candidate is available or is willing to serve as representative, then a special election will be held. Council members elected to fill a vacancy shall serve for the remainder of the vacated member's term.

### 7. Removal of Council Members

A council member whose urchin license is suspended or revoked, or who fails to renew the license, shall automatically be removed from the Sea Urchin Zone Council. A Council member who misses three consecutive meetings without notifying an officer or other Council member of the intended absence from a meeting may be removed from the Council by affirmative vote of the Council.

#### 26.40 Tote Limits

#### 1. Zone 1

It is unlawful for Zone 1 sea urchin divers, rakers or trappers to fish for, take, possess at sea, or land more than nine (9) standard size stackable fish totes of sea urchins per day. While on shore, Zone 1 sea urchin divers, rakers, or trappers may not possess, transport, or sell more than the harvester's weekly Zone 1 tote limit.

It is unlawful for Zone 1 drag vessels to fish for, take, possess at sea, or land more than nine (9) standard size stackable fish totes of sea urchins per day. While on shore, Zone 1 sea urchin drag vessels may not possess, transport, or sell more than the harvester's weekly Zone 1 tote limit.

#### 2. Zone 2

It is unlawful for Zone 2 sea urchin divers, rakers or trappers to fish for, take, possess at sea, or land more than six (6) standard size stackable fish totes of sea urchins per day. While on shore, Zone 2 sea urchin divers, rakers, or trappers may not possess, transport, or sell more than the harvester's weekly Zone 2 tote limit.

It is unlawful for Zone 2 drag vessels to fish for, take, possess at sea, or land more than six (6) standard size stackable fish totes of sea urchins per day. While on shore, Zone 2 sea urchin drag vessels may not possess, transport, or sell more than the harvester's weekly Zone 2 tote limit.

## 3. Implementation of daily and weekly tote limits

It is unlawful to offload sea urchins, or any parts of sea urchins, and then return to fishing for sea urchins the same day in Maine's territorial waters. In addition it is unlawful to transfer sea urchins, or any parts of sea urchins to or from another vessel at sea, except for tender vessels transiting to primary vessels during diving operations.

Weekly tote limits, calculated from Monday to Friday, are equal to the daily zone tote limit multiplied by the number of open days for the zone in which the license holder is authorized and elects to fish that week.

It is unlawful for a licensed sea urchin dealer to purchase a quantity of sea urchins from a licensed harvester greater than the licensed harvester's weekly zone tote limit each week. All sales of sea urchins must be completed weekly by Friday at 11:59 p.m. It is unlawful for a person other than a licensed sea urchin dealer to possess sea urchins held over from the previous harvest week.

Standard size stackable fish totes, with respect to the sea urchin fishery, is defined as 28" Long x 16" Wide x 11" Deep when measured inside at the shelf level. The tote shall retain its original size and shape when filled. A tote, when full, must allow for a straight edge to clear without hinderance when swiped over the top of the tote.

#### 26.50 Urchin Electronic Reporting

For the purpose of this section, "DMR-issued reporting device" means a transaction card or other Department developed and approved technology provided for the purpose of recording urchin transactions.

- 1. Eligibility. In order to be eligible for a DMR-issued device for the electronic reporting of urchin landings, an individual must be licensed according to 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B. Valid reporting devices may only be issued by the Department of Marine Resources.
- 2. Harvester Use. It is unlawful for an individual licensed under 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B to sell or transfer urchins the license holder has taken, unless the harvester presents a DMR-issued reporting device and records each transaction. DMR-issued reporting devices may only be used to sell urchins which were harvested by the individual identified on the reporting device. A law enforcement officer may seize or deactivate the reporting device of an individual who has used their reporting device to sell urchins they did not harvest. The act of utilizing your reporting on any given day will be considered as one fishing day, between the hours of 12:00 am 11:59pm.
- 3. Dealer Use. It is unlawful for a person licensed under 12 M.R.S. §6851 subsection 2-B, subsection 2-C, or §6852 to purchase or transfer urchins from an individual licensed under 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B, without recording the transaction using the electronic recording device specified by the Department for that purpose. DMR provided reporting software must be synchronized for updates to the reporting system prior to the purchase of urchins on each fishing day. A person licensed under 12 M.R.S. §6851 subsection 2-B or subsection 2-C may not purchase urchins from a harvester that does not present a DMR-issued reporting device. In the event of any failure of the reporting software or equipment, the Commissioner may authorize the use of paper reports until such time as the system is operational.
- 4. Records required. A person licensed in accordance with 12 M.R.S. §6851 subsection 2-B or subsection 2-C shall maintain documentation to account for all urchins in their possession. Any urchins legally obtained from other jurisdictions must have sufficient documentation to demonstrate their origin. Failure to provide proper documentation will be prima facie evidence that the urchins are illegal and are subject to seizure.
- 5. The Department will deactivate the reporting device of any individual who has met or exceeded their sea urchin harvest days. The onus is on the license holder to track days fished; harvesting beyond the number of allocated season days is considered fishing out of season and is prohibited.
- 6. An individual licensed according to 12 M.R.S. §6748, 6748-A, 6748-D, or 6302-A subsection 3 paragraph B that has declared into either the Zone 1 or Zone 2 fishery, must report all landed and retained sea urchins daily to the Department via an approved electronic reporting option by 11:59 PM the day of landing or retention. If no landings or retention occurred on a day open for fishing in the license holder's declared zone, a negative report is required.

Exception: Daily electronic reporting is not required if the license holder sells all their harvested sea urchins to a licensed dealer on the day of harvest and does not intend to hold any of the harvested sea urchins for sale later in the week.



#### **Basis Statement**

This regulation establishes open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2025-2026 season. For Zone 1, seasons are established for divers, trappers, rakers and draggers in 2025-2026, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2024-2025 season. For Zone 1, the daily tote limit is nine (9). For Zone 2, 40-day seasons are established for divers, trappers, rakers and draggers in 2025-2026, from which harvesters may only fish up to 30 days of their choosing. This regulation has the same number of fishing days and opportunity days as the 2024-2025 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 12-day season is established for Zone 2 divers, trappers, rakers and draggers in 2025-2026. For Zone 2, the daily tote limit is six (6).

Due to the incorporation of the Flex Harvest option in the previous fishing season, an update to the electronic reporting section for the upcoming 2025-2026 season was made to clarify that the use of the swipe card no longer equates to a fishing day, therefore a portion of the language in Chapter 26.5 has been struck.

Based on the summary of comments, the Zone 2 Late Season calendars and the Zone 2 LAA Late Season Dive calendar, were updated to address concerns regarding calendar dates. More specifically, in the Zone 2 Late Season Dive calendar, the open days of December 12, 19 and 22, 2025, were moved to March 17, 18, and 19, 2026. In addition, the open day of January 29, 2026, was moved to February 19, 2026. In the Zone 2 Late Season Drag calendar, the open day of January 30, 2026, was moved to February 20, 2026. In the Zone 2 LAA Late Season Dive calendar the open day of December 16, 2025, was moved to March 17, 2026.

## **Summary of Comments**

Notice of the proposed rulemaking appeared on July 23, 2025, in five major daily newspapers as published by the Secretary of State. On July 23, 2025, the rule was posted on the DMR website, and electronic messages were sent to individuals who subscribe to DMR notices. A hybrid public hearing (remote and in-person) was held on August 13, 2025, at the DMR offices in Augusta and via Microsoft TEAMS. There was one attendee at the public hearing on August 13, 2025. A summary of their comments is included below. Four written comments were received via email. The comment period closed on August 25, 2025.

Atchan Tamaki, Processor, joined remotely via Microscoft TEAMS: Well, as you may know, we are processing sea urchins all year round. Right now we are importing from Chile to process almost every day. And come September, that's when we are getting product from Canada. But the Maine Sea Urchin is very important for us. Almost all of our customers are waiting for Maine Sea Urchins. And because we have made a name already, Maine Sea Urchin is very important, same as Maine lobster. So everyone is expecting the Maine Sea Urchin once we start the season. After October 14<sup>th</sup> we strictly do just Maine Sea Urchin processing until the end of the season, which is March 12th. So during the time that our customer is expecting to get Maine Sea Urchins, we don't change it. We don't get any urchins from anywhere else, we strictly process Maine Sea Urchins. After that, after the season's over, we get it from different places and that's how we explain it to them. And right now, we're doing Chile urchins until the end of August. And every year we've been doing it this way and that's what our customer is expecting. And we have to say - that's what we have. So the only thing is, my concern is, those three idle days in February, I mean no fishing days February 17, 18, 19th of Zone 2 Late Season of the divers and trappers. And the draggers also, the week of February 18, 19, 20th, is no fishing days. That's critical for us. We've been buying sea urchins, your records show, that we've been buying sea urchins for years and years, since 1986. And we must have that week, even a couple days open, that's fine. At least we can show, that we have Maine Sea Urchins. So that's my comment.

• When asked by DMR, Deirdre Gilbert, what days he would suggest moving days from, Atchan responded: It's probably January of the, January 30<sup>th</sup> and the January 23<sup>rd</sup>. Let me see. Oh, I'm looking no, I'm looking at the draggers. OK, the divers probably January 29<sup>th</sup>, and

January 22<sup>nd</sup>, and January 15<sup>th</sup>. Those three. January is usually slow seasons because they have weather issues and those kind of stuff.

- DMR, Deirdre Gilbert, clarified if Atchan was saying to have three current January days, preferably those Thursdays, moved into February for the 17, 18 and 19. Atchan Responded: That's right. Same as the Draggers too. Draggers is January 16<sup>th</sup>, 27<sup>th</sup> and the 30<sup>th</sup>. If you could.
- DMR, Deirdre Gilbert, said thank you and asked if that was Atchan's only comment on the calendars. Atchan responded: Yes.

## Written Comment Received on July 26, 2025:

Tim Peterson, Zone 2 Tender: My name is tim Peterson I'm a zone 2 tender and representative on the urchin council and I am not happy with the fact that we had a full quorum and we set and voted on the calander then there's another meeting (that I missed because of jury duty) just to find out the calander has been amended. I would like the calander changed back to the original that we agreed on at the main meeting. Thanks

## Written Comment Received on July 30, 2025:

Frank Gray, Zone 2 Diver: I am a zone 2 late season urchin diver. I am not happy with the second round of the amended calendar set at May 21st meeting. I was happy with the original draft that was set at the April 16th meeting. It's my understanding that at the April 16th meeting there was a full quorum, which better reflects the representation of the fishermen. So no to the second round amended calendar, and yes to the April 16th original draft.

## Written Comments Received August on 13, 2025:

Atchan Tamaki, Processor (two written comments):

- Hi, I found out we have idle non fishing days of the week in February 2026. As a processor, we need open days for the week. Please make the week as a fishing day and take some days off in January. Thank you.
- Please make open fishing days in every week of February. We need to supply our customers every week until the season is closed. As a processor, this is our fate to do so. Thank you.

## **Department's Response:**

The Department appreciates comments it received from industry members. In light of comments received during the public comment period, the Department moved three days to March in the Zone 2 Late Season Dive Calendar. More specifically, December 12, 19 and 22, 2025 were moved to March 17, 18, and 19, 2026. The Department only received comments to move these days to March, reflecting what was voted on and approved by the Sea Urchin Zone Council (SUZC) at the April meeting. The Department did not receive comments during the public comment period supporting the proposed calendar created at the May SUZC meeting, which would have kept these three days in December. The Zone 2 Late Season Dive LAA calendar was also changed as a result, and an open day was moved from December 16, 2025, to March 17, 2026. In summary, these changes reflect what the public supported for these calendars.

Historically, the Department has removed open fishing days from Zone 2 Calendars during the February Maine public school vacation week on several occasions for the Maine Sea Urchin fishery. Removal of open fishing days during this week occurred in 2020, 2021 and 2023. Therefore, removing open fishing days during this vacation week is not a massive departure from what has been done in the past, due to fishermen's availability during this week and Department data revealing a slower market. At the April and May SUZC meetings of 2025, SUZC members voted to make school vacation week (the week of February 16, 2026) a no fishing week. During the public comment period, oral and written comments were received from a significant processor in Maine requesting that open fishing days be moved to this week. In response to this processor's concerns and in consideration of the SUZC's position, the Department moved one day in the Zone 2 Late Season Dive calendar and one day in the Zone 2 Late Season Drag calendar to February school vacation week. More specifically, January 29, 2026, was moved to February 19, 2026, in the Zone 2 Late Season Dive calendar and January 30, 2026, was moved to February 20, 2026, in the Zone 2 Late Season Drag calendar. The Zone 2 LAA Late Season Dive Calendar was changed so that the open day of December 16, 2025, was moved to March 17, 2026. The Zone 2 LAA Late Season Drag Calendar was not affected as a result of this change.

COMMENT DEADLINE: August 25, 2025

PRINCIPAL REASON(S) OR PURPOSE FOR PROPOSING THIS RULE: [see §8057-A(1)(A)&(C)] This regulation establishes open harvest days and tote limits for the taking of sea urchins by divers, rakers, trappers, and draggers in Zones 1 and 2 for the 2025-2026 season. For Zone 1, seasons are established for divers, trappers, rakers and draggers in 2025-2026, from which harvesters may only fish up to 15 days of their choosing, the same number of days allowed during the 2024-2025 season. For Zone 1, the daily tote limit is nine (9). For Zone 2, 40-day seasons are established for divers, trappers, rakers and draggers in 2025-2026, from which harvesters may only fish up to 30 days of their choosing. This regulation has the same number of fishing days and opportunity days as the 2024-2025 season. For the Whiting & Dennys Bays Limited Access Area in Zone 2, a 12-day season is established for Zone 2 divers, trappers, rakers and draggers in 2025-2026. For Zone 2, the daily tote limit is six (6).

Due to the incorporation of the Flex Harvest option in the previous fishing season, an update to the electronic reporting section for the upcoming 2025-2026 season was made to clarify that the use of the swipe card no longer equates to a fishing day, therefore a portion of the language in Chapter 26.5 has been struck.

This proposed rule seeks to conserve the sea urchin resource for utilization in the future; if it is successful in doing so it will have a positive impact on small business (sea urchin harvesters and sea urchin processors) in the long term.
