1/29/25	<p>Cutoff date for ACCESS participation</p> <p>Newly identified MLs are not required to participate in ACCESS or Alternate ACCESS if the ML Start Date (via Synergy) falls less than 30 days within the close of the ELP assessment window, based on federal provision of up to 30 calendar days for LEAs (in Maine, SAUs) to screen students for potential ML status.</p>	<p>It's important to note that schools still have the option for recently identified MLs to participate in ACCESS. It is recommended this decision be made as an instructional team, and that the parents are informed about the uses of the data, as well as consulted in the decision-making process.</p>	6/30/25
