Fall 2025 Administration: Important Dates

Prior to the Administration: SAUs download the latest version of the NWEA State Solutions Secure Browser onto student devices (<u>System & Technology Guide</u>)

September 15 – October 24: Fall 2025 administration window

- Assign supports and accommodations (<u>User and Student Management Guide</u>, Part 6, and <u>Accessibility</u> Guide)
- Print test tickets (<u>Manage Online Testing Guide</u>, Part 3)
- Provide all proctors with administration directions and scripts (Assessment Administration Guide)
- Provide proctors accessing the proctor dashboard in Acacia with the Manage Online Testing Guide

Within 72 hours of assessing: Student results reports become available in Acacia (Reports Interpretive Guide)

November 14: Last day to run Operational Reports for the fall administration (not including the Student Score Data File)

December 3: Fall 2025 Student Score Data File becomes available

Reminder About Daily Change Roster File Upload Timing

A daily change file is automatically generated at 7:59 PM each weekday evening and contains all changes in Synergy since the previous daily change file. A member of the Assessment Team manually uploads the daily change file the next weekday morning, excluding state holidays, into the Acacia platform.

Due to the manual nature of the upload process, please wait until 9:00 AM before verifying that students' enrollment updates in Synergy from the previous weekday are reflected in Acacia.

Scoring & Reporting

Impact of the New 2025 RIT Score Norms

Starting this fall, the Maine Through Year Assessment is using a new set of national norms to help interpret one type of student score, known as the RIT score.

What has not changed about the Maine Through Year Assessment?

The Maine Through Year Assessment continues to consist of three administrations: a required fall administration, an optional winter administration, and a required spring administration. A portion of the spring administration will continue to be used to measure student achievement according to Maine's state academic standards using the Maine scale score. The Maine scale score aligns to an achievement level of Well Below State Expectations, Below State Expectations, At State Expectations, or Above State Expectations. The Maine scale score is not a RIT score, and this measure of student achievement according to Maine-specific state academic standards is not impacted by the change in the RIT score national norms.

What has changed about the Maine Through Year Assessment?

The new national norms will impact the interpretation of the score type known as the RIT score, which is used to compare a student's performance to their same-grade peers nationwide. RIT scores are used for comparisons to other students and for measuring growth across grade levels, not for measuring a student's achievement of state academic standards specific to a grade level.

What does this mean for measuring student performance?

Students' RIT score percentile rankings may look different than before. The percentile represents where the student stands when compared with their peers today--not peers from several years ago. Because student performance has generally declined since the pandemic, the same score may now be associated with a higher percentile.

NAEP 2026

The NAEP 2026 administration window is January 26, 2026 – March 20, 2026. The assessment date assignments are tentatively scheduled to be provided to the schools at the end of this month. Schools needing to reschedule the scheduled assessment date should reach out to Dr. Regina Lewis at regina.lewis@maine.gov as soon as possible. Please reach out to principals at NAEP selected schools to

confirm that they have registered for the assessment management system (AMS) and designated a school coordinator within the AMS.

Thank you to all NAEP 2026 selected SAUs and schools for completing the NAEP Technology Survey. Maine schools achieved a 99% completion rate, which is above the national response rate of 96.6%. Schools should be able to view the model assignment for the upcoming administration at this time. *For schools designated for school device administration, application installers should be identified in the AMS by December* to begin receiving instructions for preparing school devices with the NAEP Assessment Application. The eNAEP Download Center notification will be automatically sent to individuals identified in the AMS as the application installer. *Application installers only need to be identified for schools assigned to school devices*.

As a reminder, NAEP is assigning a small number schools with student devices meeting the technical requirements for the administration of NAEP have been assigned to the NAEP device administration model to check for performance differences based on whether students take the assessment on their own devices or NAEP devices.

The NAEP Application is currently available for installation. The NAEP application installer can be a district level (SAU level) person, but the person must be identified/listed for each school in the SAU for which the app is to be installed by that individual. This person can be identified by the SAU through a streamlined process that eliminates having to list the person on each school's page in the AMS.

Current and Upcoming NAEP 2026 activities

- Assessment dates will be provided in late October.
- It's time to **designate school coordinators** to serve as the main point of contact for NAEP.
- SAU and school staff should be registering in the NAEP AMS.
- The AMS website and all accounts are new for 2026
- SAU and school users receive registration and login information for the NAEP Assessment Management System (AMS) from naep-ams@naepnpd.org.
- Multi-factor authentication is required for all users.
- The eNAEP assessment application is available for installation.

As a reminder, the NAEP 2026 Mathematics and Reading assessments have updated frameworks and new items. Additional new items will be administered via pilot assessments during the 2026 assessment window.

For NAEP 2026 the assessment will be administered using school Wi-Fi when the assessment is administered on school devices. When NAEP devices are used the assessments will be administered using a NAEP Private Network.

Notable changes for future NAEP administrations:

- The transition to school devices will include iOS devices with the 2028 administration of the NAEP Mathematics and Reading Assessments.
- NAEP will begin the transition to a multi-stage adaptive assessment. Additional information is forthcoming.

• The NAEP 2028 Science assessment will be based on the updated NAEP 2028 Science Framework.

October 2025 NAEP Nugget and Resources:

Results from the 2024 Nation's Report Card (NAEP) for 8th grade science and 12th grade math and reading were released on September 9, 2025, at 12:01AM ET at <u>nationsreportcard.gov</u>. The last time students took these assessments was in 2019, prior to the pandemic and its disruption to education. A high-level overview was also provided on the <u>National Assessment Governing Board website</u>.

An Important Note: Assessment Participation Requirements at Maine Private Schools

What has changed?

Publicly funded students attending private schools with <60% publicly funded students are not required to participate in the Maine educational assessments.

Please note that all students at private schools with at least 60% publicly funded students remain required to participate in the Maine educational assessments, and all Maine students attending Special Purpose Private Schools remain required to participate in the Maine educational assessments. Schools which are no longer required to participate in the Maine educational assessments are designated as either "Private Sectarian" or "Private Non-Sectarian" under *School Type* in the *All SAUs and Schools* spreadsheet available on the <u>Schools and SAUs Data page</u>.

Why is this change occurring?

In prior years, when updating the <u>Maine Comprehensive Assessment System Guidelines</u> and other participation resources around state assessments, there were lengthy conversations regarding publicly funded students attending private schools and students attending public schools. Public schools funded by public dollars are required to participate in state assessments and be counted in assessment participation and accountability calculations. This policy was extended to publicly funded students attending private schools. As a result, the required participation of all publicly funded students in the state assessment was included in the guidelines, regardless of attending SAU/school.

However, there is nothing in Maine statute that requires private schools whose enrollment is made up of <60% of publicly funded students to participate in state assessments.

What are the impacts to assessment rostering?

Private schools will continue to have the option of assessing their publicly funded students, and those students will continue to appear in the assessment rosters. This is similar to the presence of partially homeschooled students in the assessment roster, as those students also have the option to assess but are not required to assess.

What are the impacts to the responsible SAU of the potential non-participation of publicly funded students at private schools?

SAU participation data in the ESSA Dashboard will continue to include both students enrolled in schools within the SAU and students who attend schools outside the SAU but for whom the SAU remains responsible.

The non-participation of publicly funded students at private schools with <60% publicly funded students will not be considered in:

- The identification of schools within the SAU for additional support as part of Maine Model of School Supports, and
- The identification of schools or SAUs for targeted technical assistance based on assessment participation.

Responsible SAUs are encouraged to communicate with schools receiving public tuition funds around expectations for assessment participation in return for receipt of those funds.
