# General

### **Question:**

Should we create a special consideration exemption for ELL students if they are not testing?

A Special Consideration exemption is an emergency medical waiver for students experiencing a significant medical emergency.

For a newly arrived multilingual learner, the exemption from the Reading assessment will be automatically applied after the Maine Department of Education Data Team receives the results file from the vendor based on the student information entered into the state information system by the SAU. Specifically, the US School Entry Date (Synergy) or First US Enrollment Date (Connect) and subsequent ML Start Date must be less than 12 months from the last day of the administration window. The Maine Through Year Multilingual Learner Exemption Guidance contains the specific dates for exemption from the fall and spring administrations of the Maine Through Year Assessment.
