Questions:

For clarification: Did you say that the 2025 NWEA norms are retroactively applied to all student percentile values back through the 2022-23 school year the MARC platform?

The 2025 norms have been retroactively applied to all MAP Growth reports from prior years.

Is there a rationale that can be shared with us? We use data to create info shared with stakeholders-will this change create confusion?

From NWEA's Psychometrics Team:

Norms are reference points, not properties of the test itself. Likewise, they are descriptive in nature, not prescriptive. They tell us how a score compares to a specific population at a specific point in time.

- A score from 2020 can be compared to 2020 norms to answer: "How did this person perform relative to the 2020 population?"
- The same score can also be compared to 2025 norms to answer: "How would this person's performance look if they were part of the 2025 population?"

Both comparisons are descriptive, not prescriptive. They don't change the original score or the test taker's ability; they just provide different lenses for interpretation.

When using norms to compare scores across multiple years, the most critical consideration is to use the same norm set. If you mix norms from different years, the comparisons become inconsistent because each norm set reflects a different population or a different reference point.

From Krista Averill, Maine DOE:

NWEA created a <u>letter template for families regarding the MAP Growth updates</u>, including the new 2025 RIT score norms. Maine DOE has reviewed and revised the letter to better align to the Maine Through Year Assessment. The <u>revised letter</u> to families is located on our <u>Maine DOE Maine Through Year Assessment</u> webpage.

When should we see 25-26 students in Acacia so that we can begin grouping?

Students will appear in Acacia once they are enrolled by the SAU in Synergy. The student enrollment information in Synergy syncs to the NEO assessment roster, which is then manually uploaded each weekday morning to the Acacia platform by a member of the Assessment Team.

Do we need to download any new browsers for fall testing?

Yes, a new State Solutions Secure Browser is needed for the fall Maine Through Year Assessment. Please see the <u>System & Technology Guide</u> for more information.

I did hear we need a new State Solutions Secure Browser, what about for MAP Growth?

ISRs from Acacia will be available 12/3 from fall testing?

ISRs are available only for the spring administration of the Maine Through Year Assessment, as they report student achievement according to grade-level standards by using the Maine scale score. There are other reports that can be shared with families, however, for example the Family Report available in the MAP Growth platform.
