Hailey, you are now talking about the MAP Growth and not the Maine Through Year Assessment, correct?

Hailey is walking us through MAP Growth Report changes that are coming for the 24/25 school year. SAUs who independently roster their students in the MAP Growth platform have access to MAP Growth reports containing Maine Through Year Assessment RIT scores. Hailey is sharing changes to the MAP Growth reports that are available with Through Year Assessment RIT scores.

Are there any elements of the Class Profile or District Profile that you have shared that are not available with Maine Through Year Assessment RIT scores?

Rapid Guessing metrics will only be available for MAP Growth assessments. If SAUs are utilizing the State Growth RIT score, that metric will not be available in the data table.

The Instructional Area names/categories may differ as the State Assessment will vary from our MAP Growth assessments. Instructional Area information is still available with all adaptive test forms, they may just be called something different than what appears on our visuals/screen captures provided in the slides.

Will we be able to see historical district data in the District Profile or is it only this past school year's data?

SAUs will be able to access historical data back to the 2020-2021 academic year.
