Dear Superintendent Robinson:

The Bangor Public Schools Nutrition Program was reviewed per Federal Regulation 7CFR 210.18 and Maine Department of Education Child Nutrition policies and procedures. On February 26 & 27, 2025 Sarah Platt reviewed Abraham Lincoln School and Bangor High School. An exit conference with Noelle Scott occurred on March 12, 2025.

The enclosed Official Notification of Review Findings and Corrective Action describes the corrective action documentation required. Please submit a detailed response for each of the review findings listed in the report by the deadline(s) listed. Responses must be submitted through CNPweb, Maine Department of Education Child Nutrition's Administrative Review software, and must address the following:

- How the finding was corrected (include who, when & how)
- Documentation that the finding has been corrected district-wide
- How this action will ensure future compliance

In accordance with §210.18(k), failure to return completed documentation within 30 days from the corrective action deadline date will result in the withholding of reimbursement payments. We hope that following the exit conference you and your staff addressed the corrective actions and that you will have no problems in meeting the response deadline.

The Official Notification also provides the potential fiscal action, which is an initial estimate of the amount of reimbursement that will be reclaimed. These are only estimates which must be adjusted to the actual date of corrective action for each violation. If documentation of corrective action or acceptable corrective action is not received by the response date stated above, the claim will be recalculated to the end of the school year.

1403. Did a review of agricultural food components indicate violations of the Buy American provision?

#### **Technical Assistance: Buy American Provision**

The Buy American provision requires school food authorities to purchase, to the maximum extent practicable, domestic commodities or products.

Recently, the USDA established a new threshold for school food authorities that use exceptions to this requirement. The limit on the percent of total commercial food costs from non- domestic foods will be phased in over 7 school years.

- Beginning in SY 2025-26, the non- domestic food purchases cap will be 10 percent.
- Beginning in SY 2028-29, the non- domestic food purchases cap will be 8 percent.
- Beginning in SY 2031-32, the non- domestic food purchases cap will be 5 percent.

This phased-in approach will allow schools to gradually adjust to the new requirement

3. Are Point of Service (POS) snack counts by student/benefit category maintained?

**Finding 9220: Point of service snack counts by student/benefit category are not maintained.** Snack counts were based on the number of snacks provided and the number leftover. As with all school meal programs, meal counts must be taken at the point of service which is the point when the student receives a complete, reimbursable meal/snack.

#### Corrective Action:

Implement a POS meal count system effective immediately. Submit copies of POS meal counts for one week in March 2025.

Submit corrective action documentation in CNPweb -> E-reviews -> Corrective Action Responses by April 15, 2025.

#### **Technical Assistance:**

Technical assistance was provided during the onsite review to staff who oversee the afterschool snack program.

## Technical Assistance: Pre-K Meal Pattern

Pre-K students have their own breakfast time. Since they are not eating at the same time as the K-3 students, the CACFP meal pattern for preschoolers must be followed instead of the School Breakfast Program meal pattern.

1406. Most recent Food safety inspection posted, visible to public?

**Finding 9147: Most recent food safety inspection report is not posted in a publicly visible location.** The most recent health inspection report was posted in the kitchen and not out for public view as required.

## **Corrective Action:**

Post the most recent health inspection report in a publicly visible location.

This was corrected immediately during the onsite review. No further corrective action is required.
