Dear Superintendent Campbell

The RSU 78 Nutrition Program was reviewed per Federal Regulation 7CFR 210.18 and Maine Department of Education Child Nutrition policies and procedures. On December 18, 2024 David Hartley reviewed Rangeley Lakes Regional School. An exit conference occurred on December 18, 2024 with you.

The enclosed Official Notification of Review Findings and Corrective Action describes the corrective action documentation required. Please submit a detailed response for each of the review findings listed in the report by the deadline(s) listed. Responses must be submitted through CNPweb, Maine Department of Education Child Nutrition's Administrative Review software, and must address the following:

- How the finding was corrected (include who, when & how)
- Documentation that the finding has been corrected district-wide
- How this action will ensure future compliance

In accordance with §210.18(k), failure to return completed documentation within 30 days from the corrective action deadline date will result in the withholding of reimbursement payments. We hope that following the exit conference you and your staff addressed the corrective actions and that you will have no problems in meeting the response deadline.

The Official Notification also provides the potential fiscal action, which is an initial estimate of the amount of reimbursement that will be reclaimed. These are only estimates which must be adjusted to the actual date of corrective action for each violation. If documentation of corrective action or acceptable corrective action is not received by the response date stated above, the claim will be recalculated to the end of the school year.

#### Commendations

- \* An exit conference was held with Superintendent Georgia Campbell on December 18, 2024 to review any findings and corrective actions needed.
- \* The kitchen manger and his assistant do a good job preparing and serving the students healthy meals. Keep up the good work.

Additional training is needed about the program especially the paperwork that is required. On February 20 & 21, 2025 the Maine Child Nutrition Program is offering a training for new directors and managers. The training is conducted in Augusta. Kitchen Manager Bruce Truland has been added to the list of invitees.

\* Currently RSU 78 is in year 3 of Special Provision II. In SY 2026-2027 the district will need to collect, process and conduct meal counts based on those applications.

The Justice for All poster was not posted. It had been taken down and replaced with different posters. It was found in the kitchen managers office and rehung

#### Finding 9000: Other Finding

Kitchen assistant was wearing earing's. Based on the SOP's available for review, the Personal Hygiene SOP states, item #10, "Do not wear any jewelry except for a plain ring such as a wedding band.

Kitchen supervisor is wearing a watch. This is not allowed per the Maine Food Code, 2013.

#### **Technical Assistance:**

The SOPs can be changed to allow the wearing of earrings.

The SOP's cannot be change to allow the wearing of jewelry on the wrist.

#### Meal Components & Quantities - Rangeley Lakes Regional School (392)

401. DOR - meals selected by students contain all required components/quantities? Enter data.

#### Finding 9000: Other Finding

Meal requirements for breakfast and lunch are that each student must take 3 items/components and one must be .50 cup of fruit or vegetable.

During Breakfast the following was observed: 6 meals contained cereal and milk only, 3 meals contained cereal and juice only, one student took a bagel and milk. Either the meals did not contain a fruit or only contained two items.

During lunch the following was observed: one student took a garlic stick and went to the salad bar. Only vegetables on the salad bar, did not take much salad - total 2 items.

#### Corrective Action:

A revised plan to complete meal accountability must be developed. The individual marking students as having a full and complete reimbursable meal must see that the student has a complete meal.

Please submit your plan to the reviewer by January 24, 2025.

409. Review period production records and supporting documentation - were required meal components offered and daily/weekly requirements met? Enter data.

# Finding 9075: Production records/supporting documentation indicate weekly meal pattern requirements for the age/grade group(s) were not met.

Based on a review of production records and other supporting documentation for the week of October 28, 2024, some meals served did not meet the meal pattern requirements for the age/grade group(s) being served.

The daily offering of the meal pattern for a high school students requires the offering to be 2 ounces of meat/meat alternative. Tuesday, October 29, 2024 the entrée was ham and cheese sandwich. The recipe indicated it contained one ounce of ham and one ounce of cheese. Ham has extra items included; it takes 1.22 ounces of ham to credit as one ounce. The recipe will need to be adjusted so the ham and cheese sandwich can credit as 2 ounces in the high school meal pattern.

On the day of review a salad bar was offered to the students. The salad bar only contained vegetables. The recipe included chicken, cottage cheese, hard boiled eggs, and more.

Recipes must state what was used to make the item, not used as a guide.

Production records are incomplete. Each day pizza is offered as an alternative, this was not included on the production records. All items offered during the meal must be on the daily production record, condiments, serving sizes, number of servings made, served, leftovers.

#### Corrective Action:

Submit production records for the week of January 13, 2025, including any recipe used.

Submit the production records and revised recipes to the reviewer by January 24, 2025.
