Commendations

- \* An exit conference was held with Rick Lyons on November 12, 2024 to review any findings found during the review.
\* Katahdin Middle/High School has a new kitchen from a Healthy Meal Incentive Grant. This makes meal service at the Middle/High School much easier since the meals are prepared on site instead of being moved across a road from the Elementary School.

Staff at Katahdin Middle/High school do a good job preparing and serving meals to students. Students know they can receive a healthy breakfast and lunch at school every day.

Keep up the good work.

- \* Community Eligibility Provision (CEP)

For SY 2025 RSU 89 began participation in the CEP program. This requires using students eligible based on the Direct Certification students eligible for free meals. For SY 2025 the number of Medicaid students received free eligibility in that program can also be counted in determining the district free claiming percentage. It is suggested that RSU 89 review this and possibly renew the eligibility information for the beginning of SY 2026. This would increase the number of free claiming students.

Finding 9000: Other Finding

During a review of agriculture products peaches from China were found.

Technical Assistance:

Food products used in the Child Nutrition program are required to be Buy American Compliant. There are a few exclusions however peaches is not one of them. Products need to be checked when ordering and receiving to ensure they are Buy American compliant.

*1104. Foods sold to students – complete chart of locations, responsible entity.*

**Finding 9000: Other Finding**

Foods are not allowed to be sold to students outside of the school food service program. Every year Katahdin Middle/High School has a Cougar Pride event that sells food to students. Items sold include sodas, candy, pizza and more. This is a fundraiser. Foods sold to students during the school day must be compliant with the Smart Snack guidelines.

Food cannot be sold to students that are in competition with the school nutrition program from midnight until 30 minutes after the school day is over.
