CACFP At-Risk Afterschool Program

The "Act To Increase Access to Nutritious Foods in Schools by Implementing an After-school Food Program for At-risk Students" is a law that requires any district with a school with 50% or more Free/Reduced Eligible students to participate in CACFP At Risk Afterschool Snack/Supper Program. The program requires an education/enrichment activity that is available to all students after school. An example could be a homework help group. If the school does not want to participate or does not have qualifying enrichment, the district must opt out after public hearing and school board vote.

The state Local Foods Fund reimburses school nutrition programs \$1 for every \$3 they spend on eligible local foods!

As a reminder, minimally processed local food products including produce, proteins, grains, and value-added dairy already qualify for LFF without having to apply. See the list of <u>eligible</u> products HERE.

If you are interested in having a local value-added or processed product qualify for LFF, please send information about the product and a point of contact for the business (if possible) to katie.knowles@maine.gov.

To qualify, the value-added/processed product must:

- contain 51% or more agricultural raw materials grown, harvested, or produced in Maine by weight or volume. (Water is excluded from this requirement)
- be processed or produced in the state of Maine
