# PRIORITY NOTICE: Maine DOE Child Nutrition Programs Unaffected by Anticipated Changes to SNAP

This information is being sent to Superintendents, Principals and Guidance Counselors

In anticipation of questions from the field, the Maine Department of Education (DOE) would like to assure school administrators that its **Child Nutrition Programs** will continue to operate as usual, despite an anticipated reduction in Supplemental Nutrition Assistance Program (SNAP) benefits nationwide beginning November 1, 2025. These programs are not connected.

In addition, the **Child and Adult Care Food Program (CACFP) At-Risk Afterschool Program** will continue for those Maine schools currently enrolled. Existing program rules remain in effect; meals must be consumed on-site and in a congregate setting to ensure that students receive the full benefit of these services.

The Maine DOE has advised local Child Nutrition Directors to anticipate a potential increase in participation in school breakfast and lunch and the CACFP At-Risk Afterschool Program following the expected changes to SNAP benefits. School administrators may utilize this Community (Food) Resources template, found on the Child Nutrition Home page, when responding to families who may be experiencing gaps in nutrition assistance, due to ongoing federal uncertainty.

For families seeking additional food support, please consider sharing <u>The Emergency Food Assistance Program (TEFAP) Map</u>, organized by county, from the Maine Department of Agriculture, Conservation, and Forestry.

#### **Local Foods Fund Reminders!**

- As a reminder, you can claim multiple months at a time for the Local Foods Fund (LFF) with your monthly claim!
- LFF's fiscal year runs July 1<sup>st</sup>-June 30<sup>th</sup>, which means you can claim local food purchased at any time during the FY (for example, you can claim August, September, October with your November claim)
- Please <u>NEVER</u> revise your claim to include LFF. You can always submit your claim the following month!

### Claims are coming up! Many districts had errors with their LFF claim. $\bigcirc$ As a friendly reminder:

- Claims must include 2 files:
  - Our <u>NEW Summary Claim form</u> in EXCEL format.
  - Invoices should be attached as one PDF with claimed items highlighted.

- Have you filled out our <u>attestation statement</u> stating you understand the new changes?

If your site plans to extend the At-Risk Afterschool Program to serve meals/snacks in the evenings, on the weekends, during school vacation weeks and/or on holidays, please submit a Site Sheet revision in CNPweb to document those requests.

#### As a reminder:

- An enrichment activity is required to be offered.
- Meals and snacks must be consumed on site.
- One component may be taken off site, provided it is a fruit, vegetable, or grain item.


