Certification and Benefit Issuance - Cutler Public Schools (1411)

133. Direct Certifications correctly certified?

Finding 9024: Some students directly certified for free meals were not certified correctly.

Direct certification documentation for selected students was reviewed for completeness and accuracy. Some students were not certified for free meals incorrectly.

Technical Assistance:

The Direct Certification (DC)List must be reviewed at a minimum of 3 times a year. It is recommended to be reviewed more often. During the Administrative Review three students, either Reduced or Paid, showed up on the DC list. This was discussed with the Approving Official.

Verification - Cutler Public Schools (1411)

209. Review of verified applications – properly selected, replaced applications correctly, verified correctly?

Finding 9039: Applications not properly selected for verification.

The applications selected for verification were not appropriately selected for the sample size option used.

Technical Assistance:

The required method of Verification is Error Prone. The application selected was not Error Prone, however there was an Error Prone approved application on file. When approving applications review to see if they are Error Prone, flag them in some fashion to be used when Verification is completed. This was discussed with the Verification Official

214. Student eligibility change due to verification – update Benefits Issuance list?

Finding 9000: Other Finding

Family selected for Verification submitted the prior year tax return. The wrong figure was used to determine annual income, no change occurred.

Technical Assistance:

The wrong figure was used on the prior year tax return used for the verification process. The adjusted income after deductions was used. This was reviewed and explained to the Verification Official.
