Subgrant to serve Students Experiencing Homelessness and/or Multilingual Learners (MLs)

The Maine Department of Education (DOE), through the Coronavirus Aid, Relief, and Economic Security Act (CARES) state reservation fund, is providing the opportunity for school administrative units (SAUs) to apply for additional funding to serve students experiencing homelessness and/or multilingual learners (MLs) who have experienced unfinished learning as a result of the pandemic.

The purpose of the funding is to:

- 1) Provide supports and services for identified students experiencing homelessness, and to engage with families and prepare staff to meet the unique needs of these students and their families. The additional funding should enhance and improve programs and services for students experiencing homelessness in order to ensure that unfinished learning as a result of the pandemic is remediated, as well as to ensure sustainability of high-quality content-instruction programs.
- 2) Provide English for Speakers of Other Languages (ESOL) services, engage with families, and prepare staff to meet the unique needs of MLs and their families. The additional funding should enhance and improve programs for MLs in order to ensure that unfinished learning as a result of the pandemic is remediated, as well as to ensure sustainability of high-quality language- and content-instruction programs.

The state reservation funding will address the urgent needs of student experiencing homeless and/or ML students more immediately than state and federal funding, which are adjusted annually. The subgrant funding can cover unexpected ML and/or homeless expenses related to preventing, preparing for, or responding to the COVID-19 pandemic from October 1, 2021 to September 30, 2022.
