

# **Optional Winter 2024 Administration**

The winter administration of the Maine Through Year Assessment is optional. The window is from January 2 – February 16, 2024.

# **Daily Change Files**

As with the spring 2023 and fall 2023 administrations, daily roster change files will be loaded manually by an Assessment Team member into the Acacia platform each day. From Monday to Friday, it may take up to 36 hours to see rostering changes in Synergy reflected in the Acacia platform. If changes are made to Synergy after 8:00 PM on Friday, they will not appear in Acacia until Tuesday.

### **Removing Students from Acacia**

If you need to remove students from Acacia during the winter pre-administration window, for example due to the student being an alternate assessment participant, please email <a href="mailto:Krista.Averill@maine.gov">Krista.Averill@maine.gov</a> and cc: <a href="mailto:Kalua.Wilson@maine.gov">Kalua.Wilson@maine.gov</a>. Removal of students from the Acacia platform is a manual process that cannot be completed via the daily roster change file. Only students who have no prior score results in Acacia may be removed.

# **Professional Learning Opportunities**

### **Understanding Scores from the Maine Through Year Assessment**

During this virtual workshop, participants will learn about the characteristics and purposes of the two score types produced by the Maine Through Year Assessment. Participants will interact with student RIT score and Maine-specific scale score data to develop a deeper understanding of the purpose and value of, as well as the similarities and differences between, these two measures of student performance.

The MSAA (ELA & math) and MSAA Science are Maine's alternate assessments based on alternate academic achievement standards, designed for students with the most significant cognitive disabilities who have been found eligible by the IEP Team utilizing state guidance resources. ### MSAA Action Steps for January 2024

- **Initial student upload** Maine DOE will utilize Synergy enrollment data>NEO alternate assessment roster to create student test assignments in the MSAA Platform.
- Identify Test Coordinators and Administrators Maine DOE will send Special Education Directors a survey to identify the local alternate assessment (MSAA) coordinator. The MSAA Coordinator will ensure that a Test Administrator has been identified for every student eligible to participate in the MSAA.

# Administration window – January 29, 2024 through March 8, 2024.

The administration window for the National Assessment of Educational Progress opens on January 29<sup>th</sup>. Dr. Lewis will be contacting School Coordinators regarding student exclusions and the proper coding. Please remember that only students who participate in the alternate assessments or have been enrolled in U.S. schools for less than one year may be excluded from NAEP. # **Upcoming activities for School Coordinators include:**

- *Participate in a Zoom meeting* with the NAEP Assessment Coordinator that leads the team scheduled to administer the assessment in the school.
- Reviewing the list of students selected for NAEP. An updated list of enrolled students will be provided by Maine DOE on January 5<sup>th</sup>. Please review the list of selected students for newly selected students and assign the appropriate assessment accommodations as indicated in the students' IEPs and/or 504 plans. The AMS has some helpful guidance.
- Notifying families of the students. Parent/guardian notification letters are available in English and Spanish with in the NAEP Assessment Management System. These letters are also available in the top ten languages spoken by the families of Maine's students. The translations for the Parent Notification letters are located on the bottom of the National and International Assessment page of the Maine DOE Assessment Team Resources. This is a new location. The families of students selected for NAEP should be notified at least one week in advance. You may also elect to notify the parents of all students in the selected grade that their students may be selected to participate in the assessment.
- **Plan to be onsite and available** before as well as during the administration of the assessment on the day of the assessment.

### To prepare for the assessment's technology requirements, each On-site Technology Coordinator should:

- Work with school or district technology staff as necessary to add the email domain westatstudies.com to the safe senders list;
- **Complete Internet Speed tests in each room** that will be used for the assessment one week prior to the scheduled assessment date.
  - Contact your school coordinator for these locations.
  - If you have not already done so, please assist with safelisting URLs. A complete list is located in the NAEP Assessment Management System.
- Participate in a Zoom meeting with the NAEP Assessment Coordinator assigned to your school.
- **Plan to be onsite and available** before as well as during the administration of the assessment on the day of the assessment.

# Grade 12 Schools Only:

- *High School Transcript Study (HSTS) Coordinators* should be registered in the NAEP Assessment Management System.
- *High School Transcript Study tasks are available in the AMS* for submission of course catalogs and completion of the transcript information survey.

# What's up and coming with the International Assessments:

# Program for International Student Assessment (PISA) 2025 Field

The PISA Desired Target Population is agreed upon through negotiation between the National Project Manager and the international contractors within the constraints imposed by the definition of the PISA Target Population. The Target Population for PISA starts with students attending all educational institutions located within the adjudicated entity, and in grade 7 or higher. The "standard" PISA target population is further refined to its age basis: students between 15 years and 3 (completed) months and 16 years and 2 (completed) months at the beginning of the testing period.

The core test for PISA 2025 is a computer-based 2-hour test that includes the assessment of Science (major domain), Reading, Mathematics, as well as Learning in the Digital World (LDW). The core PISA test is administered to a sample of students drawn from the PISA target population according to established scientific principles for drawing samples from finite populations.


## **Recent ACCESS FAQs:**

## How do I remove students from WIDA AMS who have moved out of the SAU?

There is a daily change file processed by Maine DOE that captures enrollment updates such as new/transfer students and enters them into the WIDA AMS platform. However, there is no functionality in WIDA AMS to delete a student who is no longer enrolled. SAUs do not need to take action in WIDA AMS if there is a multilingual learner who is no longer enrolled and will therefore not be participating in ACCESS. Those test sessions will remain in "Not Started" status and reports will not be generated for the student. The student/s will not be counted as non-participants for the former SAU, provided that the enrollment exit date in Synergy is prior to the ESEA Demographic date.

# With the changes to WIDA AMS, how do I enter student accommodations efficiently?

Student accommodations are now entered through **Test Management**. The easiest way to do this is by entering through **Registered Student** (rather than **View Registrations**). You will have all online domains visible for the same student om one screen, and can select the appropriate accommodations for each. Considering that not all accommodations are consistent across domains, this can also be viewed as an added step to ensure that the information for each domain is consistent with the student's IEP and ILAP.

# <u>Pilot Program to Prevent Student Homelessness</u>

Do you know families who are facing eviction? Not sure where they will stay? Need help with bills or critical home repairs? If so, you may want to reach out to <u>your SAU's McKinney-Vento Liaison</u> and ask about the Pilot Program to Prevent Student Homelessness. Every SAU in Maine received funding to support families to prevent homelessness.
