Maine State Board of Education Minutes of the July 18, 2018 Meeting

The Certification and Higher Education Committee held a meeting on Wednesday, July 18, 2018, at the Department of Education in Augusta. The following were present: Committee Chair Jane Sexton; Wendy Ault; Wilson Hess; and Jana Lapoint; (Board Members). Jaci Holmes, Federal and State Legislative Liaison (Department of Education); and Mary Becker, State Board Secretary Associate.

Jason Libby, Higher Education Specialist, called into the meeting.

Chair Jane Sexton called the meeting to order at 9:40 AM.

<u>Certification Office Update</u>: (Stephanie Fyfe – written report)

MEIS Data from Stephanie Fyfe as of July 17, 2018

- Overview:
 - o Renewal portion of the new system went live on June 13, 2018 Since then:
 - 66% of working educators who need to renew have applied
 - Roughly 9,000 applications have been submitted
 - Roughly 5,200 educators have received an auto-issued endorsement
 - Roughly 2,500 applications are in queue to be worked on
 - Office was averaging 500 calls a day and 400 emails a day, but is now starting to slow down
 - Office has processed 2,759 applications
 - o Graph of applications submitted, completed and in queue
 - o Graph of percentage of recommended applications in
 - o Graph of applications submitted and endorsements auto issued by week

The Department of Education (DOE) is holding off on any changes until a deep, comprehensive review can be conducted prior to the next legislative session. Stephanie Fyfe, Certification Coordinator will lead the review.

- CAEP has their own standards and they are different than State standards.
- CAEP standards exceed the State standards.
- Do CAEP standards respond to State standards?
- One of the glaring problems is that the CAEP standards say "are you approved by the state"? Purpose of review is to prove you are approved by the State.
