

## **Certification and Higher Education Committee**

Maine State Board of Education Minutes of the July 24, 2019 Meeting

The Certification and Higher Education Committee held a meeting on Wednesday, July 24, 2019, at the Department of Education in Augusta. The following were present: Committee Chair, Jane Sexton; Jana Lapoint; Wendy Ault; and Wilson Hess (Board Members). Jason Libby, Higher Education Specialist; Angel Loredo, Director of Higher Education and Educator Support Services; Emily Gribben, Educator Effectiveness; Jaci Holmes, Federal and State Legislative Liaison (Department of Education Staff) and Mary Becker, State Board Secretary Specialist.

Committee Chair, Jane Sexton called the meeting to order at 9:30 AM.

MOVED by Jana Lapoint, seconded by Jane Sexton, and unanimously voted by those present to accept the June 26, 2019 minutes as written.

## <u>Certification Office Update</u>: (Angel Loredo for Stephanie Fyfe)

- Renewal Season
  - $\circ$  61% of all renewals are complete
- Processing Time
  - o Complete initial applications 5 to 6 weeks
  - o Re-opened files 5 to 6 weeks
- Fingerprinting
  - o Project between DOE, OIT, and SBI is now complete
  - Push of a button, the Certification Office can get results to move applications forward
- Staffing
  - o Received funds to hire one additional evaluator
- MEIS
  - o Current contract ends July 1, 2020
  - o Angel has met with other states to develop new plan/contract
- Chapter 115
  - o Chapter 115 is in holding pattern
  - o When final word and language is approved, will need to work with developer
  - No need to do K-8 to K-6 changes right now, so cost would likely be 60K and would take 2 to 3 months to complete. Many applications received after September 16 cannot be processed until the system is ready.

#### GOAL #2: STREAMLINE AND ENHANCE TEACHER CERTIFICATION AND PREPARATION IN MAINE

The State Board of Education sets as its goal to streamline and enhance teacher certification and postsecondary educator preparation programs.

Rationale: Our students need the very best teachers in their classrooms. Right now, Maine is facing a severe shortage of high-quality teacher candidates at a time when the number of teacher retirements is ramping up steeply. Certification processes that facilitate the smooth & timely credentialing of qualified candidates is crucial to filling those vacancies. Further the very best quality teacher preparation programs possible at the post-secondary level are equally critical to filling the pipeline with highly effective teachers.

**Goal 2.1 Higher Education** - Purpose, Standards and Procedures for the Review and Approval of Preparation Programs for Educational Personnel. Chapter 114

Hold higher education programs to high standards in program reviews

Rationale: "Our students need the very best teachers in their classrooms"
