

CRRSA ESSER 2 funds are only available for obligation by SAUs through September 30, 2023, which includes the Tydings period (General Education Provisions Act §421(b) (1)). Any funds not invoiced by December 30, 2023 will no longer be accessible for your SAU. Please note that this date of December 30, 2023 does not affect the dated to obligate. The date to obligate remains September 30, 2023.

### **OBLIGATION**



§ 76.707 When obligations are made.

The following table shows when a State or a subgrantee makes obligations for various kinds of property and services.

If the obligation is for—	The obligation is made—
(a) Acquisition of real or personal property	On the date on which the State or subgrantee makes a binding written commitment to acquire the property.
(b) Personal services by an employee of the State or subgrantee	When the services are performed.
(c) Personal services by a contractor who is not an employee of the State or subgrantee	On the date on which the State or subgrantee makes a binding written commitment to obtain the services.
(d) Performance of work other than personal services	On the date on which the State or subgrantee makes a binding written commitment to obtain the work.
(e) Public utility services	When the State or subgrantee receives the services.
(f) Travel	When the travel is taken.
(g) Rental of real or personal property	When the State or subgrantee uses the

# FISCAL RESPONSIBILITY ACT OF 2023 AND COVID-19 RELIEF FUNDS

Grantees received information about the Fiscal Responsibility Act of 2023, which suspended the Federal debt ceiling. ESSER, GEER, and EANS funds awarded under the ARP Act and the CRRSA Act, as well as any remaining properly obligated funds under the CARES Act are not impacted. States and subgrantees should continue to spend down these resources urgently and wisely in accordance with approved State and local plans and statutory timelines for spending. ## TIPS FOR REIMBURSMENT REQUESTS

- When you update an invoice in the GEM system with new information, you need to <u>save</u> the invoice <u>prior to submitting</u> the invoice. Otherwise, the invoice will not be updated with the intended information.
- The billing period on your invoice can be monthly or up to a maximum of three months, but cannot overlap fiscal years.
- Summer accrual payments are charges for work that has been done, but not yet invoiced or paid out. SAUs can only seek reimbursement for summer accrual payments after the employee has received the payment.

### SUBSCRIPTION REMINDER

 Any services covering multiple years, such as warranties, maintenance plans, and software subscriptions, must be prorated and can only be charged to Federal funds for the cost amount during a grant's period of allowability.
