- 3. Eligible service providers participating in waiver and affirmation that they are in good standing: Maine School Food Authorities participating in the National School Lunch Program will participate in this said waiver. All are in good standing.
- 4. Description of the challenge the State agency is seeking to solve, the goal of the waiver to improve services under the Program, and the expected outcomes if the waiver is granted. [Section 12(l)(2)(A)(iii) and 12(l)(2)(A)(iv) of the NSLA]: This request is to allow Districts to provide FFVP to parent/guardians when they pick up their meals. This is needed for districts that are doing a combination of in person and remote learning, in order for families to pick up FFVP when remote learning occurs. Children receiving meals from FFVP sponsors will have continued, increased access to nutritious fresh fruits and vegetables throughout the COVID-19 pandemic.
- 5. Specific Program requirements to be waived (include statutory and regulatory citations). [Section 12(l)(2)(A)(i) of the NSLA]: Section 19(b) of the Richard B. Russell National School Lunch Act (NSLA) (42 USC 1769a); FFVP Handbook guidelines (page 12) states that fruits and vegetables may only be served during the school day (i.e., not before school or during afterschool programs).
- **6.** Detailed description of alternative procedures and anticipated impact on Program operations, including technology, State systems, and monitoring. We anticipate no impacts on technology, state systems. or monitoring. Schools will be instructed to provide the FFVP in addition to the breakfast and lunch meal (not as part of the fruit and vegetable component of the meal).
- 7. Description of any steps the State has taken to address regulatory barriers at the State level. [Section 12(I)(2)(A)(ii) of the NSLA]: Educate DOE and local administrators of current methods under Federal and State regulations and what the waiver would allow. There are currently no state level regulatory barriers that would impact this issue.

- 9. Description of how the waiver will not increase the overall cost of the Program to the Federal Government.
