## **UNFINISHED (OLD) BUSINESS:**

## CONSIDERATION OF ONE ADDITIONAL MEMBER TO THE NATIONAL INSTITUTE OF FUNERAL SERVICES (NIFS) REVIEW COMMITTEE.

<u>BACKGROUND</u>: The National Institute of Funeral Services applied for degree granting authority in the State of Maine under Chapters 149 and 170. On October 12, 2022, the State Board of Education approved a review committee to consist of Dr. Lynne Coy-Ogan of Husson University to serve as the review committee chair, members Dr. Alicia Wilcox of Thomas College and Ms. Julie Ann Johnson of Conroy-Tully Walker Funeral Homes, and Thomas E. Keller as Observer for the State Board of Education.

On March 8, 2023, the State Board approved two additional individuals of Maine's institutions of higher education to the review committee: Elizabeth Russell, EMCC President, and Aili Robinson, University of Maine at Augusta Executive Director of Financial Services and Administration.

To fill the seat of the fifth individual who will be representative of Maine's institutions of higher education on the review committee, Richard Roberts, UMaine's Executive Director of Academic Program Support and Online Learning for the Division of Lifelong Learning, has agreed to serve.

<u>RECOMMENDATION:</u> That the State Board of Education approve the addition of Richard Roberts to the NIFS Review Committee.

MOTION by Wendy Ault, seconded by Paulette Bonneau, and unanimously voted by those present to approve the addition of Richard Roberts to the NIFS Review Committee. The motion is adopted.
