The testing window for ACCESS for ELLs and WIDA Alternate ACCESS ends on Friday, February 28, 2025.

Districts and schools should ensure that all students scheduled to test have done so by this date.

You can monitor the completion of testing in <u>WIDA AMS</u> by utilizing the Operational Dashboard in Reporting Services.

Based on <u>Elementary & Secondary Education Act</u>, or <u>ESEA</u> (as amended by <u>ESSA</u>, 2015), a student is not required to participate in ACCESS if the ML Start Date falls less than 30 days within the close of the ELP assessment window, based on federal provision of up to 30 calendar days for LEAs (in Maine, SAUs) to screen students for potential ML status. For SY24-25, this date is on or after January 29, 2025.
