

Welcome to the 2025–2026 School Year: Clear Roles, Strong Systems, and Equitable Access for Multilingual Learners

As we begin a new school year, the Maine Department of Education reaffirms that collaboration, clarity, and compliance are key to ensuring every Multilingual Learner (ML) receives the education they deserve. Equitable access begins with clearly defined roles, certified staffing, and programmatic integrity across all districts.

Every school district in Maine is required to designate a <u>Director/Coordinator of Multilingual Programs</u>, who has the authority to lead programming across all grade levels. This role is not optional; it is foundational. The Director/Coordinator must oversee key areas such as ML identification, ensuring that English language development (ELD) instruction is led by a 660 Certified educator, language access, and family engagement, while ensuring compliance with federal civil rights law (34 C.F.R. §100.3(b)(2)) and state requirements.

These requirements ensure ML students build English proficiency while fully participating in grade-level content learning. English proficiency is not a prerequisite for access to general education classrooms. ML students must remain in content-area courses with appropriate scaffolds and language support. To build shared capacity across roles, all educators are encouraged to engage in annual WIDA training. While time-intensive, these trainings are a critical investment in professional growth and educational equity.

Technology Updates and Reminders

This was shared during the summer with all Assessment Coordinators.

As part of annual technology updates, the DRC INSIGHT Chromebook application has transitioned from a Kiosk mode application to a Progressive Web Application (PWA). Districts have until July 31, 2025, to uninstall the Kiosk application and install the PWA application on their Chromebooks. After this date, students will be prevented from testing until installation is complete. Please make sure to complete this update prior to July 31 to ensure testing, including ACCESS Screening, is not interrupted.
