Fern Desjardins called the meeting to order at 1:03 p.m. and asked all participants to introduce themselves.

Chair Desjardins then asked Committee members if there were any questions regarding the first order of business, *Approval of the August 26, 2022 minutes*. There were none. Motion by Kristin Bishop, seconded by Wilson Hess, and voted unanimously to accept the August 26, 2022 minutes as written.

Chair Desjardins then outlined the primary agenda item for the remainder of the meeting, *School Construction & Renovations Discussion with MSSA Representatives*. She reviewed communications and events leading up to this agenda item including the October 13, 2022 meeting organized by the Department where the regional superintendents expressed a number of questions and recommendations regarding the Department's school construction programs. Chair Desjardins further reviewed her notes and highlights of that meeting before turning the floor over to the regional superintendents and others present to continue those discussions.

All meeting participants contributed in making a number of suggestions for improvement or further analysis. Proposals included raising the \$1 million cap for School Revolving Renovation Fund (SRRF) projects; reducing the local contribution component for approved SRRF projects; increasing the amount of funding in the SRRF; creating a new construction program for small projects (\$10 million project size); develop a new school construction rule (Chapter 62.5) so that existing programs could remain the same while creating a new program to address declining enrollments and consolidation, improve culture & equity, and implement 21st Century Programming; raising the Statutory Debt Limit for Major Capital Construction; dedicated funding to address projects that would close and consolidate schools within districts. Eileen King offered to compile what had been discussed and then reach out to the Department to review possibilities of legislation.

The Committee moved to the next agenda item, *Correspondence from MSAD 33*. Chair Desjardins acknowledged the receipt of the RSU 33 correspondence and facility report prepared by WBRC Inc. After discussion it was agreed that the Chair would draft a response.

The Committee then discussed their upcoming meeting schedule and possible agenda items.

The meeting was adjourned at 3:02 p.m.
