Maine State Board of Education Minutes of the October 28, 2020 Meeting

The Certification and Higher Education Committee held a virtual meeting on Wednesday, October 28, 2020, via Zoom. The following were present: Committee Chair, Wendy Ault; Fern Desjardins; Casey Maddock; and Wilson Hess (Board Members). Deputy Commissioner Daniel Chuhta; Angel Loredo, Director of Higher Education and Educator Support Services; Jason Libby, Higher Education Specialist; (Department of Education) and Mary Becker, State Board Secretary Specialist.

<u>Certification Office Update</u>: (Angel Loredo for Stephanie Fyfe)

MEIS Info - Online System:

- Since the Executive Order, 1,324 applications have been received.
- Since the September 23rd meeting, the Certification Office has received 650 applications which is included in the 1,324.
- Currently, 11% of the applications (144) are pending. These applications are missing information.
- Many applications are from out-of-state (Massachusetts, New York, New Jersey and Vermont). Angel Loredo was asked to report the number of applicants with no Praxis scores. Fern Desjardins requested a report breaking down different areas and where the need is with certification.
- The process is going well.
- Angel Loredo reported on conditional and professional certificates (Chapter 115, Part II).
 He reminded the Committee that the Praxis was waived under an executive order due to COVID-19.

<u>Higher Education Update:</u> (Jason Libby)

Update on Team Reports:

 observer for the CAEP review and the State review should be the same person and
 be a member of the C&HE Committee.

 - UMaine at Machias Requested delay to April 2020 Pandemic moved review to November of 2020 - delayed
- College of the Atlantic (COA) expressed concerns regarding a review in the Spring.

In January 2021, the Committee will revisit the status of the reviews.

UNE's Graduate Education Program:

At the September 23, 2020 C&HE Committee meeting, Jason Libby requested that the Committee further discuss the UNE Graduate Education Program which requires approval for its education program and special education endorsement areas. A delay in the review could potentially affect this program. The review is an initial approval and not a renewal.

After much discussion, it was suggested that Jason Libby provide a recommendation for the Committee to consider at the October 28, 2020 meeting.

Jason had a meeting with UNE. Following that conversation, he created a format that could be followed to review the Inclusion degree program. Jason shared the format with the Committee.

Format:

- 1) Unit Introduction
 - a. Overview of College with a focus on the inclusion degree
- 2) Dean of the College of Graduate and Professional Studies (CGPS) and Associate Dean of Academic Operations, along with the Education Program Director
- 3) Coursework exemplar(s) on Blackboard
- 4) Session with current or former students of the program
- 5) Local educational leader(s)
- 6) Follow-up time for additional questions

- Curriculum map
- Notes from curriculum committee meetings that detail past decisions and future plans for Inclusion courses
- Course syllabi with outcomes for all Inclusion courses
- CV's for faculty members that teach Inclusion coursework
- Exemplars from the program to highlight student work (portfolio, etc.)
- Program data related to enrollment, alumni, etc.

At the Committee's suggestion, Mary Becker, will send the format to Jana Lapoint for her review and comment, as she was not available for the October 28th meeting and agreed to serve as the Board observer.
