

# **Certification and Higher Education Committee**

Maine State Board of Education Minutes of the October 6, 2020 Special Meeting

The Certification and Higher Education Committee held a virtual meeting on Tuesday, October 6, 2020, via Zoom. The following were present: Committee Chair, Wendy Ault; Fern Desjardins; Peter Geiger; and Wilson Hess (Board Members). #### Chapter 115 Update:

Commissioner Chuhta reviewed his memorandum dated October 5, 2020 and distributed to the Certification and Higher Education Committee members:

The Chapter 115 Consensus-based Rulemaking Committee, composed of educators from across the state in various roles, has been meeting weekly since May 28 (except for one week off for the July 4th holiday) and they have covered much ground! They began by reviewing the documentation shared with the State Board this past spring. The Department is striving for a rule that would be enduring and hold high expectations for educators yet would also address the need for a diverse educator workforce. Additionally, the new rule should be clear, simple and flexible. The Committee explored ways other states (and provinces) address their certification rules, identifying areas to embrace and avoid. They undertook a view of the current rules and other rules that interact with Chapter 115. Finally, they discussed the differences between credentialing criteria, employability characteristics, and ongoing skill development.

The Committee then broke into smaller groups to begin authoring a new Part II. The groups focused on certificates that fall under the categories of administrator, special education, teacher, and career and technical education. The full Committee also heard presentations from groups representing school psychologists, school library media specialists, and career and technical education. The Department has retained the responsibility for addressing changes to the education specialist certificates/endorsements, as well as Part I of the rule.

An aggressive rulemaking timeline was then discussed considering the complexity of certain components of the rule, and the following dates were proposed:

The Certification and Higher Education Committee agreed to proceed with the timeline contingent upon the Committee having the opportunity to fully review the proposed Chapter 115 rule with adequate time for comments and questions.

Shelly Mogul reviewed the changes to section 4 – Administrator Certificates
