


Child Nutrition Programs

- National School Lunch Program (NSLP)
 - NSLP Afterschool Snack Service
 - NSLP Seamless Summer Option (SSO)
- School Breakfast Program (SBP)
- Fresh Fruit & Vegetable Program (FFVP)
- USDA Foods Distribution Program (FDP)
- Special Milk Program (SMP)
- CACFP At-Risk Afterschool Program ("At Risk")
- Summer Food Service Program (SFSP)



Food Based Menu Planning

- 5 Food Components
- 1. Fruits
- 2. Vegetables
- 3. Grains
- 4. Meat/Meat Alternate
- 5. Milk





National School Lunch Program (NSLP)

- 5 Food Components
- Serving size requirements by grade groups
- Weekly average guidelines for calories, fat, sodium
- Reimbursement for 1 complete meal to student/school day





School Breakfast Program (SBP)

- 3 Food Components
- Serving size requirements
- Weekly average guidelines for calories, fat, sodium
- Reimbursement for 1 complete meal to student/day





Fresh Fruit & Vegetable Program (FFVP)

- Fresh fruits/vegetables
- Outside of SBP/NSLP meal service
- Elementary schools that qualify
- Funding determined per student



Food Distribution Program (FDP)

- Planned Assistance Level (PAL) \$ Value
 - USDA Food
 - DOD Fresh
 - Net-Off Invoice (NOI)
- What is on your Annual Order?
- Participating in DOD Fresh? NOI?

Special Milk Program

- Milk for students without access to SBP/NSLP
 - Half-day kindergarten





NSLP Afterschool Snack

- Falls under the NSLP regulations
- Optional to participate
- Offered after the school day ends to schoolsponsored enrichment programs
- Reimbursable snack is 2 different food components
 - Ex. 1 oz cereal and 8 oz milk
 - Ex. 1 oz crackers and 1 oz cheese





CACFP At-Risk Afterschool ("At-Risk")

 Qualifying afterschool programs may serve a snack or a supper meal "super snack" at no charge to children.

 Maine schools with >50% F/R eligibility and an afterschool enrichment program must participate or opt out

Summer Food Service Program

- Offered in summer months when school is not in session
- Qualifying locations provide meals at no cost to children
- Follow the SFSP meal pattern





Seamless Summer Option (SSO)

- Operates in the summer months when school is not in session
- SFA sponsors can operate this summer meals program to streamline operations and reduce paperwork
- Follow the SBP/NSLP meal pattern
- Receive SBP/NSLP reimbursement rates



Annual Participation Packet & Agreement

- Annual agreement between the SAU and the SA to participate in federal child nutrition programs
- Completed in CNPweb by August 15
- Approved by the SA prior to operation
- Sponsor agrees to:
 - Offer free and reduced-price meals to eligible students
 - Offer meals that meet meal pattern & other requirements
 - Operate a non-profit food service program
 - Not overtly identify or discriminate against any student



CNPweb

- Child Nutrition Software Program
 - Annual agreement
 - Monthly Claim for reimbursement
 - All programs: SNP/FDP/CACFP/SFSP

Eligibility for Free & Reduced-price Meals

- A student may be determined to be eligible for free or reduced-price meals by:
 - Completed F/R meal benefit application
 - Direct certification list from the State Agency
- State of Maine funds meals at "no charge" to publicly funded students, claimed by individual student eligibility















Reimbursement for Student Meals

- Reimbursement = # of meals served (F/R/P) X reimbursement rate (F/R/P)
- No reimbursement for adult meals
- No reimbursement for second meals
- No reimbursement for incomplete meals
- Meals must be tracked properly (accountability)
- Claim for reimbursement filed by the 8th day after the month meals are served
 - September meals, claim may be filed October 1-8
 - Up to 60 days to file a claim



Reimbursement for Student Meals

- 1. Offer a meal that meets meal pattern requirements
- 2. When a complete meal is selected by a student, it is recorded by student eligibility
- At the end of the month claim is filed reporting # of F/R/P meals served
