The RSU 01 Nutrition Program was reviewed on January 13, 2020 per Federal Regulation 7CFR 210.18 and Maine Department of Education Child Nutrition policies and procedures.

Responses must be submitted through CNPweb, Maine Department of Education Child Nutrition's Administrative Review software, and must address the following:

- How the finding was corrected (include who, when & how)
- Documentation that the finding has been corrected district-wide
- How this action will ensure future compliance

In accordance with §210.18(k), failure to return completed documentation within 30 days from the corrective action deadline date will result in the withholding of reimbursement payments. We hope that following the exit conference you and your staff addressed the corrective actions and that you will have no problems in meeting the response deadline.

The Official Notification also provides the potential fiscal action, which is an initial estimate of the amount of reimbursement that will be reclaimed. These are only estimates which must be adjusted to the actual date of corrective action for each violation. If documentation of corrective action or acceptable corrective action is not received by the response date stated above, the claim will be recalculated to the end of the school year.

Technical Assistance

- * The Maine non-discrimination statement was missing from eligibility notification letters. This was corrected the same day.
- * Financial transactions that occur over the summer months need to be captured in NEO by either filing claims over the summer months or including them when filing the September claim for reimbursement.
- * Prior to the next Administrative Review, the RSU 1 Local Wellness Policy needs to be revised to include the following:
 - Nutrition Promotion language is throughout the policy, but it is recommended to have a specific section since this is
 a required element
 - Other School-Based Wellness Activities Language is throughout the policy, but it is recommended to have a specific section since this is a required element
 - Food and beverage marketing Language needs to clearly state that only the marketing of foods and beverages that
 are smart snack compliant are allowed
 - Nutrition Standards for sale outside of foodservice References "RSU 1 List of Healthy Snacks and Beverages Revised 2018". These items need to meet smart snack guidelines
 An assessment of the Local Wellness Policy must be completed every 3 years

Finding 9000: Meal benefit approval errors

Five errors: Two students changed from free to reduced-price benefits. Two students changed from reduced-price to free meal benefits. The State of Maine currently pays the reduced-price charge for school meals, so this change did not adversely affect any household. One student changed from Free to paid because there was no documentation on file but was receiving Free meal benefits.

Potential Fiscal Action to be determined.

Corrective Action:

Change eligibility status in the benefit issuance system. Submit a copy of the benefit listing for the select students to verify the change has occurred.

- Insufficient MMA 1 day with chicken noodle soup (.25)

Submit a response of how daily and weekly quantities will be met when planning menus.

Submit 5 consecutive days of production records and supporting documentation to show that daily & weekly minimum quantities are offered.
