Certification and Benefit Issuance - East Machias Public Schools (1400)

128. Correct conversion factors used for applications with more than one income frequency?

Finding 9019: Incorrect conversion factors used when processing applications.

For applications that indicate more than one income frequency, the SFA did not use the correct conversion factors to determine monthly household income: weekly – times 52; bi-weekly – times 26; twice per month – 24; and monthly – times. 12. When only one income frequency is reported on the Meal Benefit application converting to annual income is not required and could lead to errors if not done correctly.

Technical Assistance:

The correct process was explained to the Approving Official. None of the applications reviewed with incorrect income calculations resulted in an incorrectly approved application.

133. Direct Certifications correctly certified?

Finding 9024: Some students directly certified for free meals were not certified correctly.

Direct certification documentation for selected students was reviewed for completeness and accuracy. Some students were not certified for free meals correctly.

Technical Assistance:

Approving Office does not have access to the DC list. It comes from the central office. A plan needs to be developed to have more readily access to the DC list.
