410. Review period menus and production records - Quantities and meal pattern requirements met?

Finding 9076: Planned menus served during Review month do not meet portion size/quantity requirements. Productions records were reviewed for the Review Period to determine whether the portion sizes of meal components from the planned menu and served during the Review Period meet the minimum meal pattern requirements for the age/grade group(s) being served. Meals served with insufficient portion size or insufficient quantities of meal components are incomplete and are not reimbursable.

Based on a review of production records and other supporting food crediting documentation for 1 week during the Review Period (12/6/21-12/10/21), some meals served during the week reviewed did not meet the appropriate daily and weekly meal pattern requirements for the age/grade group being served. Documentation shows that less than 3/4 cup of vegetables were offered on 12/8/21 and 12/10/21.

Corrective Action:

Corrective Action has already been received; training has been provided to staff. No further Corrective Action is required.
