## Procurement Review Report Scarborough School Nutrition Program SY 2024

A review of the Scarborough School Nutrition Department procurement practices from SY2023 was conducted to ensure compliance with Federal Regulations 2 CFR 200, 7 CFR 210, as well as applicable local laws.

Code of Conduct- The school nutrition department did not have a Code of Conduct as required by 2 CFR 200.318(c)(1). The current Code of Conduct does not 1) prohibit officers, employees and agents from soliciting or accepting gratuities, favors or anything of monetary value from contractors or parties of subcontractors nor 2) include language that the SFA will neither solicit nor accept gratuities favors, or anything of monetary value from contractors or parties to subcontracts, or language with standards for situations when the financial interest is not substantial or the gift is unsolicited and of nominal value. **Required Corrective Action-** Update the Code of Conduct to ensure the federal requirements are met. Submit the updated Code of Conduct to <a href="mailto:adriane.ackroyd@maine.gov">adriane.ackroyd@maine.gov</a>

<u>Procurement Procedures</u>- Policy DJ-R – Federal Procurement Manual was reviewed. It is not compliant with 2 CFR 200.318 by exempting federal child nutrition programs (see #4 & #5 under section I. Exceptions to These Administrative). Federal child nutrition programs are required to follow the procurement regulations outlined in this manual.

The Scarborough capital equipment threshold of \$50,000 is less restrictive than the federal threshold of \$5,000.

**Required Corrective Action-** Update the procurement procedures to ensure the federal requirements are met. Adjust the capital equipment threshold to \$5,000 or less. Submit the updated procedures to <a href="mailto:adriane.ackroyd@maine.gov">adriane.ackroyd@maine.gov</a>.

## Micro-Purchases-

**Technical Assistance** – Micro-purchasing requires that purchases are distributed equitably among qualified suppliers and that prices are reasonable. Scarborough has distributed purchases amongst many different vendors. As a reminder, if price comparing, small purchase procedures

must be followed and documentation maintained that multiple quotes have been received and small purchase procedures followed.

**Formal Purchases**- The Scarborough School Nutrition Department is in a member of the York Cumberland buying group. Documentation for the solicitation and award of a prime vendor contract was reviewed. There are no findings.
