Any child age 18 years or younger can receive meals at no cost to families from any meal service and distribution sites in the towns/cities listed below. Children do not have to be a resident or attend school in these towns. Locations and times for meal service and distribution vary with each location and are subject to change as programs continue to adapt to demand and changing logistics.
