#### Transferred Monies

• Maintaining Ledgers



#### **Title Transfers**

 Districts may choose to transfer funds from one Title to another

- Transfers are no longer invoiced separately

- Some may have more than one Title transfer



### **Grants4ME Proportional Payment of Invoices**

Title IA Allocation of \$100,000 Title IIA Allocation of \$50,000

If \$20,000 of Title IIA funds are transferred to Title IA, Grants4ME will see the total pot of funds as \$120,000 in Title IA.

When Title IA funds are invoiced for on the backend of the system it will parse out what percentage of the funds are Title IA and what percent are Title IIA.

In this example: \$20,000 is 1/6 of the total \$120,000 which would also be 16.67% \$100,000 is 5/6 of the total \$120,000 which would also be 83.33%

If an invoice for \$30,000 for Title IA funds is submitted, the Grants4ME system will pay 1/6 of the total request or \$5,000 from Title IIA and 5/6 of the total request or \$25,000 from Title IA.
