DBE GOAL NOTICE

Maine Department of Transportation Disadvantaged Business Enterprise Program

CONSTRUCTION AGREEMENT

This Construction Agreement ("Agreement") is made as of <u>April 22</u>, 2024, by and between Springfield Terminal Railway Company, with its headquarters located at 1700 Iron Horse Park, North Billerica, Massachusetts 01862 ("Railroad"), and the Maine Department of Transportation, an agency of the State of Maine ("Agency").

EXPLANATORY STATEMENT

- 1. Agency is undertaking the following project: Bridge Painting project on Interstate 95 in Fairfiled, Maine (the "**Project**"). The Project will be performed by one or more Agency contractors.
- 2. Agency has obtained, or will obtain, all authorizations, permits and approvals from all local, state and federal agencies (including Agency), and their respective governing bodies and regulatory agencies, necessary to proceed with the Project and to appropriate all funds necessary to construct the Project.
- 3. Agency acknowledges that: (i) by entering into this Agreement, Railroad will provide services and accommodations to promote the public interest in the Project, without profit or other economic inducement typical of other Agency contractors; (ii) neither Railroad nor its affiliates (including their respective directors, officers, employees or agents) will incur any costs, expenses, losses or liabilities in excess of payments made to Railroad, by or on behalf of Agency or its contractors, pursuant to this Agreement; and (iii) Railroad retains the paramount right to regulate all activities affecting its property and operations.
- 4. It is the purpose of this Agreement to provide for the terms and conditions upon which the Project may proceed.

NOW, THEREFORE, in consideration of the foregoing Explanatory Statement and other good and valuable consideration, the receipt and sufficiency of which are acknowledged by the parties, the parties agree as follows:

1. Project Plans and Specifications.

Preparation and Approval. Consistent with Exhibit A of this Agreement, all plans, specifications, drawings and other documents necessary or appropriate to the design and construction of the Project shall be prepared, at Agency's sole cost and expense, by Agency or Railroad or their respective contractors. Project plans, specifications and drawings prepared by or on behalf of Agency shall be subject, at Railroad's election, to the review and approval of Railroad. Such plans, specifications and drawings, as prepared or approved by Railroad, are referred to as the "Plans" and shall be incorporated and deemed a part of this Agreement. Plans prepared or submitted to and approved by Railroad as of the date of this Agreement are set forth in Exhibit B to this Agreement.

- 1.2 <u>Effect of Railroad Approval or Preparation of Plans</u>. By its review, approval or preparation of Plans pursuant to this Agreement, Railroad signifies only that such Plans and improvements constructed in accordance with such Plans satisfy Railroad's requirements. Railroad expressly disclaims all other representations and warranties in connection with the Plans, including, but not limited to, the integrity, suitability or fitness for the purposes of Agency or any other persons of the Plans or improvements constructed in accordance with the Plans.
- 1.3 Compliance with Plans. The Project shall be constructed in accordance with the Plans.

2. Allocation and Conduct of Work.

Work in connection with the Project shall be allocated and conducted as follows:

- 2.1 <u>Railroad Work.</u> Subject to timely payment of Reimbursable Expenses as provided by Section 4, Railroad shall provide, or cause to be provided, the services as set forth in <u>Exhibit A</u> to this Agreement. Agency agrees that Railroad shall provide all services that Railroad deems necessary or appropriate (whether or not specified by <u>Exhibit A</u>) to preserve and maintain its property and operations, without impairment or exposure to liability of any kind and in compliance with all applicable federal, state and local regulations and Railroad's contractual obligations, including, but not limited to, Railroad's existing or proposed third party agreements and collective bargaining agreements.
- 2.2 <u>Work by Agency's Contractors</u>. Agency's contractor(s) shall perform, or cause to be performed, all work as set forth in <u>Exhibit A</u>, at Agency's sole cost and expense.
- 2.3 Conduct of Work. Railroad shall commence its work under this Agreement following:

 (i) delivery to Railroad of a notice to proceed from Agency; (ii) payment of such Reimbursable Expenses (as provided by Section 4.1) as required by Railroad prior to the commencement of work by Railroad as stated in the Payment Schedule; (iii) issuance of all permits, approvals and authorizations necessary or appropriate for such work; and (iv) delivery by Agency's contractor(s) of proof of insurance acceptable to Railroad, as required by Section 8. The initiation of any services by Railroad pursuant to this Agreement, including, but not limited to, the issuance of purchase orders or bids for materials or services, shall constitute commencement of work for the purposes of this Section. The parties intend that all work by Railroad or on Railroad property shall conclude no later than December 31, 2024, unless the parties mutually agree to extend such date.

- 2.4 <u>Flagging Services</u>. If Railroad determines that flagging services for the Project are to be provided by a contractor hired by Railroad, Railroad will advertise for flagging services for the Project, as a whole, upon execution of this Agreement. Agency acknowledges that it may take Railroad up to 90 days to procure contracted flagging services for the

Project, and Railroad shall not be liable for the cost of delaying the commencement of the first Project work that requires flagging services where the delay is caused by the time required to obtain contracted flagging services for the Project.

3. <u>Special Provisions</u>. Agency shall require its contractors performing Project work ("Contractors") to observe and abide by, the terms, conditions and provisions set forth in <u>Exhibit C</u> to this Agreement (the "Special Provisions"). Agency further agrees that, prior to the commencement of Project work, each Contractor shall execute and deliver to Railroad <u>Schedule I</u> to this Agreement to acknowledge Contractor's agreement to observe and abide by the Special Provisions.

4. Cost of Project and Reimbursement Procedures.

- 4.1 Reimbursable Expenses. Agency shall reimburse Railroad for all costs and expenses incurred by Railroad in connection with the Project, including, without limitation: (1) all out of pocket expenses, (2) travel and lodging expenses, (3) telephone, facsimile, and mailing expenses, (4) costs for equipment, tools, materials and supplies, (5) sums paid to Railroad's consultants and subcontractors, and (6) Railroad labor in connection with the Project, together with Railroad labor overhead percentages established by Railroad pursuant to applicable law (collectively, "Reimbursable Expenses"). Reimbursable Expenses shall also include expenses incurred by Railroad prior to the date of this Agreement to the extent identified by the Estimate provided pursuant to Section 4.2.
- 4.2 <u>Estimate</u>. Railroad has estimated the total Reimbursable Expenses for the Project as shown on <u>Exhibit D</u> (the "Estimate", as amended or revised). In the event Railroad anticipates that actual Reimbursable Expenses for the Project may exceed such Estimate, it shall provide Agency with the revised Estimate of the total Reimbursable Expenses, together with a revised Payment Schedule (as defined by Section 4.3.1), for Agency's approval and confirmation that sufficient funds have been appropriated to cover the total Reimbursable Expenses of such revised Estimate. Railroad may elect, by delivery of notice to Agency, to immediately cease all further work on the Project, unless and until Agency provides such approval and confirmation. Furthermore, Agency acknowledges and understands that any estimated cost to construct the Project shall only be good for a limited period of time and that any delays to move to construction, if Railroad agrees to such construction, shall result in increased costs.

4.3 Payment Terms.

4.3.1 Agency shall pay Railroad for Reimbursable Expenses in the amounts and on the dates set forth in the Payment Schedule as shown on Exhibit E (the "Payment Schedule", as revised pursuant to Section 4.2). Railroad agrees to submit invoices to Agency for such amounts and Agency shall remit payment to Railroad at the later of (i) thirty (30) days following delivery of each such invoice to Agency, or (ii) the payment date (if any) set forth in the Payment Schedule.

- 4.3.2 Following completion of the Project, Railroad shall submit to Agency a final invoice that reconciles the total Reimbursable Expenses incurred by Railroad against the total payments received from Agency. Agency shall pay Railroad the amount by which Reimbursable Expenses exceed total payments, as shown by the final invoice, within thirty (30) days following delivery of such final invoice to Agency. In the event that payments received by Railroad from Agency exceed the Reimbursable Expenses, Railroad shall remit such excess to Agency.
- 4.3.3 In the event that Agency fails to pay Railroad any uncontested amounts due Railroad under this Agreement: (i) Agency shall pay Railroad interest at the lesser of 1.0% per month or the maximum rate of interest permitted by applicable law on the uncontested amount until paid in full; and (ii) Railroad may elect, by delivery of notice to Agency: (A) to immediately cease all further work on the Project, unless and until Agency pays the entire delinquent sum, together with accrued interest; and/or (B) to terminate this Agreement.
- 4.3.4 All invoices from Railroad shall be delivered to Agency in accordance with Section 15 of this Agreement. All payments by Agency to Railroad shall be made either by (i) electronic payment to an account designated by Railroad, or (ii) by State of Maine check mailed to the following address or such other address as designated by Railroad's notice to Agency:

- 4.4 <u>Effect of Termination</u>. Agency's obligation to pay Railroad Reimbursable Expenses in accordance with this Section 4 shall survive termination of this Agreement for any reason.
- 4.5 <u>Damage Claims</u>. Agency may pursue claims for any direct damages resulting from Railroad's failure to timely perform its obligations under this Agreement, and Agency may pursue claims for any direct damages resulting from Railroad's conduct of its work on the Project. Agency shall not be entitled to pursue claims for consequential, indirect or incidental damages or lost profits.
- 5. <u>Appropriations</u> Agency represents to Railroad that: (i) Agency has appropriated funds sufficient to reimburse Railroad for the Reimbursable Expenses encompassed by the Estimate attached as <u>Exhibit D</u>; (ii) Agency shall use its best efforts to obtain appropriations necessary to cover Reimbursable Expenses encompassed by subsequent Estimates approved by Agency; and (iii) Agency shall promptly notify Railroad in the event that Agency is unable to obtain such appropriations.
- 6. Easements and Licenses.

- 6.1 <u>Agency Obligation</u>. Agency shall acquire all necessary licenses, permits and easements required for the Project.
- 6.2 <u>Temporary Construction Licenses</u>. Insofar as it has the right to do so, Railroad hereby grants Agency a nonexclusive license to access and cross Railroad's property, to the extent necessary for the construction of the Project (excluding ingress or egress over public grade crossings), along such routes and upon such terms as may be defined and imposed by Railroad and such temporary construction easements as may be designated on the Plans approved by Railroad.
- 6.3 <u>Temporary Construction Easements.</u> Railroad may grant without warranty to Agency, if required, a temporary non-exclusive easement for access to the extent necessary for the Project on terms and conditions and at a price acceptable to the parties.
- 6.4 <u>Permits.</u> At its sole cost and expense, Agency shall procure all permits and approvals required by any federal, state, or local governments or governmental agencies for the construction, maintenance and use of the Project, copies of which shall be provided to Railroad.

7. Termination.

- 7.1 <u>By Agency</u>. For any reason, Agency may terminate this Agreement by delivery of notice to Railroad.
- 7.2 <u>By Railroad</u>. In addition to the other rights and remedies available to Railroad under this Agreement, Railroad may terminate this Agreement by delivery of notice to Agency in the event Agency or its Contractors fail to observe the terms or conditions of this Agreement and such failure continues more than ten (10) business days following delivery of notice of such failure by Railroad to Agency.
- 7.3 Consequences of Termination. If this Agreement is terminated by either party pursuant to this Section or any other provision of this Agreement, the parties understand that it may be impractical for them to immediately stop the work. Accordingly, they agree that, in such instance a party may continue to perform work until it has reached a point where it may reasonably and safely suspend the work. Agency shall reimburse Railroad pursuant to this Agreement for the work performed, plus all costs reasonably incurred by Railroad to discontinue the work and protect the work upon full suspension of the same, the cost of returning Railroad's property to its former condition, and all other costs of Railroad incurred as a result of the Project up to the time of full suspension of the work. Termination of this Agreement or work on the Project, for any reason, shall not diminish or reduce Agency's obligation to pay Railroad for Reimbursable Expenses incurred in accordance with this Agreement. In the event of the termination of this Agreement or the work for any reason, Railroad's only remaining obligation to Agency shall be to refund to Agency payments made to Railroad in excess of Reimbursable Expenses in accordance with Section 4.

8. <u>Insurance</u>. In addition to the insurance that Agency requires of its Contractors, Agency's Contractors shall purchase and maintain insurance in compliance with Railroad's insurance requirements stated in <u>Exhibit C</u>. No work by Agency's Contractors shall commence until such policy or policies have been submitted to and approved by Railroad's Risk Management Department.

9. Ownership and Maintenance.

- 9.1 By Agency. Agency shall own and, without cost to Railroad, maintain, repair, replace and renew, or cause same to be done, in good condition and repair to Railroad's satisfaction, the highway overpass structure, the roadway surfacing, the roadway slopes, the retaining walls, and the highway drainage facilities. In the event that Agency fails to properly maintain such structures and improvements and such failure, in the opinion of Railroad, jeopardizes the safe and efficient operation of its property, Railroad shall be entitled to remedy such failure and recover from Agency the costs incurred by Railroad in doing so. Upon the cessation of use of the Project by Agency, Agency shall remove the bridge structure and restore Railroad's property to its original condition, at Agency's sole cost and expense, to Railroad's satisfaction.
- 9.2 <u>Alterations</u>. Agency shall not undertake any alteration, modification or expansion of the Project that will impact Railroad without the prior approval of Railroad, which may be withheld for any reason, and the execution of such agreements as Railroad may require.

10. [RESERVED]

- 11. <u>Independent Contractor</u>. The parties agree that neither Agency nor its Contractors shall be deemed either agents or independent contractors of Railroad. Except as otherwise provided by this Agreement, Railroad shall exercise no control whatsoever over the employment, discharge, compensation of, or services rendered by Agency or Agency's Contractors, or the construction practices, procedures, and professional judgment employed by Agency or its Contractors to complete the Project. Notwithstanding the foregoing, this Section 11 shall in no way affect the absolute authority of Railroad to prohibit Agency or its Contractors or anyone from entering Railroad's property, or to require the removal of any person from its property, if it determines, in its sole discretion, that such person is not acting in a safe manner or that actual or potential hazards in, on or about the Project exist.
- 12. "Entire Agreement." This Agreement embodies the entire understanding of the parties, may not be waived or modified except in a writing signed by authorized representatives of both parties, and supersedes all prior or contemporaneous written or oral understandings, agreements or negotiations regarding its subject matter. In the event of any inconsistency between this Agreement and the Exhibits, the more specific terms of the Exhibits shall be deemed controlling.

- 13. <u>Waiver</u>. If either party fails to enforce its respective rights under this Agreement, or fails to insist upon the performance of the other party's obligations hereunder, such failure shall not be construed as a permanent waiver of any rights or obligations in this Agreement.
- 14. <u>Assignment</u>. Railroad may assign this Agreement and all rights and obligations herein to a successor in interest, parent company, affiliate, or future affiliate. Railroad shall notify Agency of any such assignment. Upon assignment of this Agreement by Railroad and the assumption by Railroad's assignee of Railroad's obligations under this Agreement, this Agreement shall remain in effect, with Railroad's assignee thereafter being considered "Railroad" hereunder. Agency shall not assign its rights or obligations under this Agreement without Railroad's prior consent, which consent may be withheld for any reason.
- 15. Notices. All notices, consents and approvals required or permitted by this Agreement shall be in writing and shall be deemed delivered upon personal delivery, upon the expiration of three (3) days following mailing by first class U.S. mail, or upon the next business day following mailing by a nationally recognized overnight carrier, to the parties at the addresses set forth below, or such other addresses as either party may designate by delivery of prior notice to the other party:

- 16. <u>Severability</u>. The parties agree that if any part, term or provision of this Agreement is held to be illegal, unenforceable or in conflict with any applicable federal, state, or local law or regulation, such part, term or provision shall be severable, with the remainder of the Agreement remaining valid and enforceable.
- 17. <u>Applicable Law</u>. This Agreement shall be governed by the laws of the State of Maine, exclusive of its choice of law rules. The parties further agree that the venue of all legal and equitable proceedings related to disputes under this Agreement shall be situated in Kennebec County, Maine, and the parties agree to submit to the personal jurisdiction of any State or Federal court situated in or with venue over Kennebec County, Maine.

Good Morning All,

Here is the first submission of the construction agreement for the subject project for review. I have filled in all the information I can and there's some additional information you guys will need to fill in. I have placed 60 working days of rail protection flagging in the document as we feel that's how much time it will take to complete the bridge painting project. This project has 2 grade separated crossings within the project limits (2 separate interstate bridges over railroad directly next to each other) and will need railroad flagger protection when working around the railroad. Below is a scope of work summary and pictures of the crossings are attached as well (just Google earth screenshots from September 2023). Please let me know if you need any additional information.

This project advertised March 22, 2023 and was awarded to Monoko LLC of Tarpon Springs, FL on May 12, 2023. It was originally scheduled to be completed in 2023 but due to the lack of a railroad agreement template until late 2023 construction was delayed until 2024.

PROTECTION OF RAILROAD TRAFFIC AND STRUCTURES SPECIAL PROVISIONS

EXHIBIT C

1. GENERAL REQUIREMENTS

Part of the work required by the contract between MaineDOT and the Contractor for the performance of the Project (the "Contract") will be performed within a railroad right of way and/or adjacent to the tracks, telephone, telegraph, signal and electric supply lines of Springfield Terminal Railway Company ("Railroad"), a subsidiary of CSX Transportation. The Contractor agrees to perform all such work in compliance with all of the terms of these Special Provisions and all safety rules, regulations, or standards applicable to the Railroad. The Contractor shall be fully responsible for all damages arising from the Contractor's failure to comply with the requirements of these Special Provisions. The Contractor shall be deemed to have included all costs associated with complying with these requirements in the unit prices of the Schedule of Prices and the Proposal.

Additionally, the Contractor shall comply with the current version of the CSX Special Provisions for Construction Near CSX Property found in the CSX Public Project Information Manual. In instances where these Special Provisions and the aforementioned CSX Special Provisions conflict, the more stringent requirement shall prevail; where there is a conflict between a general requirement and a specific requirement, the specific requirement shall prevail.

2. AMOUNT OF WORK NEAR TRACKS

The estimated amount of work to be done within 50 feet of the Railroad's track is 40% of the Contract.

3. NUMBER OF TRAINS AND TRAIN SPEED

The Contractor is notified that a maximum speed of $\underline{10}$ mph will be considered as prevailing for the operation of trains of the Railroad at the Project location and that the approximate number of trains per day at the Project location is $\underline{<1}$.

4. PRIORITY OF RAILROAD OPERATIONS

The train movements of the Railroad, and its lessees and licensees, shall have absolute priority over the performance of the Project within the Railroad right of way. The Contractor hereby agrees that the hours and times of work within the Railroad right of way must be coordinated through the Railroad and that such hours and times are subject to change without prior notice to the Contractor, unless other prior arrangements have been made through the Railroad.

5. AUTHORITY OF RAILROAD TO STOP WORK

If the Contractor fails to comply with the safety terms of these Special Provisions, or if the Railroad determines that the Contractor is using unsafe practices that threaten the safety of rail traffic, rail workers, or the general public, the Railroad shall have the right to immediately order the Contractor to cease work and vacate the Railroad's property. The Railroad agrees to confirm any cessation of work in writing by delivering to MaineDOT's Construction Manager a completed Stop Work Order form attached as Exhibit A within 24 hours of giving any such order.

The Contractor shall arrange and conduct its work so that there will be no interference with the Railroad's operations, including train, signal, telephone and telegraphic services, or damage to the Railroad's property, or to poles, wires, and other facilities of tenants on the Railroad's property or right-of-way. The Contractor shall store materials so as to prevent trespassers from causing damage to trains or to the Railroad's property. Whenever work is likely to affect the operations or safety of trains, the method of doing such work shall first be submitted to the Railroad's representative for approval, but such approval shall not relieve the Contractor from liability in connection with such work.

If conditions arising from or in connection with the Project require that immediate and unusual provisions be made to protect train operation or the Railroad's property, the Contractor shall make such provision. If the Railroad's representative determines that such provision is insufficient, the Railroad may, at the expense of the Contractor, require or provide such provision as may be deemed necessary, or cause the work to cease immediately.

6. ENTRY UPON RAILROAD PROPERTY

The Railroad hereby agrees to permit the Contractor, together with their subcontractors, suppliers, consultants and engineers (the "Contractor"), to enter upon the Railroad property for the purpose of performing the Project, PROVIDED THAT the Contractor complies with all of the terms of these Special Provisions and all safety requirements and directions of the Railroad's representative.

7. NOTICE REQUIRED BEFORE ENTRY

The Contractor shall not commence any work on the Railroad's property or rights-of-way until it has complied with the following conditions:

- A. Notify the Railroad in writing of the date that it intends to commence work on the Project. Such notice must be received by the Railroad at least 14 calendar days in advance of the date the Contractor proposes to begin work on the Railroad's property. The notice must refer to the agreement between MaineDOT and the Railroad for the Project (the "Agreement") by date. Additional notice requirements when flagging/inspection services are required are set forth in Section 21.
- B. Obtain authorization from the Railroad's representative to begin work on the Railroad's property, such authorization to include an outline of specific conditions with which it must comply.

C. Obtain from the Railroad the names, addresses and telephone numbers of the Railroad's personnel who must receive notice under provisions in the Agreement. Where more than one individual is designated, the area of responsibility of each shall be specified.

8. HAZARDS

The Contractor shall assess to its own satisfaction hazards which may be caused by its operations. At a minimum, the Contractor agrees that the following shall constitute Hazards:

An operating track shall be considered fouled and subject to hazard when any object is brought nearer than 25 feet to the gauge line of the near rail of the track.

A signal line or communication line shall be considered fouled and subject to hazard when any object is brought nearer than 25 feet to any wire or cable.

An electric supply line shall be considered fouled and subject to hazard when any object is brought nearer than 25 feet to any wire of the line.

Cranes, trucks, power shovels or any other equipment shall be considered as fouling and subjecting to hazard a track, signal line, communication or electric supply line when working in such position that failure of equipment, with or without load, could foul the track, signal line, communication or electric supply line.

Railroad operation will be considered subject to hazard when explosives are used in the vicinity of Railroad premises, or during the driving or pulling of sheeting for any footing adjacent to a track, or when erecting structural steel adjacent to a track, or when performing work under, across or adjacent to a track, or when operations involve swinging booms or chutes that could in any way come nearer than <u>25</u> feet to the gauge line of the near rail of the track, or when erection or removal of staging, false work or forms fouls a track or wire line.

None of the operations specified as a Hazard above shall be carried on during the approach or passing of a train or without permission from the Railroad and the presence of a Railroad inspector/flagman, unless other prior arrangements have been made through the Railroad.

9. MINIMUM CLEARANCES

During the construction of staging, false work or forms, the Contractor shall at all times maintain a minimum vertical clearance of 23 feet above the top of high rail and a minimum side clearance of 10 feet from the gauge line of the near rail where track is tangent. Additional side clearance must be maintained where track is on a curve.

10. COOPERATION AND DELAYS

Contractor shall arrange a schedule with the Railroad for accomplishing stage construction

involving work by the Railroad. In arranging its schedule, the Contractor shall ascertain, from the Railroad, the lead time required for assembling crews and materials and shall make due allowance therefore.

The Contractor may not charge any costs or submit any claims against the Railroad for hindrance or delay caused by railroad traffic; work done by the Railroad or other delay incident to or necessary for safe maintenance of railroad traffic; or for any delays due to compliance with these Special Provisions.

The Contractor shall cooperate with others participating in the construction of the Project to the end that all work may be carried on to the best advantage.

The Contractor understands and agrees that the Railroad does not assume any responsibility for work performed by others in connection the Project. The Contractor further understands and agrees that it shall have no claim whatsoever against the Railroad for any inconvenience, delay or additional cost incurred by the Contractor on account of operations by others.

11. WORK PLAN SUBMITTAL AND APPROVAL

The Contractor shall submit in writing to the Railroad's representative and MaineDOT's representative, at least 30 calendar day(s) in advance of the start of the Project, an outline of the Contractor's plan for work within the Railroad right of way, including contemplated method(s) of construction. This plan must meet with the approval of the Railroad's representative and MaineDOT's representative in every respect. If the Contractor contemplates the use of "on the track equipment", it should so state and obtain from the Railroad the conditions pertaining to such operations. All Railroad costs included in this operation will be borne by the Contractor. In a like manner, any of the Contractor's equipment or material on cars for the Project shall be handled in conformance with existing traffic rules, with all costs borne by the Contractor.

Prior to submitting its Proposal, the Contractor shall have ascertained, from the Railroad's representative and from MaineDOT's representative, all information relating to the Railroad's requirements and regulations and all costs in connection with compliance thereto.

The Railroad may require additional construction submittals pending review of the Work Plan. Such submittals may include but are not limited to:

- 1. Hoisting Operations
- 2. Demolitions Procedure
- 3. Erection Procedure
- 4. Temporary Excavation and Shoring
- 5. Track Monitoring

Submission requirements and review periods for such submittals will be communicated at the preconstruction utility meeting.

12. WORK FOR THE BENEFIT OF THE CONTRACTOR

No temporary or permanent changes to wire lines or other facilities (other than third-party fiber optic cable transmission systems) on the Railroad's property that are considered necessary to the work are anticipated or shown on the Plans. If any such changes are, or become, necessary in the opinion of the Railroad or MaineDOT, such changes will be covered by appropriate revisions to the Plans and by preparation of a force account estimate. Such force account estimate may be initiated by either the Railroad or MaineDOT, but must be approved by both the Railroad and MaineDOT. MaineDOT or Contractor shall be responsible for arranging for the relocation of the third-party fiber optic cable transmission systems, at no cost or expense to the Railroad.

Should MaineDOT or Contractor desire any changes in addition to the above, then it shall make separate arrangements with the Railroad for such changes to be accomplished at MaineDOT's or Contractor's expense.

13. HAUL ACROSS RAILROAD

If Contractor desires access across the Railroad's property or tracks at other than an existing and open public road crossing in or incident to construction of the Project, Contractor must first obtain the permission of the Railroad and shall execute a license agreement or right of entry satisfactory to the Railroad, wherein Contractor agrees to bear all costs and liabilities related to such access.

Contractor shall not cross the Railroad's property and tracks with vehicles or equipment of any kind or character, except at such crossing or crossings as may be permitted pursuant to this section.

14. STORAGE OF MATERIALS AND EQUIPMENT

Contractor shall not store its materials or equipment on the Railroad's property or where they may potentially interfere with the Railroad's operations, unless Contractor has received the Railroad representative's prior written permission. Contractor understands and agrees that the Railroad will not be liable for any damage to such materials and equipment from any cause and that the Railroad may move, or require Contractor to move, such material and equipment at Contractor's sole expense. To minimize the possibility of damage to the railroad tracks resulting from the unauthorized use of equipment, all grading or other construction equipment that is left parked near the tracks unattended by watchmen shall be immobilized to the extent feasible so that it cannot be moved by unauthorized persons.

15. EXCAVATIONS

Before excavation for footings adjacent to tracks and/or within the Railroad's right-of-way may commence, whether or not also within the limits of a public highway, plans and calculations for such excavations, prepared by a Professional Engineer authorized to practice in Maine, shall be submitted to the Railroad's representative for review and approval. Unless other prior arrangements have been made, the Railroad shall have 30 calendar days to perform such review and approval and issue written permission to proceed with the excavation. No excavation shall

proceed without such permission. If permission is denied, the Railroad shall have an additional 30 calendar days to perform such review of any re-submittal.

At a minimum, excavations must utilize proper bracing, shoring, sheeting or other support, as determined by the Railroad, to support the tracks with railroad traffic. Open excavation shall be suitably planked over when construction operations are not in progress. No excavation work shall be performed by the Contractor within the limits of the Railroad right of way, whether or not also within the limits of a public highway, until the Contractor has ascertained from the Railroad the location of any wires, conduits, pipes, cables or other railroad facilities below the surface of the ground. Damage to any such facilities caused by the failure of the Contractor to ascertain the location of such facilities or by failure to use due care to avoid injury to such facilities shall be at the expense of the Contractor.

16. EQUIPMENT

Equipment of the Contractor shall be in such condition so as to prevent failure that would cause delay in the operation of trains or damage to railroad facilities. Equipment shall not be placed or put in operation adjacent to a track without first obtaining permission of the Railroad. The Railroad agrees that such permission shall not be unreasonably withheld.

17. RAILROAD SERVICES - GENERALLY

When work is to be performed within the Railroad's right-of-way, the Railroad shall provide the services, equipment and materials provided in these Special Provisions including, but not limited to, engineering, flagging, inspection, signal protection and/or relocation, and restoration or replacement of the Railroad's track structure or ballast. Further, if the Railroad determines that the Contractor's operations do not comply with all of the safety requirements of these Special Provisions and all of the Railroad's safety requirements and directions, the Railroad will employ the necessary qualified employees to protect its trains and other facilities. The Contractor shall pay to the Railroad the cost for performing all Railroad Services unless said costs are to be paid by MaineDOT as specified in these Special Provisions.

18. CONSTRUCTION PROCEDURES

A. General

- 1. Construction work on the Railroad's property shall be subject to the Railroad's inspection and approval.
- 2. Construction work on the Railroad's property shall be in accord with the Railroad's written outline of specific conditions and with these Special Provisions.
- 3. Contractor shall observe the terms and rules of the Railroad's Safe Way manual, which Contractor shall be required to obtain from the Railroad, and in accord with any other instructions furnished by the Railroad or the Railroad's Representative.

B. Blasting

- 1. Contractor shall obtain the Railroad's prior written approval for use of explosives on or adjacent to the Railroad's property. If permission for use of explosives is granted, Contractor must comply with the following:
- a. Blasting shall be done with light charges under the direct supervision of a responsible officer or employee of Contractor.
- b. Electric detonating fuses shall not be used because of the possibility of premature explosions resulting from operation of two-way train radios.
- c. No blasting shall be done without the presence of an authorized Railroad representative. At least 10 calendar days' advance notice to the Railroad is required to arrange for the presence of an authorized Railroad representative and any flagging that the Railroad may require.
- d. Contractor must have at the Project site adequate equipment, labor and materials, and allow sufficient time, to (i) clean up (at Contractor's expense) debris resulting from the blasting without any delay to trains; and (ii) correct (at Contractor's expense) any track misalignment or other damage to the Railroad's property resulting from the blasting, as directed by the Railroad's Representative, without delay to trains. If Contractor's actions result in delay of any trains, including Amtrak passenger trains, Contractor shall bear the entire cost thereof.
- e. Contractor shall not store explosives on the Railroad's property.
- 2. The Railroad's representative will:
- a. Determine the approximate location of trains and advise Contractor of the approximate amount of time available for the blasting operation and clean-up.
- b. Have the authority to order discontinuance of blasting if, in his or her opinion, blasting is too hazardous or is not in accord with these Special Provisions.

19. MAINTENANCE OF DITCHES ADJACENT TO RAILROAD'S TRACKS

Contractor shall maintain all ditches and drainage structures free of silt or other obstructions that may result from Contractor's operations. Contractor shall provide erosion control measures during construction and use methods that accord with applicable state standard specifications for road and bridge construction, including either (1) silt fence; (2) hay or straw barrier; (3) berm or temporary ditches; (4) sediment basin; (5) aggregate checks; and (6) channel lining. All such maintenance and repair of damages due to Contractor's operations shall be performed at Contractor's expense.

20. UTILITY FACILITIES ON RAILROAD'S PROPERTY

MaineDOT shall arrange, upon approval from the Railroad, to have any utility facilities on or over the Railroad's property changed as may be necessary to provide required clearances.

21. INSPECTION / FLAGGING

The Railroad has sole authority to determine the need for inspection/flagging required to protect its operations and property. The Railroad shall furnish and assign all inspectors/flaggers for general inspection purposes and for general protection of Railroad property and operations during construction as the Railroad determines are necessary to preserve safety.

- (a) Responsibility for Cost. MaineDOT will bear the cost of flagging or inspection (including travel time), or any combination thereof, up to <u>60</u> man days of said flagging or inspection. If, in the opinion of the Railroad, further services of a flagger or inspector will be required due to the operations of the Contractor, the services will be furnished and the cost thereof (salary, expenses, insurance, taxes and vacation allowance, etc.) shall be paid to the Railroad by MaineDOT, and will be recovered by MaineDOT from the Contractor.
- (b) <u>Terms</u>. The minimum hours per day for the Railroad employees engaged in inspection or flagging services shall be eight (8) hours. Time at rates for straight time, overtime or for deadheading starts in accordance with established practices in effect in the territory in which the Project is located. Information as to these practices should be obtained from the Railroad.
- (c) Notice. The Contractor shall notify the Railroad's representative in writing at least 30 calendar days before the Contractor first commences work within 50 feet of the track or that otherwise requires inspection or flagging services so that Railroad can provide these services. Thereafter, following this initial notice, the Contractor shall notify the Railroad's representative in writing at least 10 calendar days before suspending such work, and shall notify the Railroad's representative in writing at least 10 calendar days before resuming such work. Failure to give notice of intent to suspend work shall be cause to charge the Contractor the cost of inspection during the period when work is suspended.
- (d) <u>Estimated Cost.</u> The following is an estimate of the cost per day of inspection/flagging necessary for this Project. The rates shown include all overhead charges, travel time, deadheading and personal expenses.

Estimated daily rate for four (4) consecutive hours Monday-Friday (straight time): \$600

Estimated daily rate for four (4) consecutive hours Saturday, Sunday, Holiday (overtime): \$900

Estimated rate for hours worked in excess of eight (8) hours in any one day: \$225/hour

Rates charged will be the actual pay rate of the flaggers and inspectors used, plus standard

additives, whether that amount is above or below the rate provided in the Estimate. The Railroad agrees to notify MaineDOT if rates used to calculate the above estimates change before the date of bids are received for this Contract.

(e) Definitions.

Man day (M.D.) - eight (8) consecutive hours or any portion thereof.

Overtime - Each additional hour or fraction thereof consecutive to and beyond the standard man day will count as 3/16 of a man day.

Standard Man Day - Eight (8) consecutive hours, Monday - Friday between the hours of 8:00 a.m. to 4:00 p.m. unless otherwise noted and agreed to by all parties.

Travel Time - Time required by flagger and/or inspector to commute between his or her point of headquarters to the project site. This time shall not be included in determining available man days.

22. CLEAN-UP

Contractor, upon completion of the Project, shall remove from the Railroad's property any temporary grade crossings, any temporary erosion control measures used to control drainage, all machinery, equipment, surplus materials, falsework, rubbish, or temporary buildings belonging to Contractor. Contractor, upon completion of the Project, shall leave the Railroad's property in neat condition, satisfactory to the Railroad's representative.

23. OTHER CONTRACTOR RESPONSIBILITIES

The restoring and resurfacing of tracks, if disturbed due to the Contractor's operations, shall be at the expense of the Contractor.

Any other changes made or services furnished by the Railroad as a result of the Contractor will be at the Contractor's expense.

24. INDEMNIFICATION

A. <u>Generally</u>. To the maximum extent permitted by applicable law, Contractor shall indemnify, defend, and hold Railroad and its affiliates harmless from and against all claims, demands, payments, suits, actions, judgments, settlements, and damages of every nature, degree, and kind (including direct, indirect, consequential, incidental, and punitive damages), for any injury to or death to any person(s) (including, but not limited to the employees of Railroad, its affiliates, MaineDOT, or MaineDOT's other contractors, if any), for the loss of or damage to any property whatsoever (including but not limited to property owned by or in the care, custody, or control of Railroad, its affiliates, MaineDOT, or Maine DOT's other contractors (if any), and environmental damages and any related remediation brought or recovered against Railroad and its affiliates), arising directly or indirectly from the negligence, recklessness or intentional wrongful

misconduct of Contractor, its agents, employees, invitees, or subcontractors in the performance of or in connection with the work or activities incidental thereto, or from their presence on or about Railroad's property. The foregoing indemnification obligation shall not be limited to the insurance coverage required herein, except to the extent required by law or otherwise expressly provided herein.

- B. <u>Compliance with Laws</u>. Contractor shall comply with any federal, state, or local laws, statutes, codes, ordinances, rules, and regulations applicable to its work and shall indemnify, defend, and hold Railroad and its affiliates harmless with respect to any fines, penalties, liabilities, or other consequences arising from breaches of this requirement.
- C. "Railroad Affiliates". For the purpose of this indemnification provision, Railroad's affiliates include Springfield Terminal Railway Company and all entities, directly or indirectly, owned or controlled by or under common control of Springfield Terminal Railway Company and their respective officers, directors, employees and agents.
- D. <u>Notice of Incidents</u>. Contractor shall notify Railroad and MaineDOT promptly of any loss, damage, injury or death arising out of or in connection with its work.
- E. <u>Survival</u>. This indemnification provision shall survive the termination or expiration of the Contract.

25. INSURANCE

- A. <u>Insurance Policies</u>. To the extent that Contractor is performing work on or about Railroad's property, Contractor shall procure and maintain the following insurance policies:
- 1. Commercial General Liability coverage at Contractor's sole cost and expense with limits of not less than \$5,000,000 in combined single limits for bodily injury and/or property damage per occurrence, and such policy shall name Railroad as an additional insured. The policy shall include endorsement ISO CG 24 17 evidencing that coverage is provided for work within 50 feet of a railroad. If such endorsement is not included, railroad protective liability insurance must be provided as described in item 4 below.
- 2. Statutory Worker's Compensation and Employers Liability Insurance with limits of not less than \$1,000,000, which insurance must contain a waiver of subrogation against Railroad and its affiliates (if permitted by state law).
- 3. Commercial automobile liability insurance with limits of not less than \$1,000,000 combined single limit for bodily injury and/or property damage per occurrence, and such policy shall name Railroad as an additional insured. The policy shall include endorsement ISO CA 20 70 evidencing that coverage is provided for work within 50 feet of a railroad. If such endorsement is not included, railroad protective liability insurance must be provided as described in item 4 below.

- 4. If either the commercial general liability insurance described in item 1 above or the commercial automobile liability insurance described in item 3 above does not include the referenced endorsement evidencing that coverage is provided for work within 50 feet of a railroad, then Contractor also shall procure and maintain Railroad Protective Liability Insurance with limits of not less than \$5,000,000 combined single limit for bodily injury and/or property damage per occurrence and an aggregate annual limit of \$10,000,000, which insurance shall satisfy the following additional requirements:
 - a. The Railroad Protective Insurance Policy must be on the ISO/RIMA Form of Railroad Protective Insurance Insurance Services Office (ISO) Form CG 00 35.
 - b. Springfield Terminal Railway Company must be the named insured on the Railroad Protective Insurance Policy.
 - c. Name and Address of Contractor must appear on the Declarations page.
 - d. Description of operations must appear on the Declarations page and must match the Project description.
 - e. Authorized endorsements must include the Pollution Exclusion Amendment CG 28 31, unless using form CG 00 35 version 96 and later.
 - f. Authorized endorsements may include:
 - (i) Broad Form Nuclear Exclusion IL 00 21
 - (ii) 30-day Advance Notice of Non-renewal or cancellation
 - (iii) Required State Cancellation Endorsement
 - (iv) Quick Reference or Index CL/IL 240
 - g. Authorized endorsements may not include:
 - (i) A Pollution Exclusion Endorsement except CG 28 31
 - (ii) A Punitive or Exemplary Damages Exclusion

Mishap probability shall be assigned an Arabic letter according to the following criteria:
 - (1) Sub-category A Likely to occur immediately or within a short period of time.
 - (2) Sub-category B Probably will occur in time.
 - (3) Sub-category C May occur in time.
 - (4) Sub-category D Unlikely to occur.
 - c. <u>Risk Assessment Code.</u> The RAC is an expression of risk which combines the elements of hazard severity and mishap probability. Using the matrix shown below, the RAC is expressed as a single Arabic number that can be used to help determine hazard abatement priorities.

This special provision was created for the Build America, Buy America Act (BABA) to expand the list of construction materials required to be manufactured in the United States beyond what is currently only required for steel/iron products. The Infrastructure Investment and Jobs Act (IIJA), Public Law No. 117-58 includes the Build America, Buy America Act. The Office of Management and Budget issued memorandum M-22-11 to provide guidance on the law which can be found here:

All iron/steel, including the iron/steel in construction materials and manufactured products, must satisfy Buy America 23 CFR 635.410 requirements.

All construction materials, as defined in the following, that are permanently incorporated into federal-aid projects shall meet Build America, Buy America requirements.

For the purpose of this Specification, construction materials shall include an article, material, or supply that is or consists primarily of the following.

- Non-ferrous metals.
- Plastic and polymer-based products (including polyvinylchloride, composite building materials, and polymers used in fiber optic cables),
- Glass (including optic glass),
- Lumber, or
- Drywall.

All manufacturing processes for construction materials shall occur within the United States. The category of construction materials excludes cement and cementitious materials, aggregates such as stone, sand, or gravel, or aggregate binding agents or additives.

Due to a nationwide waiver, BABA requirements do not apply to manufactured products for FHWA funded projects. Manufactured products are items that consist of two or more of the listed construction materials that have been combined through a manufacturing process, and items that include at least one of the listed materials combined with a material that is not listed (including steel/iron) through a manufacturing process.

The Contractor shall certify in writing that all permanently incorporated Construction Materials for this contract meet the BABA requirements.

SPECIAL PROVISION 105 GENERAL SCOPE OF WORK

Equal Opportunity and Civil Rights (Disadvantaged Business Enterprises Program)

105.10.1.1 Disadvantaged Business Enterprises Program The Maine Department of Transportation (MaineDOT) has established a Disadvantaged Business Enterprise (DBE) program in accordance with regulations of the United States Department of Transportation (USDOT), 49 CFR Part 26. The MaineDOT receives federal financial assistance from USDOT, and as a condition of receiving this assistance, the Department has signed an assurance that it will comply with 49 CFR Part 26. The MaineDOT is responsible for determining the eligibility of and certifying DBE firms in Maine.

A DBE is defined as a for-profit business that is owned and controlled by one or more socially and economically disadvantaged person(s). For the purpose of this definition:

- 1. "Socially and economically disadvantaged person" means an individual who is a citizen or lawful permanent resident of the United States and who is Black, Hispanic, Native American, Asian, Female; or a member of another group or an individual found to be disadvantaged by the Small Business Administration pursuant to Section 3 of the Small Business Act.
- 2. "Owned and controlled" means a business which is:
 - a. A sole proprietorship legitimately owned and controlled by an individual who is a disadvantaged person.
 - b. A partnership or limited liability company in which at least 51% of the beneficial ownership interests legitimately are held by a disadvantaged person(s).
 - c. A corporation or other entity in which at least 51% of the voting interest and 51% of the beneficial ownership interests legitimately are held by a disadvantaged person(s).

The disadvantaged group owner(s) or stockholder(s) must possess control over management, interest in capital, and interest in earnings commensurate with the percentage of ownership. If the disadvantaged group ownership interests are real, substantial and continuing and not created solely to meet the requirements of this program, a firm is considered a bona fide DBE.

105.10.1.2 Commercially Useful Function MaineDOT will count expenditures of a DBE contractor toward DBE goals only if the DBE is performing a commercially useful function on that contract. A DBE performs a commercially useful function when it is responsible for execution of the work of the contract and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. Credit will only be given when the DBE meets all conditions for a CUF. Credit for labor will be in accordance with the responsibilities outlined in the contract. To perform a commercially useful function, the DBE must also be responsible, with respect to materials and supplies used on the Contract, for negotiating price, determining quality and quantity, ordering the materials, and installing (where applicable) and paying for the material itself. To determine whether a DBE is performing a commercially useful function, MaineDOT will evaluate the amount of work subcontracted, industry practices, whether the amount the firm is to be paid under the Contract is commensurate with the work it is actually performing and DBE credit claimed for its performance of the work, and other relevant factors.

Rented equipment used by the DBE must not be rented from the Prime Contractor on a job that the DBE is subcontracted with that Prime Contractor for regular course of business.

A current listing of certified DBEs that may wish to participate in the highway construction program and the scope of work for which they are certified can be found at https://www.maine.gov/mdot/civilrights/dbe/. Credit will be given for the value described by a DBE performing as:

- A. A prime contractor; 100% of actual value of work performed by own workforces.
- B. An approved subcontractor; 100% of work performed by own workforces.
- C. An owner-operator of construction equipment; 100% of expenditures committed.
- D. A manufacturer; 100% of expenditures committed. The manufacturer must be a firm that operates or maintains a factory or establishment that produces on the premises the materials or supplies obtained by the Contractor. Brokers and packagers shall not be regarded as manufacturers.
- E. A regular dealer; 60% of expenditures committed. A regular dealer is defined as a firm that owns, operates, or maintains a store, warehouse or other establishment in which the materials or supplies required for the performance of the contract are bought, kept in stock, and regularly sold to the public. For purposes of this provision a "Broker" is a DBE that has entered into a legally binding relationship to provide goods or services delivered or performed by a third party. Brokers and packagers shall not be regarded as regular dealers.
- F. A bona fide service provider; 100% of reasonable fees or commissions. Eligible services include professional, technical, consultant, or managerial, services and assistance in the procurement of essential personnel, facilities, equipment, materials or supplies required for the performance of the contract. Eligible services also include agencies providing bonding and insurance specifically required for the performance of the contract.
- G. A trucking, hauling or delivery operation. 100% of expenditures committed when trucks are owned, operated, licensed and insured by the DBE and used on the contract and, if applicable, includes the cost of the self supplied materials and supplies.100% of expenditures committed when the DBE leases trucks from another DBE firm including an owner-operator. 100% of reasonable fees or commissions the DBE receives as a result of a lease arrangement for trucks from a non-DBE, including an owner-operator.
- H. Any combination of the above.

105.10.1.3 Race-neutral Goals The Maine DOT is required to set an annual goal (approved on a three year basis) for DBE participation in Federal-aid projects. In order to fulfill that goal, bidders are encouraged to utilize DBE businesses certified by the MaineDOT. MaineDOT seeks to meet the established DBE goal solely through race-neutral means. *Race-neutral* DBE participation occurs when a DBE is awarded a prime contract through customary competitive procurement procedures, is awarded a subcontract on a contract that does not carry a DBE contract goal, or wins a subcontract from a prime contractor that did not consider its DBE status in making the award. A DBE/subcontractor Utilization Proposed Form is required to be included in bid documents.

MaineDOT will analyze each project and create a Project Availability Target (PAT), based on a number of factors including project scope, available DBE firms, firms certified in particular project work, etc. Each bid will request that the contractor attempt to meet the PAT. This PAT is developed to assist contractors to better understand what the MaineDOT expectations are for a

specific project. The PAT is NOT a mandate but an assessment of what this particular project can bear for DBE participation. The Department anticipates that each contractor will make the best effort to reach or exceed this PAT for the project.

105.10.1.4 Race-conscious Project Goals If it is determined by the Department that the annual DBE goal will not be met through *race-neutral* means, the Department may implement *race-conscious contract goals* on some projects. Race-conscious contract goals are goals that are enforceable by the Department and require that the prime contractor use good faith effort to achieve the goal set by the Department for that particular project. If race conscious means are implemented on a project, the Prime must comply with the requirements of 49 CFR.

At the time of the bid opening, all Bidders shall submit with their bid a Disadvantaged Business Enterprise (DBE) Commitment Form provided by the Department. This form will list the DBE and non-DBE firms that are proposed to be used during the execution of the Work. The list shall show the name of the firm, the item/material/type of work involved and the dollar amount of work to be performed. The dollar total of each commitment shall be totaled and a percentage determined.

If the project goal is not met, acceptable documentation showing all good faith efforts made to obtain participation may be required in order to award the project. Failure to provide the required listing with the dollar participation total or acceptable documentation of good faith efforts to obtain DBE participation within 3 days after the bid opening date will be considered a lack of responsiveness on the part of the low bidder. Rejection of the low bid under these circumstances will require the low bidder to surrender the Proposal Guaranty to the Department. The submission and approval of the above forms does not constitute a formal subcontract.

If for any reason during the progress of the Work the Contractor finds that DBEs included on the list are unable to perform the proposed work, the Contractor, with written release by the committed DBE or approval of the Department, may substitute other DBE firms for those named on the list. If the Contractor is able to clearly document their inability to find qualified substitute firms to meet the project goal, the Contractor may request in writing approval to substitute the DBE with a non-DBE firm. If at any time during the life of the Contract it is determined that the Contractor is not fulfilling the goal or commitment(s) and is not making a good faith effort to fulfill the DBE requirement, the Department may withhold progress payments. If good faith effort is determined by the Department, failure to meet the DBE contract goal will not be a detriment to the bid award. Fulfillment of the goal percentage shall be determined by dividing the dollars committed to the DBEs by the actual contract dollars. These requirements are in addition to all other Equal Employment Opportunity requirements on Federal-aid contracts.

105.10.1.5 Certification of DBE attainment on Contracts The MaineDOT must certify that it has conducted post-award monitoring of all contracts to ensure that DBEs had done the work for which credit was claimed. The certification is for the purpose of ensuring accountability for monitoring which the regulation already requires. The MaineDOT will certify these contracts through review of CUF forms, Elations sub-contract payment tracking as well as occasional onsite reviews of projects and through the project's final closeout documentation provided by our Contracts Section.

105.10.1.6 Bidders' List Survey Pursuant to 49 CFR 26.11 the MaineDOT is required to "create and maintain" a bidders list and gather bidder information on our construction/consultant projects, Contractors will maintain information on all subcontract bids submitted by DBE and Non-DBE firms and provide that information to the Department. The Following information is required:

Age of firm (years)

And the annual gross receipts amount as indicated by defined brackets, i.e. \$500,000 to \$800,000, rather than requesting exact figures.

Not only is this information critical in determining the availability of DBE businesses relative to other businesses that do similar work, but the Federal Highway Administration requires that we obtain this information.

ALL REQUIREMENTS IN THIS SPECIFICATION ARE THE RESPONSIBILITY OF THE CONTRACTOR UNLESS NOTED OTHERWISE.

506.01 Description This specification covers the field cleaning of and application of a protective coating system to all existing structural steel, cross braces, all other ancillary structural supports attached to the bridge (i.e. all steel that has previously been painted), piers (Warren) and bridge bearings. The work shall consist of furnishing all supervisory personnel, including competent person(s), labor, tools, equipment, containment, scaffolding, protection of public and private property, Quality Control activities, materials, and incidentals necessary for satisfactory completion of the Work. The specific areas to be cleaned and coated are as designated in the Contract for the following projects:

506.02 General All existing structural steel requires the complete removal of existing rust, mill scale and coatings which may contain lead and hexavalent chromium by abrasive blast cleaning or vacum—shrouded power tool cleaning. It is the responsibility of the Contractor to test the existing coating to determine the toxic metal content and, based on those results, design and implement the appropriate plans for containment, environmental protection, waste disposal and worker safety.

Apply a coating system to the cleaned surfaces. The coating system shall be selected from the Northeast Protective Coating Committee (NEPCOAT) Qualified Products List B. Organic Zinc Rich Primer, Three Coat System. The list may be found through NEPCOAT's web page: http://www.nepcoat.org.

Contractors and Subcontractors involved with the removal of lead based paint and the field application and touch-up of the coating systems shall be qualified in accordance with SSPC QUALIFICATION PROCEDURE NO. 1, Standard Procedure for Evaluating Painting Contractors (Field Application to Complex Industrial Structures) and SSPC QUALIFICATION PROCEDURE NO. 2, Standard Procedure for the Qualification of Painting Contractors (Field Removal of Hazardous Coatings from Complex Structures) prior to Bid opening and shall remain qualified throughout the duration of the Contract. Copies of current certificates issued by the Qualifying Agency shall be submitted with the Bid package.

Assure that the latest copies of the following documents are on site and available at all times. Applicable parts of the documents are enforceable as part of the Contract:

- SSPC VIS 3, Visual Standard for Power and Hand-Tool Cleaned Steel.

- SSPC Guide 7, Guide to the Disposal of Lead-Contaminated Surface Preparation Debris.

Supply the Resident with the applicable product data sheets and safety data sheets (SDS) before any coating work is performed. Also obtain from the manufacturer written procedures for touch-up including acceptable coating materials. If the coating manufacturer recommends a coating material for touch-up that is different from the coating material chosen by the Contractor, it will be supplied at no additional cost to the Department. Obtain in writing from the coating manufacturer, and provide to the Resident, a chart or table listing minimum and maximum recoat times for the primer and intermediate coat over the expected range of temperatures and relative humidity.

The primer color and the blasted steel shall be contrasting colors and the primer and intermediate color shall be contrasting colors. Stripe coating shall be a contrasting color to the previous coat. The finish topcoat color shall be green and match the following Federal Standard 595C, light green, color number: 14272.

506.03 Quality Control The Contractor is responsible for all aspects of the quality of the Work, including labor, equipment, materials, incidentals, processes, construction methods and Quality Control. Quality Control (QC) is the planned and specified actions or operations necessary to produce an end product that Conforms to the requirements of the Contract and includes inspections and testing for process control to the extent determined necessary by the Contractor. All costs associated with QC activities shall be considered incidental to related Pay Items.

<u>506.031 Submittals</u> The Schedule of Work shall be in conformance with Standard Specification Section 107.4, Scheduling of Work, unless there is a Special Provision which supersedes the Standard Specification.

All Plans and submittals from the Contractor will be reviewed by the Department in accordance with Section 105.7, Working Drawings, of the Standard Specifications.

506.032 Quality Control Qualifications Provide QC personnel trained and certified by: The National Association of Corrosion Engineers (NACE) – International: Coating Inspector Program Level 1 (minimum); SSPC BCI Coatings Inspection Training and Certification for the Bridge Industry (Level I without certification), or Level II; or other training that is acceptable to the Department. If the Contractor's QC personnel do not follow and enforce the approved Quality Control Plan, the Resident may require the Contractor to retain the services of an independent, third party certified NACE/SSPC BCI inspector for the remainder of the Project, at no additional cost to the Department. If the Resident determines that the Contractor is not performing the QC function properly, the Resident will issue the Contractor a verbal warning. The second time the Resident finds that the QC function is being improperly performed, for the same reason, the Contractor will be given a written warning. The third time the Resident finds that the QC function is being improperly performed, for the same reason, the Contractor will be required to retain the services of a third party NACE/SSPC BCI certified inspector, at no additional cost to the Department. Discovery by the Department of a pattern of rework for the same items would be considered improper performance of the QC function.

506.033 Quality Control Plan Submit a QC Plan to the Department for review at least 21 days prior to the beginning of any removal of paint. The QC plan shall include: The names of all the Contractor's on-site representatives, including the NACE/SSPC BCI certified inspector, who will be responsible for the inspection and the acceptance of the Contractor's work; the definition of hold points, from pre-surface preparation inspection to final inspection; the format and submittal process for daily work reports and coating/DFT reports; and the process for rework.

Develop a Job Control Record (JCR) to systematically organize all reports, tests, test locations, test results, Non-Conformance Reports, final acceptance and other documents deemed necessary by the Resident.

Record the following in the JCR as applicable:

- Daily inspection reports including location of the work, personnel and equipment.
- Surface preparation cleanliness and anchor profile.

- Environmental conditions ambient temperature, surface temperature, relative humidity, dew point.
- Condition of the containment
- Coating batch and/or lot number, date of manufacture and shelf life.

- Dry Film Thickness (DFT) for each coat.
- Cure data-time/temperature/relative humidity.
- Final inspection and acceptance.
- All other job documentation generated by the Contractor.

Submit the format for the JCR and sample forms to the Resident for review prior to beginning application of protective coating.

Violation of the QC Plan may result in a suspension of work. If the Department orders a suspension, in writing, work shall not resume until the Contractor provides a plan, which is acceptable to the Department, describing how compliance will be restored and maintained. A suspension resulting from the Contractor's failure to adhere to the QC Plan shall be considered an Inexcusable Delay.

506.034 Surface Preparation/Coating Plan Provide written procedures (preparation plan) for the surface preparation, the remediation of soluble salts, and coating application and repair. The plan shall include a description of the equipment that will be used for surface preparation and coating. The plan shall also identify the type and brand name of abrasive proposed for use; provide Safety Data Sheets (SDS) for proposed abrasive. Also include the surface preparation methods and materials to be used in "sensitive areas", e.g. areas in close proximity to galvanized members, bearings, utility hangers, & utilities, etc. If any of the areas that are determined to be sensitive by the Department are damaged due to surface preparation practices, the Contractor will be responsible for the repair of all damage at no additional cost to the Department. It is recommended that the Contractor explore alternative surface preparation methods for these "sensitive areas", such as vacuum shrouded power tool cleaning and the use of impregnated sponge and other less aggressive blast media. The Contractor shall receive approval from the Department before performing any removal methods when working in "sensitive areas".

The preparation plan shall identify the methods of protection or work isolation procedures that will be followed to protect surrounding structures, concrete surfaces, equipment, galvanized bridge deck members, utility cables, etc. and property from exposure to surface preparation and paint debris. The Contractor is responsible for any damage caused by surface preparation.

All grease, oil, chlorides, salts and any other foreign matter must be removed prior to removal of any existing paint.

<u>506.035 Containment Plan</u> Provide a containment plan to the Department for review. Do not begin the erection of containment system(s), or paint disturbance activities until review by the Department has been completed and aproved.

Prepare detailed drawings and structural analysis stamped by a Professional Engineer (PE) licensed in the State of Maine. Install the containment in accordance with the drawings stamped by the Contractor's PE. Do not begin surface preparation until the Contactor's PE has field verified the proper installation of the containment system(s). Perform all surface preparation and painting in the approved containment system, conforming to the latest SSPC Guide 6, Guide for Containing Surface Preparation Debris Generated During Paint Removal Operations, for the specified level of cleaning, as applicable.

The Contractor is responsible for ensuring the containment meets all OSHA, federal and state regulations. Throughout the entire Project, work shall only be conducted within approved containment enclosures. The plan shall be sufficiently detailed to show conformance with the requirements of SSPC Guide 6, Class 1A containment specifications. The Containment Plan shall also describe, in detail, the Contractor's methods of protecting galvanized bridge members, existing utilities, etc. The Contractor shall be responsible for all damage incurred. The Containment Plan shall include the following information and requirements, at a minimum:

- A. Detailed drawings and structural analysis, prepared and stamped by a PE licensed in the State of Maine.
- B. Detailed design calculations stamped by a PE licensed in the State of Maine for the Contractor's operation including all construction loads applied to the structure. The design shall use the latest editions of the AASHTO LRFD Bridge Design Specifications with HL-93 Live Load. The applied loads from the proposed paint containment system (enclosures, work platforms, collected waste product, equipment, etc.) shall not exceed the allowable resistance of any bridge member.
- The Contractor shall determine the wind speed above which damage to the existing structure(s) will result from wind loading on the containment system. If actual wind speeds exceed this design wind speed, the Contractor shall immediately make provisions to properly relieve the containment wind loading. The process for relieving the wind loading shall not release any of the lead paint waste. The Contractor may redesign/reconfigure the containment enclosure(s) or suspend operations until the actual wind speeds fall to levels below the design wind speed. Any release of pollutants from the containment enclosure(s), in excess of applicable state or federal limits, to the surrounding environment due to containment failure will result in the immediate suspension of work. Prior to resuming work, the Contractor shall take appropriate actions to abate the discharge and obtain the Department's concurrence on a plan of action to prevent reoccurrence. The time and costs associated with any delays and clean-up, modifications, and rebuilding of the containment enclosure(s) resulting from wind damage or associated with any actions required to prevent any reoccurrence of release of pollutants caused by wind loads shall be borne by the Contractor. Any delays due to the suspension of work or due to containment failure, as the result of wind loads, shall be considered Inexcusable Delays. The Contractor shall monitor and

document actual wind speeds on the existing structure(s), as appropriate, to ensure the safety of the existing structure(s); the cost of all wind monitoring shall be incidental to related Contract Pay Items.

- D. A plan for staging, installing, moving, and removing the containment and the methods of attachment that will be used. Attachment points to main framing members only (main girders, floorbeams, truss members may be allowed with prior approval from the Resident) will be allowed. The plan shall include the methods of access that will be provided to work areas inside containment, locations of safety lines, locations of containment entryways, etc. When the containment system is installed over navigable water, the containment system must comply with U.S. Coast Guard requirements.
- E. Detailed plans for lighting the inside of the containment for surface preparation, painting, and inspection. Provide work area illumination as follows:

Surface Preparation and Coating Application	20	50	
Inspection	50	200	

Provide a light meter that measures illumination in foot candles. Failure to provide at least the minimum illumination will be considered denial of access to the work and may result in rejection of the work by the Resident.

- F. Detailed plans for maintaining the environmental conditions required during coating application and curing, including monitoring, measuring and documenting environmental conditions.
- G. Detailed plans for the collection and removal of accidental spills or discharges.
- H. Technical data sheets, specification sheets and any other information needed to thoroughly describe the containment plan, materials, and containment and ventilation equipment proposed for use. Only use containment materials that are flame resistant.

506.036 Environmental Protection Plan Thirty days prior to the initiation of on site work, submit to the Department for review and acceptance an Environmental Protection Plan that establishes programs for the monitoring activities that will be undertaken on the Project. The plan shall reference and utilize the applicable sampling procedures established in the most recent version of SSPC-TU 7. This plan shall include written programs to address the following:

A. Regulated Area Monitoring and Maintenance. For establishing and maintaining regulated areas around activities which could generate airborne emissions of lead or other toxic metals.

- B. High Volume Ambient Air Monitoring. The Contractor shall contract with an independent environmental monitoring firm to conduct high volume ambient air monitoring for TSP-lead to assure compliance with this item and any applicable state and local regulations. Have the monitoring begin at least 48 hours prior to any abrasive blasting, for a baseline. Procedures for the monitoring which confirm that the monitoring equipment is properly calibrated, sited, and operated; filters are properly handled and transported; the laboratory analysis is performed correctly; and that all monitoring, calculations, documentation, and forms will be provided directly to the Department by the monitoring firm, with copies to the Contractor. Prior to any sampling, the Contractor shall clearly identify proposed monitor locations, including what corrective action will be implemented immediately, in the event of unacceptable results.
- C. Final Cleaning/Clearance Evaluations. Procedures and methods that will be used to conduct and document final Project clean-up, and final visual cleanliness inspections and evaluations. This process is to assure that the Project area and surrounding equipment, structures, soil, water, and sediment along the river banks have not been negatively impacted by Project activities.
- D. Laboratory Qualifications. Provide the name of the laboratory and/or firm that will be used for analysis of regulated area exposure monitoring, worker exposure monitoring, and high volume ambient air monitoring, as required. Provide documentation that this firm is American Industrial Hygiene Association (AIHA) accredited for metals analysis, and has successfully participated (previous 12 months at a minimum) in the AIHA ELPAT program.
- E. Worker Protection Compliance Program. A Project-specific compliance program, prepared under the direction of, and signed and sealed by, a Certified Industrial Hygienist (CIH), for the protection of workers from lead, in accordance with 29 CFR 1926.62, and other toxic metals in the paint. Include the name, experience, and qualifications of the competent person who will be making routine inspections of Project activities to ensure compliance with the program. If Subcontractors are operating under a separate program, include the program with the submittals.

506.036a Environmental Evaluations

A. *Ground (Soil) Evaluations*. An evaluation of the ground and soil prior to commencement and upon completion of the Work to assure that the ground has not been negatively impacted by Project activities shall be performed. This shall include the bridge site and the areas used to store equipment and waste. MaineDOT personnel will assess lead level soil data from select locations beneath the bridge and in the contractor storage area(s) through use of an X-ray fluorescence (XRF). The lead level in soils will be evaluated prior to the start of work and at its conclusion. Additionally, a visual inspection of the ground surface

with respect to the presence of paint chips and debris will be performed prior to the start of work and after. The visual inspection shall include photo documentation of existing soil and site conditions. The Contractor will be consulted prior to initiation of the pre- and post- work assessments and will be encouraged to have representatives accompany MaineDOT personnel during the visual and XRF work.

The ground (soil) will be considered to have been impacted by project activities based on the analysis as described below:

- 1. Visible paint chips, spent abrasive, or debris are present on the ground; or
- 2. If the geometric mean pre-project soil lead level is less than or equal to 200 ppm (totals) and an increase in the post-geometric mean total content of 100 ppm or more occurs, or If the geometric mean pre-project soil lead level is greater than 200 ppm and the post-geometric mean concentration exceeds the pre-project geometric mean plus two standard deviations, or increases in the post-geometric mean level of 100 ppm occurs, whichever is greater.
- B. *Water/Sediment Evaluations*. For visual inspection of the water and sediment along the river banks prior to commencement and upon completion of the Work to assure that the water and sediment, as applicable, are not negatively impacted by Project activities. The visual inspection shall be completed by the Contractor with a representative of the Department. The inspection shall include photo documentation of existing water/sediment conditions.
- C. Remediation of Ground (Soil), Water, and Sediment. In the event that post-Project inspection, sampling or analysis show unacceptable results, the contractor will provide a written plan within 30 calendar days from the date of notification, outlining what steps will be taken to accomplish the necessary clean-up or remediation of the ground (soil), water, and sediment, as appropriate, to satisfy all applicable regulatory agencies. Any clean up measures shall be at no additional cost to the Department.

All monitoring calculations, documentation, and forms will be provided directly to the Contractor upon request.

506.037 Pre-Production Meeting Coordinate a pre-production meeting with the Department's Resident at least two weeks prior to the beginning of the removal of the existing coating. Provide two weeks notice to the Department prior to the meeting. The meeting agenda will include procedures to be used for all lead abatement, the coating application, the inspection hold points, the responsibilities and documentation methods of each party involved, all safety methods to be used, contingency plans, and all other areas relating to the adequate completion of the painting of this Contract, including coordination with the U.S. Coast Guard, when applicable. Present at this preproduction meeting shall be all parties directly involved in the lead abatement, paint application,

and inspection of this Project including the Department, the Contractor and any Subcontractors, all Quality Control personnel, coating technical representatives, U.S. Coast Guard representatives, the Department's hazardous waste representative, a representative from the Contractor's hazardous waste transporter and any additional stakeholders who may have a direct impact on the completion of this Project. The Contractor shall be responsible for ensuring that all applicable personnel working directly, or indirectly, for the Contractor be present at this meeting.

<u>506.04 Quality Assurance</u> The Department will perform Quality Assurance (QA). QA may be accomplished by reviewing QC reports provided by the Contractor, by performing random inspections of work previously inspected by the Contractor and/or by randomly accompanying the Contractor's inspector during QC inspections and testing.

Provide the Department with the opportunity to perform QA inspections of the Work at the following hold points, as a minimum:

- A. Prior to start of work.
- B. Immediately following surface preparation.
- C. Immediately prior to application of the first coat.
- D. Prior to application of additional coats.
- E. After final coat is applied and cured.
- F. Any time the relative humidity is at, or above, 85% and the steel temperature is not 5 degrees above the dew point.

QA inspections are the prerogative of the Department. As such, the Department may, or may not, choose to perform inspections at hold points. Consequently, if any QA inspections performed at hold points result in no rework being identified or, if no QA inspections are performed at any hold points, this does not constitute Acceptance of the Work by the Department. If the Department discovers Unacceptable Work at any time prior to Final Acceptance, the Contractor shall repair, replace, or otherwise bring the Unacceptable Work into conformance with the Contract, at no additional cost to the Department. Refer to Standard Specification Section 107.9, Project Closeout, for procedures leading up to Final Acceptance.

Facilitate QA as required, by providing ample notice to the Department of availability for QA (minimum of ½ hour notice), adequate time for QA and by providing access to the work, along with all necessary safety equipment needed by the Department to perform the QA. For final inspection an aerial lift shall be provided.

Provide all the inspection and testing equipment needed to verify the quality of the surface preparation and coating process, including, but not limited to mirrors, flashlights and wet film thickness gauges. This equipment shall be made available for use by the Department at all times. All equipment shall be properly maintained and kept in working order by the Contractor.

Provide access and railing in compliance with OSHA standards for representatives of the Department to all work locations where cleaning or coating application may be in progress, for the

purpose of QA. The Contractor is also responsible for providing adequate lighting for QA purposes, at no additional cost to the Department.

If the Contractor is dissatisfied in any way with the Department's management of its QA program, the Contractor shall bring this issue immediately to the attention of the Resident or, at the latest, to the next scheduled Progress Meeting.

506.05 Protective Measures During surface preparation and field painting of the existing structural steel, provide adequate safety measures for the protection of the public and surrounding area against damage due to paint drippings, paint spatter, over-spray, falling objects, etc. The Contractor is fully responsible for property damage or personal injury which may result from operations incidental to surface preparation of the structural steel and the field application of the coating system. The coating system shall be protected at all times during application and curing to prevent contamination caused by construction or traffic activities. No coating material shall be stored on the bridge structure, or under the bridge structure.

506.06 Surface Preparation Chloride and salts should be expected to be present, especially at corrosion sites. The Maximum chloride threshold allowed is 7ug/cm². Test for chlorides and soluble salts using a Bresle Test kit, or equal, as approved by the Resident. After initial blast if chlorides are too high reduce chlorides and soluble salts to acceptable levels by waterjetting, solvent cleaning or other methods acceptable to the Resident prior to coating application and primer.

Test for soluble salts at a minimum of five locations per bridge span or as directed by the Resident. If after the initial testing has been done, it appears that no unacceptable levels of chlorides and soluble salts are present, the Resident may require a diminished number of tests. The Resident is not obligated to require less testing.

Remove all oil and grease present on bare steel or rusted surfaces in acordance with SSPC-SP 1, solvent cleaning, before blast cleaning.

The abrasive blast media shall meet the requirements of SSPC-AB 1, AB 2 or AB 3. The anchor profile shall be angular and meet the requirements of the coating manufacturer's published data sheet.

Abrasive blast clean the steel in accordance with SSPC-SP 10, Near-White Blast Cleaning except that inaccessible areas and sensitive areas as designated by the Resident shall be cleaned in accordance with SSPC-SP 11, Power Tool Cleaning to Bare Metal. After abrasive blast cleaning visually inspect the substrate for fins, tears, delaminations and other unacceptable discontinuities. Remove unacceptable discontinuities with a grinder or other suitable power tool. Reblast the affected area(s) to develop an acceptable anchor profile. The Contractor may propose an alternative method of developing an acceptable anchor profile on repair areas to the Resident.

Exercise care to avoid any nicking or gouging of the steel during rust removal. Nicks and gouges are cause for a suspension of activities until appropriate adjustments are made to prevent a reoccurrence. Repair damage to steel caused by surface preparation.

Measure the anchor profile of the substrate on every plane of each beam or girder. Record the location and results in the JCR. Label the replica tape (location, profile, etc) and affix the tape to the JCR. Provide copies to the Resident.

Double blow down or vacuum residual dust on the blasted substrate. Solvent clean any visible contamination that may result from handling, inspection or other activities that may inadvertently leave contaminants on the surface of the steel.

The allowable time between abrasive blast cleaning and primer application shall not exceed the Manufacturer's Product Data Sheet or 12 hours, whichever is less. If rust-back occurs, re-blast the entire prepared substrate prior to application of primer.

Newly fabricated steel members shall be cleaned in accordance with SSPC-SP 10.

Use SSPC-VIS.1 for abrasive blast cleaned substrate and SSPC-VIS.3 for hand or power tool cleaned substrate to determine acceptable surface cleanliness.

Measure the anchor profile in accordance with ASTM D 4417 Method C (replica tape). If the anchor profile fails to meet the minimum requirements, re-blast the substrate until the minimum required anchor profile is achieved. If the anchor profile exceeds the maximum allowed, generate a Non Conformance Report (NCR) describing the condition of the substrate and a proposed solution and submit it to the Resident for review.

If compressed air is used for abrasive blast cleaning, perform a blotter test ASTM D 4285 at the beginning of each shift and at any time requested by the QAI. Notify the QAI prior to performing the test so that the QA Inspector can witness the test.

506.061 Pre-Production Surface Preparation Test Sections Prepare test sections prior to production surface preparation. Prepare at least one test section for each specified degree of surface preparation. Test sections should be at least 1 square meter in size and include representative surfaces such as riveted and bolted connections. Prepare the test section surface preparation using the same equipment, materials and procedures that will be used for the duration of the Project. Perform the test cleaning in locations approved by the Department.

SSPC-VIS 1 and SSPC-VIS 3 photographic standards, as applicable, will be used by the Department to determine the level of cleanliness achieved. Do not proceed with production surface preparation activities until the Department agrees that the test section conforms to the applicable cleanliness requirements. The agreed upon test areas shall be masked off and left unpainted until the completion of the Project and will be used for calibration of gauges by both Department and Contractors personnel. A desiccant filled masking paper shall be used, all at no additional cost to the Department.

<u>506.062 Removal of Existing Debris</u> Remove and properly dispose of accumulated winter sand/salt, bird droppings, dirt, grease, and debris from all areas to be prepared and painted prior to undertaking any paint removal or surface preparation operations.

506.063 Sharp Edges and Steel Defects Remove by grinding all fins, tears, slivers, scabs, laminations, etc., that are present on any steel member, or that become apparent during the blasting operation. Re-blast areas that have been ground to achieve the specified profile. Immediately report to the Department any cracks or significant metal loss found in the structural steel.

506.064 Removal of Pack Rust Remove all rust scale on any surface and loose pack rust that has formed between structural members. Remove tight pack rust until the highest point is a minimum of 3 mm (1/8 inch) below the surface of the surrounding steel.

Exercise care to avoid any nicking or gouging of the steel during rust removal. Nicks and gouges are cause for a suspension of activities until appropriate adjustments are made to prevent a reoccurrence. Damage to steel by the Contractor shall be repaired by the Contractor as approved by, and at no cost to, the Department and no additional time will be added.

506.065 Compressed Air Cleanliness Provide compressed air that is free from moisture and oil contamination. Conduct a white blotter test in accordance with ASTM D 4285 to verify the cleanliness of the compressed air. Conduct the test at least once per shift for each compressor system. Sufficient freedom from oil and moisture is confirmed if soiling or discoloration is not visible on the paper.

If air contamination is identified, suspend operations and make adjustments as necessary to achieve clean, dry air.

<u>506.07 Mixing</u> Thoroughly mix the coating according to the manufacturer's recommendations. Thinning, if necessary shall be per the manufacturer's recommendations.

506.08 Conditions for Coating Apply and cure all coatings in accordance with the manufacturer's recommendations. Provide digital data recorders that measure and record temperature and relative humidity during the curing period for all coatings. Provide a minimum of two data recorders, which shall be placed in the immediate vicinity of the curing operation, and shall also provide the Department with the software necessary to download the recorded data. The data recorders shall measure and record the temperature and relative humidity during the entire curing cycle. No subsequent coating shall be applied until the Contractor demonstrates that the curing has met the requirements of the manufacturer's product data sheets.

506.09 Paint Application Caulk all gaps between abutting surfaces and at areas of pack rust that cannot be removed, as between the intermediate and top coat. Apply caulking between the bearing plates and the concrete piers. Provide the name, generic type, technical data sheets, and

application instructions for the material to the Resident. Provide written concurrence from the coating manufacturer that the caulking is compatible for use with the coating.

Measure the environmental conditions in the immediate vicinity of the piece(s) being coated during the coating operation and the entire cure period. Provide two data loggers capable of measuring ambient humidity and temperature. The data loggers shall come with software that can download the data onto a computer. Print the data. The data will become part of the JCR. Place the data loggers in the immediate vicinity of the coating operation during the entire application and curing cycle. The data will be used by the Resident to determine that the cure/recoat time requirements for each coat have been met. Failure to comply will result in the coating being cured for the maximum time necessary to assure adequate cure as determined by the Resident.

Apply each coat in a neat and workmanlike manner. Apply the coating inside the approved containment. Apply the coating smoothly and uniformly without film defects, in conformance with these specifications and applicable provisions of SSPC-PA 1, Shop, Field and Maintenance Coatin of Metals. Correct skips, thin areas or other deficiencies before each succeeding coat is applied. The surface of the paint receiving additional coating shall be free from dust, grease, oil or any other contaminant that would prevent bonding.

Measure the DFT of each coat with a Type 2 Electronic Gauge in accordance with SSPC-PA 2, Procedure for Determining Conformance to Dry Coating Thickness Requirements. Record the following:

- Gauge type/manufacturer/model
- Serial number
- Coat/shim used for calibration (e.g. Primer Coat/5 mil. Shim, etc.)
- Measurements/spot average/location
- Cure time
- Non-conforming areas and determination for correction

Brushes, when used shall be of good quality so as not to leave bristles in the coating and have sufficient body and length of bristle to spread the coating in a uniform flow. Rollers, when used, shall be of a type which will not leave a stippled texture or roller particles on the coated surface.

Inform the Resident prior to mixing and thinning all coating. Record the batch and lot numbers of the coating, the type and amount of thinner used, the time and pot life of the coating in the JCR.

Mix and add thinner in conformance with the Manufacturer's Product Data Sheet. Measure the thinner with a graduated cup or other measuring device. Mix the paint using the method, equipment and for the amount of time recommended by the coating manufacturer. Coating that is not mixed and thinned in accordance with the Manufacturer's Product Data Sheet will be rejected.

Stripe coat the substrate with primer in accordance with SSPC-PA 1, Section 7.3. The stripe coat is to be applied to edges, welds, outside corners, bolt heads/threads and crevices as directed

by the Resident. The stripe coat shall be brush and/or roller applied. Spray application of the stripe coat is only allowed upon prior approval of the Resident. If spray application is approved, the stripe coat shall be subsequintly worked into the surfaces by brush and/or roller. Whenever possible apply the stripe coat prior to application of the primer coat, however, in order to save the blast the Contractor may apply the stripe coat after the application of primer with the prior concurrence of the Resident. The resident may allow the contractor to stripe coat with the Intermediat coat on a case by case baisas. Failure to notify the Resident will render the work Non-Conforming Work.

Measure and record the DFT readings in the JCR. Document that minimum cure time has been achieved in the JCR. Include the data logger printout. Maintain environmental conditions to assure acceptable cure time between coats and after the top coat is applied. Coating that has been improperly cured will be rejected, removed and re-coated. The Resident will determine that the coating has been properly cured based on QC tests, measurements and documentation.

Identify areas on Non-Conformance and generate and Non-Conformance Report (NCR). Present the NCR to the Resident with a proposed repair. Examples of Non-Conformance are, but not limited to:

- Overspray
- Sags, drips, runs
- Thin coating
- Excessive film build
- Orange peel, mud cracking
- Blisters
- Surface contamination
- Discontinuities that may be reasonably expected to cause premature coating failure

Repair damaged coating or defectively applied coating (runs, sags, skips, misses, etc.). Remove the affected coating layers and reapply. If all coating layers are damaged or defective, remove all coating layers to the specified degree of cleanliness. Feather the edges of the remaining coating to create a smooth transition from the repaired area to the remaining coating. Reapply all affected coating layers.

506.10 Samples for Testing The Department may require random coating material samples from the Contractor. If necessary, the samples will be sent to an independent certified laboratory to obtain infrared spectra to check the formulation compared to that on the approved coatings list. Sampling and testing shall be at no additional cost to the Department. If the material fails the independent lab analysis, the Contractor shall remove and replace the coating to the Contract specified conditions, at no additional cost to the Department.

<u>506.11 Waste Management.</u> The Contractor shall collect, store and dispose of all hazardous, special and solid waste in compliance with relevant Federal, State and local laws and requirements. The procedures used for management and disposal of lead paint and related waste shall conform to the latest requirements of Steel Structures Painting Council Guide 7, Guide for

the Disposal of Lead-Contaminated Surface Preparation Debris. The Contractor shall have a copy of this guide available on site at all times. The Contractor shall also have a copy of the Maine Department of Environmental Protection's (DEP's) Handbook for Hazardous Waste Generators and a copy of the State of Maine Hazardous Waste Management Rules, 06-096 CMR Chapters 850-857, on site at all times. Thirty days prior to generating any waste, the Contractor shall submit their Waste Management Plan which shall include the Spill Prevention Control and Countermeasure Plan (SPCCP), to the Department for review and comment. Work shall not proceed until the Department has reviewed and approved this plan.

The Department has Large Quantity Generator (LQG) hazardous waste status for hazardous waste activities associated with this Contract, as defined by DEP in the Handbook for Hazardous Waste Generators. Waste generated as part of this initiative shall be stored and managed under dedicated, Environmental Protection Agency (EPA) waste identification numbers for each bridge site. The Contractor shall perform all work on behalf of the Department and comply with all Federal, State and local regulations.

The Contractor shall establish hazardous waste storage areas for this each bridge site. Hazardous waste shall be managed in US DOT approved containers and stored in an approved locking security structure which has a firm, impervious, floor surface and secondary containment that is either 110% of the largest container or 20% of all containers, whichever is larger. Waste containers must be labeled with the words "Hazardous Waste", the hazard (e.g., Toxic, flammable, etc.), the start date, full date, site location and generator information. The lockable security structure must be labeled "Danger-Unauthorized Personnel Keep Out" and shall be locked at all times when not being accessed. Waste containers in the waste storage security area must be inspected each operating day and a log must be maintained by the Contractor, and provided to the Department at the end of the Project. The Contractor shall store and manage all hazardous waste, in conformance with MDEP regulations as detailed in Chapters 850 – 857 and EPA regulations as defined in 40 CFR 260 – 268. All hazardous wastes are limited to an on-site storage time of 90 days based on the date of initial accumulation.

The Contractor shall test paint debris (including waste paint, personal protective equipment, gray water and spent solvents) to determine the appropriate disposal options. A minimum of Four composite sample representative of each waste type must be collected and tested for Toxicity Characteristic Leaching Process (TCLP), constituents in accordance with the procedures outlined in EPA SW846 Method 1311. The Department must be notified at least one week in advance of the date of sampling activities and provided with the proposed protocol for sample collection. The Department shall witness the sampling. Chain-of-custody must be adhered to for sample removal. Certified TCLP test results shall be provided to the Department upon receipt by the Contractor.

The Contractor shall inform the Department at least one week in advance of planned date(s) for removal of hazardous waste from the job site. The EPA ID number for the project will be provided by the Department prior to the first shipment of waste. The Contractor shall secure a MaineDOT pre-approved transporter licensed by the MDEP for transportation of hazardous waste. Preparation of all necessary transportation forms is the responsibility of the Contractor. The Hazardous Waste Manifest must be approved and signed by the Department. A six-part, pre-

numbered Uniform Hazardous Waste Manifest (EPA Form 8700-22) shall be prepared when shipping hazardous waste. The appropriate original sheets of the multi-part hazardous waste manifest must be provided to the Department and must be sent to the Department's Environmental Office, State House Station #16, Augusta, Maine, 04333-0016.

The Contractor shall select a Treatment, Storage or Disposal (TSD) facility as soon as the waste has been tested and the results are known. The Contractor will submit the selected TDS for MaineDOT approval. Following approval by MaineDOT, the Contractor shall obtain approval for acceptance of the waste from the selected facility prior to transport.

Hazardous/special paint debris and other waste shall not be placed or accumulated on unprotected ground or released to waters of the State. Work areas shall be adequately shielded at all times to prevent dispersion of debris by wind or rain. The Contractor's equipment and storage areas used for the handling and storage of hazardous waste and hazardous materials shall have impervious tarps placed under them. Any evidence of improper storage and handling shall be cause for immediate suspension of work in progress, and work will not be allowed until corrective actions are taken. Emergency procedures to be taken in the event of a release of hazardous/special waste or hazardous matter to the environment shall be part of the Contractor's Spill Prevention, Control and Countermeasures Plan that is required as part of the Contractor's Waste Management Plan and by the Department's Supplemental Specifications and Supplemental Standard Details for Construction, Section 656.3.4, f. Spill Prevention.

The Contractor shall have Aid Agreements with the local fire department, police department, hospital and hazardous waste spill responder. Copies of these agreements shall be provided to the department prior to generating any waste, in conformance with the DEP Rules, Chapter 851, Section 13, Part C (7)(c)(ii) and 40 CFR 264.37.

Failure of the Contractor to comply with this section shall result in the following:

- First finding of non-conformity shall be a written warning which will include deadline for compliance.
- Second finding of non-conformity shall be documented in writing, and all operations by the Contractor, except those needed to restore compliance, will be immediately suspended, until full compliance has been restored.
- Third and subsequent findings of non-conformity will be documented in writing and all operations shall be immediately suspended, except those needed to restore compliance, until full compliance has been fully restored, and the Contractor assessed a penalty of \$10,000.00 per incident. If the Contractor fails to restore the Project into compliance, additional fines shall be assessed.

All penalties assessed shall be in addition to any fines assessed by DEP/EPA for failing to comply with the Federal, State, or local regulations. The Contractor shall not be granted additional time for suspensions of work due to noncompliance.

506.111 Visible Emission Observations

A. Visible Emission Assessments

- 1. Conduct visible emissions assessments as defined in this Section and in accordance with 40 CFR 60, Appendix A, Method 22. This assessment is based on total visible emissions regardless of the opacity of the emission. SSPC Technical Update No. 7 provides guidance on conducting visible emission assessments.
- 2. Conduct the visible emissions assessments to account for all locations where emissions of lead dust might be generated, including but not limited to, the containment or work area, dust collection and waste recovery equipment as applicable, and waste containerizing areas.
- 3. In addition to assessing airborne emissions, conduct visual inspections for releases or spills of dust and debris that have become deposited on surrounding property, structures, equipment or vehicles.
- 4. State and local regulations regarding visible emissions:
 - a) Note that State of Maine regulations regarding visible emissions, as well as any local requirements, are in addition to, but not in lieu of, the requirements of this Section.

B. Acceptance Criteria for Visible Emissions Assessments

- 1. For surface preparation activities, visible emissions in excess of SSPC Guide 6, Level 1 (1% of the workday) are unacceptable. This amounts to a maximum duration of 4 minutes and 48 seconds in an 8-hour workday, or 36 seconds per hour. This criterion applies to scattered, random emissions of short duration. Sustained emissions (e.g., 1 minute or longer) from a given location, regardless of the total length of emissions for the workday, are unacceptable. Immediately shut down the emission-producing operation, change work practices, extend the ground coverings, modify the containment, or take other appropriate corrective action to prevent similar releases from occurring in the future.
- 2. Visible emissions in excess of the above criteria are cause for immediate shutdown. Immediately stop the applicable operations if these criteria are violated. Correct and repair the deficiencies causing the emission, and undertake clean up with HEPA vacuums.
- 3. Violations of any high volume ambient air monitoring acceptance criteria is cause for immediate project shut down and the initiation of corrective action, even if the visible emissions results are acceptable.

C. Frequency and Location of Emissions Assessments

- 1. Conduct the specialized assessments as described in this Section at least four times (for a minimum of fifteen minutes each) during each shift in which paint disturbance operations are underway. Document all observations even if visible emissions are not observed.
- 2. Perform casual observations of emissions on an ongoing basis.

D. Assessment and Correction of Spills or Releases

- 1. Conduct all activities so that spills or releases of paint chips or spent abrasive do not occur.
- 2. On a daily basis, visually inspect the site for releases of dust, paint chips, and spent abrasive outside of the work area that have become deposited on surrounding property, structures, equipment, or vehicles and on the unprotected ground or in areas where rain water could carry the debris outside of the work area.
- 3. Clean up all visible paint chips and debris on a daily basis at the end of each shift, or more frequently if directed by the Department. Conduct the cleaning by manually removing paint chips or by HEPA vacuuming.
- 4. When releases are observed, in addition to cleaning the debris, immediately shut down the emission-producing operations, change work practices, extend the ground coverings, modify the containment, or take other appropriate corrective action to prevent similar releases from occurring in the future. Do not resume operations until the corrective measures have been inspected and approved by the Department.

E. Reporting of Visible Emissions and Releases

- 1. Document all visible emission observations and all cases where work has been halted due to unacceptable visible emissions or releases, the cleanup activities invoked, and the corrective action taken to avoid reoccurrence. Provide a report to the Department within 48 hours of the occurrence.
- 2. Maintain the results of the assessments in a log at the site. Identify the frequency of observations made, the methods of observation utilized, the name of the observer(s), and documentation completed. Include and summarize the documentation prepared for work stoppages due to unacceptable visible emissions or releases. Make the log available to the Department for review upon request.

506.112 High Volume Ambient Air Monitoring All ambient air monitoring shall be performed by the Contractor according to EPA regulations 40 CFR Part 50 Appendix B, Reference Method for the Determination of Suspended Particulate Matter in the Atmosphere (High-Volume Method), and 40 CFR Part 50 Appendix G, Reference Method for the Determination of Lead in Suspended Particulate Matter Collected from Ambient Air.

A. Conduct daily high volume ambient air monitoring for TSP-Lead during any dust producing operations (i.e., abrasive blast cleaning, containment movement, and/or vacuuming spent abrasive) to confirm that emissions do not impact the public.

- B. Conduct ambient air monitoring at a minimum of three locations per jobsite or as directed by the Resident. The Contractor shall provide the monitors, and all necessary calibration and support equipment, power to operate the units, security (or arrangements to remove and replace the monitors daily), filters, and flow chart recorders. Provide operational high volume ambient air monitors for the duration of the project to account for each of the monitoring locations. Dust producing activities will not be permitted to begin if monitoring locations are not supported by the required number of monitors. Therefore, several back up monitors are recommended.
- C. High volume ambient air sample results will be compared to the acceptance criteria of 1.5 micrograms per cubic meter over a 90-day period. Utilize the formulae of SSPC Guide 6 to extrapolate the acceptance criteria to an adjusted daily allowable concentration.
- D. In the event that the TSP-Lead air monitoring results exceed the acceptance criteria on any one day of blasting, the Contractor shall suspend dust producing operations (e.g., paint removal and/or clean-up) and implement appropriate corrective action to control emissions.
- E. Document all cases when work has been suspended due to emissions exceeding the ambient air monitoring criteria.
- F. Background samples shall be collected for two days prior to the start of work while no dust producing operations are underway. The background monitoring shall be conducted-on one weekday and one weekend day. The background monitoring shall coincide with the anticipated working hours for the paint removal operations, but shall last for a minimum of 8 hours each day.
- G. Calibrate the monitors according to the manufacturer's written instructions upon mobilization to the site, following any repairs or maintenance to the units, and quarterly.
- H. Filters shall be placed in monitors prior to start of dust-producing operations and the filters removed upon completion of dust producing activities for that day. Advise the Department in advance when the filters will be removed and replaced. The monitor operator shall record the following information, at a minimum, on field data and laboratory chain-of-custody forms (or equivalent):
 - 1. Monitor location and serial number
 - 2. Flow rate, supported by flow charts
 - 3. Start, stop times and duration of monitoring
 - 4. Work activities and location of work during the monitoring period
 - 5. Wind direction/speed
- I. Ambient Air Monitoring Results. The laboratory shall provide the results directly to the Department with a copy to the Contractor within 3 days of the sampling. The results shall include:
 - 1. Monitor identification and location
 - 2. Work location and activities performed during monitoring period
 - 3. Monitor flow rate, duration, and volume of air sampled
 - 4. Laboratory methods used for filter digestion / analysis
 - 5. Sample results for the actual duration of monitoring

- 6. Sample results expressed in micrograms per cubic meter of air
- 7. Comparison of the results with the adjusted daily allowable concentration indicating whether the emissions are compliant
- 8. Field data and chain-of-custody records used to derive results

506.113 Regulated Areas Physically demarcated regulated area(s) shall be established around exposure producing operations at the OSHA Action Level for the toxic metal(s) present in the coating being removed or the abrasive being used. The Contractor shall provide all required protective clothing and equipment for personnel entering into a regulated area. Unprotected street clothing is not permitted within the regulated areas. Conduct air sampling at the boundaries of the regulated area for lead and any other toxic metals that may be present in the coating being removed or abrasive being used. Use a minimum of two low flow pumps located at points on the perimeter of the regulated area, one upwind and one downwind from the work area. Until monitoring results are available, establish the regulated area a minimum of 15 feet from any equipment or operations that might generate airborne emissions of toxic metals. If the monitoring confirms that emissions at the boundary do not exceed the OSHA Action Level as an 8-hour Time Weighted Average, discontinue monitoring. If the monitoring results exceed the OSHA Action Level, modify work practices and the containment to provide better controls over the emissions and repeat the monitoring until results are below the OSHA Action Level. Additional monitoring is not required unless directed by the Department, or if visible emissions occur or if there are changes to the work practices or equipment being used in the regulated area. Verify that cassettes are analyzed by an American Industrial Hygiene Association (AIHA) laboratory accredited for metals analysis. Have the laboratory provide results within 72 hours of the field sampling.

<u>506.12 Method of Measurement</u> Surface Preparation of Existing Structural Steel shall be measured for payment as one lump sum, complete and accepted.

Field Painting of Existing and New Structural Steel shall be measured for payment as one lump sum, complete and accepted.

Containment and Pollution Control Measures shall be measured for payment as one lump sum, complete and accepted.

Disposal of Special Waste or Hazardous Waste materials shall be measured for payment as one lump sum.

<u>506.13 Basis of Payment</u> The accepted quantity of Surface Preparation of Existing Structural Steel will be paid at the respective Contract lump sum price, which shall be full compensation for furnishing all materials, labor, tools, equipment, scaffolding, QC activities, and any other incidentals necessary for the satisfactory performance of the work.

The accepted quantity of Field Painting of Existing and New Structural Steel will be paid at the Contract lump sum price, which shall be full compensation for furnishing all material, labor, equipment, scaffolding, QC activities, and incidentals necessary for the satisfactory performance of the work.

Containment and pollution control will be paid for at the Contract lump sum price, which shall be full compensation for furnishing all materials, labor, equipment, and incidentals necessary for the satisfactory performance of the work.

Disposal of Special Waste or Hazardous Waste materials will be paid at the Contract lump sum price, which shall be full compensation for all permits, tests, transportation, disposal, tipping fees and incidentals necessary for the satisfactory performance of the work.

SPECIAL PROVISION <u>SECTION 527</u> ENERGY ABSORBING UNIT

(Truck Mounted Attenuator)

<u>Description:</u> This work consists of furnishing, maintaining and deploying a truck mounted attenuator (TMA) and a shadow or barrier truck in accordance with this specification and as directed. A Truck Mounted Attenuator must comply with NCHRP Report 350.

<u>Materials:</u> The energy absorbing system shall be from the Department's Qualified Product List (QPL). The TMA shall be mounted in accordance with the manufactures specifications to a truck with a gross vehicle weight of at least 10,000 pounds.

<u>Installation:</u> The chart below identifies the distance from the work zone or hazard where the TMA shall be deployed. If the work zone is within a marked lane closure, the barrier truck distances shall apply and if the work is mobile, then shadow truck distances shall apply. When used as a barrier, the barrier truck shall be parked in low gear with brakes applied and the front wheels turned away from the work zone and the adjacent traffic lane. For placement details, reference the Manual of Uniform Traffic Control Devices (MUTCD).

Method of Measurement: Truck mounted attenuator will be measured by the unit furnished.

<u>Basis of Payment:</u> The accepted quantity of truck mounted attenuator will be paid for at the contract unit price each which includes furnishing and all costs of attaching to and retrofitting of a truck on which The TMA will be deployed. Daily maintenance and deployment of the TMA, including the cost of the truck, shall be considered incidental.

SPECIAL PROVISION <u>SECTION 652</u> MAINTENANCE OF TRAFFIC

<u>Approaches</u>. Approach signing shall include the following signs at a minimum. Field conditions may warrant the use of additional signs as determined by the Resident.

Road Work Next X* Miles Road Work 500 Feet (Ahead) End Road Work

Work Areas. At each work site, signs and channelizing devices shall be used as directed by the Resident.

Signs include:

Road Work xxxx¹. One Lane Road Ahead Flagger Sign

Other typical signs include:

Be Prepared to Stop Low Shoulder Bump Pavement Ends

The above lists of Approach signs and Work Area signs are representative of the contract requirements. Other sign legends may be required.

Unless otherwise defined in Special Provision 105/107 or submitted and approved in the Traffic Control Plan, the following shall apply:

- The Contractor shall conduct their operations in such a manner that the roadway will not be restricted to one lane for more than 2,500 feet at each work area and no more than 4,000 feet for paving, milling, and crack seal/repair work areas.
- Where more than one work area restricts traffic to one lane operation, these work areas shall be separated by at least 1 mile of two-way operation.

<u>Temporary Centerline</u> A temporary centerline shall be placed each day on all new pavement to be used by traffic. The temporary centerline, when specified of reflectorized traffic paint, shall conform to the standard marking patterns used for permanent markings. Failure to apply a temporary centerline daily will result in a Traffic Control Violation and suspension of paving operations until temporary markers are applied to all previously placed pavement.

SPECIAL PROVISION <u>SECTION 652</u> SOUND ATTENUATION WALL

Description:

1.1 This work shall consist of furnishing, erecting, and positioning portable, temporary, noise attenuation sound walls to shield high noise-generating ground-level equipment used for bridge painting operations from residential areas of the City, as described herein and as directed.

Materials:

2.1 Acoustical Sound Walls.

- **2.1.1** Temporary sound wall barriers shall have a minimum Sound Transmission Class (STC) of STC-30 or greater, as based on certified sound transmission loss data taken by a certified laboratory and according to ASTM Test Method E90 and E413.
- **2.1.2** The temporary sound wall barrier shall have a Noise Reduction Coefficient (NRC) rating of no less than NRC-1.00 or greater based on certified sound absorption coefficient data taken by a certified laboratory and according to ASTM Test Method C423.
- **2.1.3** The materials used for temporary sound wall barriers shall be of sufficient make and quality to last through the duration of construction for the Contract and shall be maintained in good repair.
- **2.1.4** Sound wall barrier panels, planks, or cells shall be attached to support frames constructed in sections as to provide a portable barrier and shall be designed to withstand a minimum wind load of 20 psf.
- **2.1.5** When sound wall barrier units are joined together, the mating surfaces of the barrier sides shall be flush with each other. Gaps between barrier units and between the bottom edge of the barrier and the ground shall be closed with an approved acoustical material that will completely fill the gaps and attenuate noise.
- **2.1.6** Noise reduction materials may be new or used. Used materials shall be of good quality, and condition to perform their designed function and meet the requirements of this specification.

- **2.1.7** The minimum sound wall barrier height shall be 15 feet, unless approved otherwise.
- **2.1.8** All temporary sound wall materials and equipment will remain the property of the Contractor or Contractor's subcontractor, vendor, and suppliers, as applicable.

2.2 Noise monitoring equipment.

- **2.2.1** Sound level meters used for noise measurements shall meet or exceed the criteria for Type 1 (Precision) or Type 2 (General Purpose) Sound Level Meter as defined in the most recent revision of the ANSI Standard S1.4.2.
- **2.2.2** The sound level meters shall be capable of measuring dB noise levels on the A-weighted scale and operating on the "slow" response setting.
- **2.2.3** The sound level meters shall be laboratory calibrated and certified annually, and field calibrated prior to each measurement.

Construction Requirements:

3.1 General.

3.1.1 Approval. Furnish, use, and maintain temporary sound walls in a conscientious manner to reduce the level of noise generated from paint operations equipment, as approved by the Department.

3.2 Supplier Qualification.

3.2.1 The temporary sound wall material supplier shall be experienced in furnishing noise attenuation materials and implementing effective noise reduction methods for industrial applications.

3.3 Noise Reduction Plan.

3.3.1 Submit a Noise Reduction Plan to the Department for approval, describing materials, field controls, site configuration, and positioning of temporary sound walls to reduce noise from ground-level high noise generating equipment, primarily, the <u>grit recycling unit</u>, <u>dust collector</u>, and <u>air compressor</u>.

- **3.3.2** The Noise Reduction Plan shall be prepared by a qualified Technical Representative of the sound wall material supplier. Noise monitoring measurements shall be taken by trained, qualified personnel.
 - **3.3.3** The Noise Reduction Plan should include the following elements:
 - 1. Written description of the plan, materials, material product data sheets, certifications of compliance, material lab data certifications, and laboratory qualifications;
 - 2. A sketch of the site, configuration of equipment, location of noise reduction measures, etc.;
 - 3. Noise monitoring plan, including background noise measurements, monitoring frequency, duration, locations, and noise measuring equipment, reporting procedures, and complaint response & resolution procedures;
 - 4. Detail drawings of the sound wall assembly.
- **3.3.4** After the temporary sound wall is assembled, arrange for a technical representative (not a sales representative) of the sound wall supplier to conduct a site inspection, in the presence of the Department's representative, to verify the quality of assembly, and to issue a letter stating that the system has been assembled in an approved manner as shown on the drawings. Submit the letter to the Department before starting work.

3.4 Noise reduction methods.

- **3.4.1** The Contractor shall use reasonable efforts to implement noise reduction methods to reduce ground-level construction equipment noise levels. Noise reduction methods include, but are not limited to:
 - 1. Shielding Erecting temporary sound wall noise attenuation barriers to intervene between the noise source and residential noise receptor locations.
 - 2. Distance- Configuring the construction site in a manner that locates loud equipment and activities as far as possible from noise-sensitive locations.
 - 3. Echo Placing construction equipment out from under the bridge as much as possible to reduce a potential echoing effect.
 - 4. Scheduling Scheduling construction events and limiting usage times to minimize noise during non-productive hours, unnecessary idling, etc.

3.5 Installation, maintenance, and removal.

- **3.5.1** The sound wall barriers shall be installed in such a manner that the noise-absorptive surfaces face the construction noise source.
- **3.5.2** The sound wall barriers shall be installed in such a manner to minimize penetration into the ground for support.
- **3.5.3** The Contractor shall maintain the temporary sound wall barriers and repair all damage that occurs, including but not limited to, keeping the barriers clean and free of graffiti, and maintaining structural integrity. Gaps, holes, and weaknesses in the barriers, and openings between or under the units shall be repaired promptly or replaced with new material.
- **3.5.4** The Contractor shall remove the temporary sound wall barrier at the end of the Contract or as soon as directed by the Department.
 - **3.5.5** All moves of the temporary sound wall are incidental to the work.

3.6 Site Configuration.

3.6.1 Position the temporary sound walls on three sides as close as practicable to the high noise-generating equipment between the noise source and residential noise receptor locations.

3.7 Noise level monitoring.

- **3.7.1** Take background noise measurements over three consecutive weekday nights in the project area.
- **3.7.2** Take noise measurements at a height of five-feet above the ground at the closest distance to a residential right-of-way line from the noise generating equipment as determined by the Resident before any production work requiring the use of noise generating equipment is done. If the noise measurement shows the noise levels are under the High Noise level threshold, the test cost will be paid under Item 652.55 and then Item 652.55 will be removed from the contract for that WIN.
- **3.7.3** Take noise measurements at least once each week and when high-noise producing equipment and temporary sound walls are repositioned.
- **3.7.4** Use a report form to record noise measurements and report results to the Department.

- **3.7.5** Limits of Operations and Section 652 High Noise for noise limits.
- **3.7.6** The time period for each measurement shall be 20 minutes, unless approved by the Department.

Method of Measurement:

4.1 Item 652.55, Temporary Sound Walls, will be measured as a Lump Sum. All labor, tools, equipment, materials, scaffolding, supplies, plans, programs, services of the manufacturer's representative, relocations as required, or incidentals to properly perform and complete the Work specified, will be a lump sum.

Basis of Payment:

5.1 The accepted item of 652.55, Temporary Sound Walls, will be paid for at the contract lump sum price, complete. Partial payments will be made. The contract lump sum price will be prorated to establish the amount of each partial payment based on the percentage of the item that has been completed.



SPECIAL PROVISION <u>SECTION 652</u> High Noise

The work is adjacent to a residential area. Out of consideration for these residents, the Contractor shall use field controls to reduce noise from ground-level equipment generating high levels of noise, primarily, the grit recycling unit, dust collector, and air compressor if the noise generated is higher than the ambient background noise or 80 dB whichever is greater.







SPECIAL PROVISION SECTION 652

MAINTENANCE OF TRAFFIC

Portable/Temporary Traffic Signals Automated Flagging Assistance Devices (AFADs)

652.01 Description Portable/Temporary Traffic Signals or Remotely Controlled Automated Flagging Assistant Devices (AFADs) may be used in conformance with this Special Provision at the option of the Contractor in lieu of Flaggers and as approved by the Department.

Portable/Temporary Traffic Signals shall conform to Part 4H.02 of the latest edition of the Manual on Uniform Traffic Control Devices (MUTCD) and shall be the Dolly Type (SQ2) or the Trailor Mounted Type (SQ3). AFADs shall conform to Part 6E.04 of the latest edition of the Manual on Uniform Traffic Control Devices (MUTCD).

Portable/Temporary Traffic Signals and AFADs must satisfy applicable crashworthiness standards based on device weight which shall be in accordance with National Cooperative Highway Research Program (NCHRP) Report 350 and the American Associated for State Highway and Transportation Officials (AASHTO) Manual for Assessing Safety Hardware. The use of Portable/Temporary Traffic Signals may be suspended at any time at the discretion of the Resident.

652.02 Portable/Temporary Traffic Signals Operation

The Contractor shall submit a Traffic Control Plan to the Resident for approval which shall detail Portable/Temporary Traffic Signals operation.

Portable/Temporary Traffic Signals may be used during daytime or nighttime operations; however, Dolly Types (SQ2) shall not be in operation when the work site is unattended.

Work zones utilizing Portable/Temporary Traffic Signals shall add A Signal Ahead symbol (W3-3) sign that will replace the Flagger symbol sign. An 18-inch-wide removable stop line with a STOP HERE ON RED (R10-6) sign shall be installed at the intended stopping point.

The Resident may waive the requirement for a stop line if the roadway is unpaved or it is otherwise impractical to install a stop line and the STOP HERE ON RED sign is in place.

The distance between Portable/Temporary Traffic Signals units shall not exceed the phase timing and distances as designed by a Professional Engineer, registered in the state of Maine, or as designated on the Charts provided in this specification.

When the work no longer necessitates use of the Portable/Temporary Traffic Signals, the units shall be removed or turned off and moved out of view from the traveled way.

652.03 Automated Flagging Assistance Devices (AFADs)

AFADs shall be used only for short-term or intermediate-term lane closures in situations where there is one lane of approaching traffic that needs to be controlled. AFAD use is acceptable in either of the following cases: The first case employs an AFAD unit at each end of the work zone while the second case employs an AFAD unit at one end and a flagger at the other end. Utilizing an AFAD, a single flagger may remotely control two or more AFAD units provided that the flagger has a clear view of each unit, and of approaching traffic in both directions. Other cases may be used as approved by the Resident.

AFAD use is permitted during daytime or nighttime operations; but, if used at night, the AFADs must be illuminated in accordance with Section 6E.08 of the latest edition of the MUTCD.

AFADs are not traffic control signals, they should not be used to replace traffic signals or other continuously operating traffic control devices.

A competent, certified flagger, who has been trained on the operation of the AFADs shall operate and not leave the AFADs unattended at any time. The flagger shall have an unobstructed view of the AFADs and approaching traffic in both directions at all times. The distance between AFAD units shall not exceed one-half mile.

Work zones utilizing AFADs shall comply with the Standard Sheet for flagger operation on a 2-lane 2-way roadway, where an AFAD unit, or units, is used in lieu of a flagger a BE PREPARED TO STOP sign (W3-4) is to be used in lieu of the Flagger symbol sign. Red/Yellow lens AFADs shall have a STOP HERE ON RED (R10-6) sign installed on the right-hand shoulder at least 8 feet in advance of the RCRYLS unit where vehicles are expected to stop and Stop/Slow AFADs shall have WAIT ON STOP (R1-7) and GO ON SLOW (R1-8) signs immediately adjacent to the AFAD.

The Contractor's Traffic Control Plan shall detail AFAD operation including a list of competent, certified flaggers trained to operate the AFADs. When the work no longer necessitates use of the AFADs, units shall be moved out of view from the traveled way.

652.04 General Operation

Portable/Temporary Traffic Signal and AFAD units shall be placed in the shoulder on the right-hand side of the road with a sight distance as designated in the <u>Minimum Sight</u> <u>Distance for Signal Visibility</u> chart provided in this specification.

If the shoulder is not adequate, the Portable/Temporary Traffic Signals or AFADs may encroach on the travel lane provided that the appropriate sight distance is available and as approved by the Resident. Re-positioning of the Portable/Temporary Traffic Signals or AFADs shall need the approval of the Resident.

Appropriate flagger apparel and equipment shall be maintained near each Portable/Temporary Traffic Signal or AFAD unit to facilitate flagging in the event of a malfunction or operational need due to frequent disruptions of traffic flow. The Contractor shall immediately provide traffic control with flaggers if a Portable/Temporary Traffic Signal or AFAD unit malfunctions; fails to properly or adequately control traffic; creates congestion, queues or gridlock which cannot be remedied by timely on-site adjustments to the signal operation; or is otherwise inadequate; all of which shall be determined by the Resident.

When Flaggers are being utilized, Portable/Temporary Traffic Signals shall not be in operation.

Portable/Temporary Traffic Signals or AFADs shall not be located within 200 feet of a grade crossing unless the temporary traffic control signal is provided with preemption in accordance with MUTCD Section 4D.27, or unless a uniformed officer or flagger is provided at the crossing to prevent vehicles from stopping within the crossing.

<u>652.05 Method of Measurement</u> Portable/Temporary Traffic Signals or AFADs shall be measured by the hour for each approach that are in place and operating.

652.06 Basis of Payment Portable/Temporary Traffic Signals shall be paid at the Flagger Hourly Rate for each approach in operation.

AFADs shall be paid at the Flagger Hourly Rate for each unit in operation and for the operator.

(1st Example: One set of AFADs (one unit), plus operator, would be paid as 2 X Flagger hourly rate X hours in use.)

(2nd Example: One set of AFADs (two units), plus operator, would be paid as 3 X Flagger hourly rate X hours in use.)

The information and requirements set forth in this Special Provision will constitute the Soil Erosion and Water Pollution Control Plan (SEWPCP) for this Project.

All Work shall be done in accordance with the latest revision of the Maine Department of Transportation Best Management Practices for Erosion and Sediment Control (a.k.a. Best Management Practices manual or BMP Manual). The latest version is dated February 2008 and is available at:

http://www.maine.gov/mdot/env/

- 1. The on-site person responsible for implementation of this plan, shall be the Contractor's Superintendent or other supervisory employee (the "Environmental Coordinator") with the authority to immediately remedy any deficient controls and shall provide the Resident with their numbers (telephone number, cellular phone and pager numbers, if applicable) where the Environmental Coordinator can be reached 24 hours a day.
- 2. All areas where soil is disturbed shall be permanently mulched on a daily basis and seeded on a weekly basis (if seeded by hand, it shall be done on a daily basis). All previously mulched areas shall be maintained and re-mulched on a daily basis if bare areas develop until an acceptable growth of grass has been obtained.
- 3. All disturbed ditches shall receive erosion control blanket or stone rip rap, as required, prior to the end of the working day.
- 4. Winter stabilization BMPs shall be applied in accordance with the MaineDOT BMP Manual between November 1 and April 15 or during frozen ground conditions.
- 5. Where necessary, catch basins and drainage inlets shall utilize Storm Drain Inlet Protection in accordance with the MaineDOT BMP Manual.
- 6. If the Work includes the handling or storage of petroleum products or Hazardous Materials including the on site fueling of Equipment, the Resident must be provided with a Spill Prevention Control and Countermeasure Plan (SPCCP) plan from the Contractor. At a minimum, the SPCCP shall include:
 - The name and emergency response numbers (telephone number, cellular phone and pager numbers, if applicable) of the Contractor's representative responsible for spill prevention and response;

- General description and location of (1) handling, transfer, storage, and containment facilities of such products or hazardous Matter/Substances ("activities and facilities") and (2) potential receptors of such products or hazardous Matter/Substance including oceans, lakes, ponds, rivers, streams, wetlands, and sand and gravel aquifers ("sensitive resources") including potential conveyances (adjacent open and closed drainage systems), the distances between said activities and facilities and said sensitive resources;
- Description of preventative measures to be used to minimize the possibility of a spill including Equipment and/or Materials to be used to prevent discharges including containment and diversionary structures, inspections and personnel training;
- A contingency response plan to be implemented if a spill should occur including a list of emergency phone/pager numbers including the Contractor's representative, Maine DEP Spill Response, the National Response Center (if spill enters the water), the Resident, and local police and fire authorities, a list of emergency response equipment and locations and description of the capabilities of the equipment, a description of the general response and clean up protocols by product or Matter/Substances and an overview of the verbal and written notification procedures for federal, state and local officials. For a related provision, see *Standard Specification*, *Section*, <u>105.2.3 Project Specific Emergency Planning</u>.
- 7. The Environmental Coordinator must inspect and maintain, daily, all controls for the duration of the project.
- 8. If the Project Resident directs additional soil disturbance that requires temporary erosion and sedimentation control measures included within this Special Provision, all additional Work will be paid for as Changes Permitted.
- 9. If the Project Resident directs additional soil disturbance that requires temporary erosion and Sedimentation control measures not included within this Special Provision, Standard Specification, Section 656.1 will be reinstituted and the Contractor shall prepare and submit a SEWPCP and properly implement its approved SEWPCP. (Corrections, Additions, & Revisions to Standard Specifications – March 2020)

<u>SECTION 101</u> CONTRACT INTERPRETATION

101.2 Definitions

Construction Easement revise this definition by removing it in its entirety and replace with; "A right acquired by the Department for a specific use of private property outside of the established Right-of-Way. Examples include but are not limited to Drainage Easements, Construction and Maintenance Easements, and Slope Easements. Construction Easement areas, including Temporary Construction Limits and Temporary Road Limits, outside of the Right-of-Way remain private property. No use other than to access and perform the specified work activity is permitted without written permission of the owner."

<u>Construction Limit Line</u> Remove this definition in its entirety.

<u>Holidays</u> Amend this paragraph by adding "**Juneteenth**" between 'Memorial Day' and 'Independence Day'.

<u>Plans</u> Revise this paragraph by removing "Standard Details, Supplemental Standard Details" from the first sentence.

<u>Project Limits</u> Revise this definition by removing it in its entirety and replacing it with: "Areas within the Right-of-Way, Construction Easements, or Temporary Construction Limits shown on the Plans or otherwise indicated in the Contract. If no Project Limits are indicated in the Contract, the Project Limits shall be determined by the Department. For a related Maine statute, see 23 MRSA § 653. "

<u>Right-Of-Way</u> Revise this definition by removing it in its entirety and replacing it with: "The area of land, property, or interest therein, acquired for or devoted to the Project or other purposes. Portions of the Right-of-Way may be used for storage of materials and equipment and the location of engineering facilities, subject to written approval by the Department."

Amend this Section by adding the following two definitions (that replace Construction Limit Line);

<u>Temporary Construction Limits</u> The area within which the Contractor may access and perform the Physical Work and outside of which Work may not be performed without written authorization by the property owner.

<u>Temporary Road Limits</u> The area within which the Contractor may construct and maintain a temporary detour for maintenance of traffic.

SECTION 102 BIDDING

102.11 Bid Responsiveness Revise the paragraph that states

"The Bid is not signed by a duly authorized representative of the Bidder." So that it reads:

"The Bid is not signed by a duly authorized representative of the Bidder.

The Apparent Successful Bidder who does not already hold an Annual Prequalification shall have 21 days to provide the Department with their Prequal documents or the Department may move on to the next low bidder."

SECTION 104 GENERAL RIGHTS AND RESPONSIBILITIES

- <u>104.2.1 Furnishing of Right-of-Way</u> Revise this subsection by removing it in its entirety and replace with the new subsection:
- <u>"104.2.1 Furnishing of Property Rights</u> The Department will secure all necessary rights to real property within the Project Limits shown on the Right-of-Way Plans that are provided with the Bid Documents. For related provisions, see Sections 104.3.2 Furnishing of Other Property Rights, Licenses and Permits and 105.4.5 Maintenance of Existing Structures. For related definitions, see Construction Easements and Right-of-Way."
- 104.3.2 Furnishing of Other Property Rights, Licenses and Permits Revise this subsection by replacing "104.2.1 Furnishing of Right-of-Way" with "104.2.1 Furnishing of Property Rights".

SECTION 105 GENERAL SCOPE OF WORK

- Vertical pay limits:
 - Below a plane parallel with and 12 inches below the bottom of the drainage or minor structure or
 - Below the excavation limits shown in the Bid Documents; whichever is greater.
- Horizontal pay limits The maximum allowable horizontal dimensions shall not exceed those bounded by vertical surfaces 18 inches outside the base, or extreme limits of, the structure, and to the vertical neat lines of underdrain trenches, as shown in the Contract Documents.

SECTION 401 HOT MIX ASPHALT PAVEMENT

401.19 Contractor Quality Control Amend this Section by adding the following to the end: "Failure to comply with the approved QCP will result in work suspension and pay reductions as outlined in Section 106.4.6. The Quality Control Plan Value shall be the total bid value for all items covered by the QCP as identified in Special Provision 403."

SECTION 501 FOUNDATION PILES

<u>501.044 Special Requirements for Steel Pipe Piles and Steel Casings</u> Amend this section by deleting it in its entirety and replacing with:

Pipe piles shall be driven closed ended, unless otherwise specified. When open-ended pipe piles are specified or when the ends are not completely closed ended when driven, the inside of the pile shall be thoroughly cleaned out, and the inside walls cleaned by jetting or other means approved by the Resident. The sediment control required for the cleaning operations shall be covered in the Contractor's SEWPCP.

Pipe piles shall be inspected and approved by the Resident immediately before concrete is placed in them. They shall be free from rupture and undue deformation and shall be free from water unless the Resident determines that the concrete can be placed without damage to the pile and such that the discharged water will be contained. The Contractor shall provide lights and other equipment necessary to enable the Resident to inspect each pipe pile.

Portland cement concrete for filling the pipe piles shall be placed in one continuous operation to fill the pile completely without causing water contamination. An internal type vibrator shall be used in the top 25 feet. Pile heads shall be protected and cured in accordance with Section 502, Structural Concrete.

The placing of concrete and the driving of piles shall be scheduled so that fresh and setting concrete will not be injured by the pile driving.

Concrete shall not be placed in pipe piles until pile driving has progressed beyond a radius of 15 feet from the pile to be concreted. If pile heave is detected for pipe piles that have been filled with concrete, the piles shall be redriven to the original position after the concrete has attained sufficient strength and a proper hammer-pile cushion system, is in place and is satisfactory to the Resident.

When a reinforcing steel cage is specified, it shall be placed inside the piles to allow for a minimum of 2 inches of concrete cover and the piles shall be filled with concrete to the elevation shown on the Plans.

Full-length pipe piles and steel casings shall be used wherever practicable; however, splicing may be permitted when approved by the Resident. The method of splicing shall be as follows:

- a. Steel pipe piles and steel casings shall be spliced by full penetration butt joint welds.
- b. When the pipe piles and steel casings are to be spliced while in a vertical position, splicing shall be accomplished utilizing single-bevel groove welds with the use of back-up rings. When the pipe piles and steel casings are to be spliced while in a horizontal position, splicing shall be accomplished utilizing single-vee groove welds with the use of back-up rings.
- c. Welded joints shall conform to the Standard Details.

<u>501.047 Splicing Piles</u> Amend this section by deleting it in its entirety and replacing it with:

Full-length piles shall always be used wherever practicable. When full-length piles cannot be used, the number of splices, locations, and details shall be noted in the QCP. Piles fabricated from multiple pieces will be acceptable only if they comply with the following:

When pre-planned splicing is approved, the pile piece of lesser length shall be placed at the tip of the pile (the first part of the pile that enters the ground).

- B. Qualify welders in accordance with the most recent edition of the AWS D1.5 code.
- C. Submit a written Weld Procedure Specification (WPS) for each joint to be included as part of the QCP. The WPSs shall be provided to the Fabrication Engineer for review and approval prior to beginning welding. Provide copies of the approved WPSs to the welder, QC Inspector and Resident prior to beginning welding. Welding performed without an approved WPS and approved QCP will be considered Unacceptable Work.
- D. Provide a list of qualified welders with copies of their AWS certifications to the Fabrication Engineer for review prior to beginning welding. Welders shall have in their possession, at the time of welding, a valid certification for the process and position to be used in production from the AWS. The welder shall show the Resident their credentials upon request.
- E. The Contractor shall only use electrodes that are on the Department's Qualified Products List for Welding Electrodes or shall submit alternative electrodes for review and approval by the Fabrication Engineer. Electrodes used shall match those approved for use in the WPS.
- F. Welding shall not be done: When the temperature in the immediate vicinity of the weld is below 0°F; when the surfaces are damp or exposed to rain, snow, or high wind; or when the welders or welding operators are exposed to inclement conditions.
- G. The pile shall be preheated to and maintained at 150°F minimum, within 6 inches from the joint during welding.
- H. Power sources for welders shall have meters indicating amperage/voltage that have been calibrated within 1 year at the time of welding.
- I. The Contractor shall provide the Department with notice, a minimum of, 7 Days prior to the start of any welding.
- J. The Contractor shall provide a QC Inspector to perform QC for the welds in accordance with the AWS D1.1 welding code. The QC Inspector shall be an AWS Certified Welding Inspector (CWI) in conformance with the requirements of AWS QC1, Standard for AWS Certifications of Welding Inspectors. The Contractor may submit, in lieu of a CWI, an alternative QC Inspector with documented training and experience in metals fabrication, inspection, and testing for approval by the Fabrication Engineer. The QC Inspector shall be someone other than the welder performing the welds to be inspected.
- K. The QC Inspector shall inspect all production stages of the welded splice to ensure that workmanship and materials meet the requirements of the AWS D1.1 welding code and the Contract. The QC Inspector shall submit a signed record of all weld inspection documentation to the Resident after welding is completed.

Record of weld inspection shall include, but not be limited to, the following:

- 1. Name of QC Inspector
- 2. Project WIN and Location
- 3. Date
- 4. Weather conditions
- 5. Type, size, length, and location of welds.

- 6. Confirmation of appropriate equipment and materials used, including proper handling of welding electrodes.
- 7. Confirmation that welder has approved WPS onsite, and welding is performed in accordance with approved WPS.
- 8. Confirmation that welder is qualified to perform work per approved WPS. Include name and certifications of qualified welder who performed the work.
- 9. Confirm that 100% visual testing, in accordance with AWS D1.1 Table 8.1, has been conducted and any subsequent repairs are made prior to non-destructive testing (NDT).
- 10. Document NDT testing including name of NDT technician, NDT personnel qualifications, type and extent of NDT testing performed, and include NDT testing reports provided by the NDT testing technician.
 - L. Piles shall not be driven until all pile welding has been inspected and accepted by the Department.

501.0471 Specific Requirements for Splicing H-Beam Piles

- A. Damaged material shall be removed from the end of the driven pile. Lifting holes shall be repaired or trimmed off. The ends of both pieces to be spliced shall be cut off square with the longitudinal axis of the pile and beveled per the approved WPS. All cutting shall be done with the use of a mechanical guide, except that minor trimming may be allowed, as approved by the Resident.
- B. The Contractor shall use an approved mechanical splicer or a full penetration butt weld for the entire cross section of the pile. Mechanical splicers shall be installed per the manufacturer's recommendations, except that the flanges shall be welded using a complete joint penetration weld, per the AWS D1.1 welding code.

- B. Qualify welders in accordance with the most recent edition of the AWS D1.5 code.
- C. Submit a written WPS for each tip to be included as part of the QCP. The WPSs shall be provided to the Fabrication Engineer for review and approval prior to beginning welding. Provide copies of the approved the WPS to the welder and Resident prior to beginning welding. Welding performed without an approved WPS and approved QCP will be considered Unacceptable Work.
- D. Provide a list of qualified welders with copies of their AWS certifications to the Fabrication Engineer for review prior to beginning welding. Welders shall have in their possession, at the time of welding, a valid certification for the process and position to be used in production from the AWS or other organization acceptable to the Resident. The welder shall show the Resident their credentials upon request.
- E. The Contractor shall only use electrodes that are on the Department's Qualified Products List for Welding Electrodes or shall submit alternative electrodes for review and approval by the Fabrication Engineer. Electrodes used shall match those approved for use in the WPS.
- F. Pile tips shall be approved by the Resident.

- G. Welding shall not be done: When the temperature in the immediate vicinity of the weld is below 0°F; when the surfaces are damp or exposed to rain, snow, or high wind; or when the welders or welding operators are exposed to inclement conditions.
- H. The pile shall be preheated to and maintained at 150°F minimum within 6 inches from the joint during welding.
- I. Power sources for welders shall have meters indicating amperage/voltage that have been calibrated within 1 year at the time of welding.
- J. Pile tips may be welded to the piles by the pile supplier upon approval by the Department. Approval is contingent upon submission of the following: A welding QC Plan; proof that the proposed welder(s) is certified per AWS D1.5; and an AWS D1.1 WPS, with base metal preheated to a minimum of 150°F. The Contractor shall provide notice a minimum of 14 Days prior to the start of any welding by the pile supplier. At a minimum, welds shall be 100% visually inspected by the pile supplier's QC representative.
- K. The Contractor shall provide a QC Inspector to perform QC for the welds in accordance with the AWS D1.1 welding code. The QC Inspector shall be an CWI in conformance with the requirements of AWS QC1, Standard for AWS Certifications of Welding Inspectors. The Contractor may submit, in lieu of a CWI, an alternative QC Inspector with documented training and experience in metals fabrication, inspection, and testing for approval by the Fabrication Engineer. The QC Inspector shall be someone other than the welder performing the welds to be inspected.
- L. The QC Inspector shall inspect all production stages of the welded splice to ensure that workmanship and materials meet the requirements of the AWS D1.1 welding code and the Contract. The QC Inspector shall submit a signed record of all weld inspection documentation to the Resident after welding is completed.

The end of the pile to which the tip is to be attached shall be cut off square with the longitudinal axis of the pile and prepared per the approved WPS. All cutting shall be done with the use of a mechanical guide, except that minor trimming may be allowed, as approved by the Resident.
- B. Regarding weld size, prefabricated pile tips shall be attached to H-beam piles with 5/16-inch groove welds along each flange, or as recommended by the manufacturer of the pile tips, whichever weld size is larger.
- C. The QC Inspector shall, at a minimum, perform 100% VT on each pile tip weld.
- D. "The minimum lap splice lengths in the table above are based on the parameters below. When any of these parameters are altered, appropriate minimum lap splice lengths will be as shown on the Plans.

- Class B tension lap splice
- Minimum center-to-center spacing between bars of 6 inches
- Minimum clear cover of 2 inches
- Nominal reinforcing steel yield strengths
 - o Low-carbon Chromium = 100 ksi
 - \circ Stainless = 75 ksi
 - \circ All others = 60 ksi
- Reinforcement with yield strengths greater than 75 ksi shall have beam transverse reinforcement and column ties provided over the required lap splice length in accordancewith the current edition of the AASHTO LRFD Bridge Design Specifications

When lap splices are placed horizontally in an element where the concrete depth below the splice will be 12 inches, or more, the indicated lap splice lengths shall be multiplied by a factor of 1.3."

<u>SECTION 506</u> SHOP APPLIED PROTECTIVE COATING – STEEL

506.13 Surface Preparation Amend this section by adding this paragraph to the end:

"Steel shall meet the requirements of SSPC SP8 Pickling prior to being immersed in the zinc tanks. Verification of the surface preparation shall be included in the QC documentation."

SECTION 523 BEARINGS

<u>523.051 Protective Coating</u> Revise this subsection by removing the paragraph beginning with "Anchor rods shall be galvanized…" and replacing with:

"Anchor rods shall be galvanized. When anchor rods are designated to secure bare unpainted steel or painted steel, a dielectric coating (epoxy or bituminous type coatings are acceptable) shall be applied to the anchor rod and/or adjacent steel to prevent contact between galvanized surfaces and painted or unpainted steel."

<u>523.22 Fabrication</u> Amend this subsection by adding the following: "Elastomeric Bearings shall be fabricated in accordance with AASHTO M251."

SECTION 526 CONCRETE BARRIER

Amend this section by deleting it in its entirety and replacing it with:

"526.01 Description This work shall consist of the furnishing, constructing, erecting, setting, resetting, and removal of concrete barrier and associated elements in accordance with these specifications, the Standard Details, and the lines and grades shown on the Plans or established by the Resident.

The types of concrete barrier are designated as follows:

<u>Portable Concrete Barrier Type I</u> Double faced removable barrier in accordance with the Standard Details.

Permanent Concrete Barrier Type II Double faced barrier as shown on the Plans.

<u>Permanent Concrete Barrier Type IIIa</u> Single faced barrier 32 inches high in accordance with the Standard Details or as shown on the Plans.

<u>Permanent Concrete Barrier Type IIIb</u> Single faced barrier 42 inches high in accordance with the Standard Details or as shown on the Plans.

<u>Permanent Concrete Transition Barrier</u> Barrier of various heights joining steel bridge rail to steel guardrail in accordance with the Standard Details or as shown on the Plans.

<u>Permanent Texas Classic Rail Barrier</u> Traffic rail or sidewalk rail, in accordance with the Standard Details or as shown on the Plans.

526.02 Materials

a. <u>Concrete</u> Concrete for barriers, both permanent and portable, shall have a design strength of 5,000 psi.

For cast-in-place barrier: The concrete shall be Class LP, in accordance with Standard Specification Section 502, Structural Concrete.

For precast barrier: The concrete shall meet the requirements of Standard Specification 712.061, Structural Precast Concrete Units, except that the stripping strength for precast barriers is 4,000 psi.

- b. <u>Reinforcing Steel</u> Reinforcing steel shall meet the requirements of Section 503, Reinforcing Steel.
- c. <u>Structural Steel</u> Plates and barrier connections shall meet the requirements specified in Standard Specification 504 Structural Steel and shall be hot dip galvanized after fabrication in accordance with Standard Specification 506, Shop Applied Protective Coating Steel
- d. <u>Bolts</u> Bolts shall meet the requirements specified in Section 713.02, High Strength Bolts.
- e. <u>Connecting Pins for Portable Concrete Barrier</u> Portable concrete barriers must be connected using a 1- inch diameter pin. The connecting pin must be smooth, not deformed, i.e., reinforcing bar may not be used, and shall meet the strength requirements of ASTM A449 steel. Materials with greater strength may be used with the approval of the Department.
- f. Anchor Pins for Portable Concrete Barrier Anchoring to concrete or asphalt will be required when specified on the Plans. When required, portable concrete barriers must be anchored using a 1 ½ inch diameter anchor pin. The anchor pin must be smooth, not deformed, i.e., reinforcing bar may not be used, and shall meet the strength requirements of ASTM A36 steel. Materials with greater strength may be used with the approval of the Department.
- g. <u>Device Crashworthiness</u> MaineDOT is transitioning to MASH2016 criteria for Portable Concrete Barrier on the following schedule:

New Portable Concrete Barrier shall be crash tested and/or evaluated to MASH2016 criteria.

Current Portable Concrete Barrier in useful serviceable condition that is successfully tested to NCHRP Report 350 or MASH2009 criteria may be utilized through December 31, 2029.

Other current Portable Concrete Barrier that is deemed acceptable by the Department may be utilized on projects off the National Highway System through December 31, 2024.

526.03 Construction Requirements

Cast-in-place barriers shall be fabricated in accordance with Standard Specification Section 502, Structural Concrete. Precast barriers shall be fabricated in accordance with Standard Specification 534, Precast Structural Concrete.

Concrete finish for permanent barrier shall be rubbed as defined in Standard Specification Section 502, Structural Concrete, 502.13 D2 or an approved equal.

Portable concrete barrier shall be generally free from fins and porous areas and shall present a neat and uniform appearance.

Permanent barrier shall have a protective coating applied in accordance with Standard Specification Section 515, Protective Coating for Concrete Surfaces.

Reflective delineators for concrete median barrier shall meet the requirements of Special Provision 645, Highway Signing.

Preformed Joint Filler shall meet the requirements specified in Subsection 705.01, Preformed Expansion Joint Filler.

Permissible dimensional tolerances for all concrete barriers shall be as follows:

- a. Cross-sectional dimensions shall not vary from design dimensions by more than ¼ inch. The vertical centerline shall not be out of plumb by more than ¼ inch.
- b. Longitudinal dimensions shall not vary from the design dimensions by more than $\frac{1}{4}$ inch per 10 feet of barrier section and shall not exceed $\frac{3}{4}$ inches per section.
- c. Location of anchoring holes shall not vary by more than ½ inch from the dimensions shown in the concrete barrier details on the Plans.
 - d. Surface straightness shall not vary more than ¼ inch under a 10-foot straightedge.
- e. The barrier shall have no significant cracking. Significant cracking is defined as fractures or cracks passing through the section, or any continuous crack extending for a length of 12 inches or more, regardless of position in the section.

<u>526.04 Method of Measurement</u> Permanent Concrete Barrier Type II, IIIa, IIIb, Texas Classic Rail, and Precast Median Barrier will be measured for payment by lump sum, complete in place.

Portable concrete barrier, both anchored and unanchored will be measured for payment by lump sum. Lump sum measurement will include verification of the installation and removal of all portable concrete at the completion of the Contractor's operations.

The Contractor shall replace sections of portable concrete barrier, including anchored barrier damaged by the traveling public when directed by the Resident. Replacement

sections will be measured for payment in accordance with Standard Specification 109.7, Equitable Adjustments to Compensation and Time.

Transition barrier will be measured by each, complete in place.

<u>526.05 Basis of Payment</u> The accepted quantities of Concrete Barrier Type II, IIIa, IIIb, Texas Classic Rail, and Precast Median Barrier will be paid for at the Contract lump sum price for the type specified, complete in place.

The accepted quantities of Portable Concrete Barrier Type I, both anchored and unanchored will be paid for at the Contract lump sum price. Such payment shall be full compensation for furnishing all materials, assembling, moving, resetting, transporting, temporarily storing, removing barrier, furnishing new parts as necessary, and all incidentals necessary to complete the work.

Portable barrier shall become the property of the Contractor upon completion of the use of the barrier on the project and shall be removed from the project site by the Contractor.

Transition barrier will be paid for at the Contract price each, complete in place.

The accepted quantity of all types of concrete barrier, whether portable or permanent, will be paid for at the lump sum or per each price, as applicable, which payment shall be full compensation for all materials, including reinforcing steel, protective coating, reflective delineators, steel plates and hardware, equipment, labor and incidentals required, as necessary, to complete the work.

527.02 Materials Amend this section by deleting it in its entirety and replacing it with:

"MaineDOT is transitioning to MASH2016 criteria for Work Zone Traffic Control Devices on the following schedule:

Portable Crash Cushions will be crash tested and/or evaluated to MASH2016 criteria by January 1, 2030. Current Category 3 devices in useful serviceable condition that are successfully tested to NCHRP Report 350 or MASH2009 criteria may be utilized through December 31, 2029.

Work Zone Crash Cushions shall be selected from the Department's Qualified Products List of Crash Cushions/Impact Attenuators or approved equal."

SECTION 535 PRECAST, PRESTRESSED CONCRETE SUPERSTRUCTURE

535.22 Tolerances Amend this section by deleting it in its entirety and replacing it with: "Product dimensional tolerances shall be in conformance with the latest edition of PCI MNL-135, Tolerance Manual for Precast and Prestressed Concrete Construction, as applicable to the particular product (e.g., slab, I-girder, box beam), the Plans, and this Specification. Use Box Beam fabrication tolerances for voided or solid slab beams and use Double Tee tolerances for NEXT beams. In case of dispute, the Fabrication Engineer shall determine the allowable tolerance."

535.24 Installation of Slabs, Beams, and Girders Revise the 5th paragraph by replacing "6.0 and 9.0" to "5.0 and 8.0" so it reads: "Ready mixed grout shall achieve a design compressive strength of 6,000 psi at 28 days, have an entrained air content of between 5.0 and 8.0 percent, be non-shrink, flowable, and contain a non-shrink additive listed on the Department QPL for expansive cements."

535.25, Installation of Precast/Prestressed Deck Panels Revise the 2nd paragraph by replacing "6.0 and 9.0" to "5.0 and 8.0" so it reads: "Ready mixed grout shall achieve a design compressive strength of 6,000 psi at 28 days, have an entrained air content of between 5.0 and 8.0 percent, be non-shrink, flowable, and contain a non-shrink additive listed on the Department QPL for expansive cements."

SECTION 606 GUARDRAIL

Amend this section by replacing it with the following:

<u>606.01 Description</u> This work shall consist of furnishing and installing guardrail components in accordance with these specifications and in reasonably close conformity with the lines and grades shown on the plans or as established. Guardrail is designated as:

31" W-Beam Guardrail - Mid-Way Splice

Galvanized steel w-beam, 8" wood or composite offset blocks, galvanized steel posts Thrie Beam

Galvanized steel thrie beam, 8" wood or composite offset blocks, galvanized steel posts

Median guardrail shall consist of two beams of the above types, mounted on single posts.

Bridge mounted guardrail shall consist of furnishing all labor, materials, and equipment necessary to install guardrail as shown on the plans. This work shall also include drilling for and installation of offset blocks if specified, and incidental hardware necessary for satisfactory completion of the work.

Remove and Reset and Remove, Modify, and Reset guardrail shall consist of removing the existing designated guardrail and resetting in a new location as shown on the plans or directed by the Resident. Remove, Modify, and Reset guardrail and Modify guardrail include the following guardrail modifications: Removing plate washers at all posts, except at anchorage assemblies as noted on the Standard Details, adding offset blocks, and other modifications as listed in the Construction Notes or General Notes. Modifications shall conform to the guardrail Standard Details.

Bridge Connection shall consist of the installation and attachment of beam guardrail to the existing bridge. This work shall consist of constructing a concrete end post or modifying an existing end post as required, furnishing, and installing a terminal connector, necessary hardware, and incidentals required to complete the work as shown on the plans. Bridge Transition shall consist of a bridge connection and furnishing and installing guardrail components as shown in the Standard Details.

<u>606.02 Materials</u> Materials shall meet the requirements specified in the following Sections of Division 700 - Materials:

Timber Preservative	708.05
Metal Beam Rail	710.04
Guardrail Posts	710.07
Guardrail Hardware	710.08

Guardrail components shall meet the applicable standards of "A Guide to Standardized Highway Barrier Hardware" prepared and approved by the AASHTO-AGC-ARTBA Joint Cooperative Committee, Task Force 13 Report.

Posts for underdrain delineators shall be "U" channel steel, 8 ft long, 2 ½ lb/ft minimum and have 3/8-inch round holes, 1-inch center to center for a minimum distance of 2 ft from the top of the post.

Reflectorized Flexible Guardrail Markers shall be mounted on all guardrails. A marker shall be mounted onto guardrail posts at the flared guardrail terminal end point and tangent point, both at the leading and trailing ends of each run of guardrail. The marker's flexible posts shall be gray with either silver-white or yellow reflectors (to match the edge line striping) at the tangents, red at leading ends, and green at trailing ends. Whenever the guardrail terminal is not flared, markers will only be required at the terminal end point. These shall be red or green as appropriate. Markers shall be installed on the protected side of guardrail posts unless otherwise approved by the Resident. Reflectorized flexible guardrail markers shall be from the Department's Qualified Products List of Delineators. The marker shall be gray, flexible, durable, and of a non-discoloring material to which 3-inch by 9-inch reflectors shall be applied, and capable of recovering from repeated impacts and meeting MASH 16 requirements. Reflective material shall meet the requirements of Section 719.01 for ASTM D 4956 Type III reflective sheeting. The marker shall be secured to the guardrail post with two fasteners, as shown in the Standard Details.

Reflectorized beam guardrail reflectors shall be mounted on all "w" beam guardrail and shall be either the "butterfly" type or linear delineation system panels. "Butterfly" or linear delineation panels shall be installed at approximately 62.5 foot intervals on tangents (after every tenth post) and 31.25 feet on curves (after every fifth post), and shall be centered on the guardrail beam. On Divided highways, the left-hand delineators shall be yellow and the right-hand delineators shall be silver/ white. On two-way directional highways, the right-hand side will have silver / white reflectors and no reflectorized delineator used on the left. Delineators shall have reflective sheeting that meets or exceeds the requirements of Section 719.01.

"Butterfly" reflectors shall be fabricated from high-impact, ultraviolet & weather resistant thermoplastic. Aluminum, galvanized metal or other materials shall not be used. Reflective sheeting will be applied to only one side of the delineator facing the direction of traffic and shall be centered vertically on the guardrail beam as shown in the Standard Detail 606(7).

Linear delineation system panels shall be 1.5 inches wide by approximately 11 inches nominal length, with a minimum of 5 raised lateral ridges spaced at approximately 2.25 inches. The height of each ridge shall be 0.34 inches with a 45 degree profile and a 0.28 inches radius at the top. Sheeting shall be laminated to thin gauge aluminum with a pre-applied adhesive tape on the back. Panels shall not be installed over seams or bolt heads and shall be centered horizontally on the guardrail beam; linear delineation panels shall be attached to only one guardrail beam. The guardrail beam surface shall be cleaned and prepared according to the manufacturer's instructions. Air temperature and guardrail surface temperature must be a minimum of 50 degrees F (10 C) with rising temperature at the time of installation.

Exact locations of the either the "butterfly" type or the linear delineation panels shall be approved by the Resident prior to installation.

Single wood post shall be of cedar, white oak, or tamarack, well-seasoned, straight, and sound and have been cut from live trees. The outer and inner bark shall be removed, and all knots trimmed flush with the surface of the post. Posts shall be uniform taper and free of kinks and bends.

Single steel post shall conform to the requirements of Section 710.07 b.

Single steel pipe post shall be galvanized, seamless steel pipe conforming to the requirements of ASTM A120, Schedule No. 40, Standard Weight.

Acceptable multiple mailbox assemblies shall be listed on the Department's Qualified Products List and shall be MASH 16 tested and approved.

Flared and Tangent w-beam guardrail terminals and guardrail offset blocks shall be from the Department's Qualified Products List. Flared terminals shall be installed with a 4 ft offset as shown in the Manufacturer's installation instructions.

Anchorage assemblies used to anchor trailing ends, radius guardrail, or other ends not exposed to traffic shall meet the applicable standards of "A Guide to Standardized Highway Barrier Hardware" prepared and approved by the AASHTO-AGC-ARTBA Joint Cooperative Committee, Task Force 13 Report, Drawing SEW02a.

Existing materials damaged or lost during adjusting, removing and resetting, or removing, modifying, and resetting, shall be replaced by the Contractor without additional compensation. Existing guardrail posts and guardrail beams found to be unfit for reuse shall be replaced when directed by the Resident.

606.03 Posts Posts for guardrail shall be set plumb in holes or they may be driven if suitable driving equipment is used to prevent battering and distorting the post. When posts are driven through pavement, the damaged area around the post shall be repaired with approved bituminous patching. Damage to lighting and signal conduit and conductors shall be repaired by the Contractor.

When set in holes, posts shall be on a stable foundation and the space around the posts, backfilled in layers with suitable material, thoroughly tamped.

The reflectorized flexible guardrail markers shall be set plumb with the reflective surface facing the oncoming traffic. Markers shall be installed on the protected side of guardrail posts. Markers, which become bent or otherwise damaged, shall be removed and replaced with new markers.

Single wood posts shall be set plumb in holes and backfilled in layers with suitable material, thoroughly tamped. The Resident will designate the elevation and shape of the top. The posts, that are not pressure treated, shall be painted two coats of good quality oil base exterior house paint.

Single steel posts shall be set plumb in holes as specified for single wood posts or they may be driven if suitable driving equipment is used to prevent battering and distorting the post.

Additional bolt holes required in existing posts shall be drilled or punched, but the size of the holes shall not exceed the dimensions given in the Standard Details. Metal around the holes shall be thoroughly cleaned and painted with two coats of approved aluminum rust resistant paint. Holes shall not be burned.

<u>606.04 Rails</u> Brackets and fittings shall be placed and fastened as shown on the plans. Rail beams shall be erected and aligned to provide a smooth, continuous barrier. Beams shall be lapped with the exposed end away from approaching traffic.

End assemblies shall be installed as shown on the plans and shall be securely attached to the rail section and end post.

All bolts shall be of sufficient length to extend beyond the nuts but not more than ½ inch. Nuts shall be drawn tight.

Additional bolt holes required in existing beams shall be drilled or punched, but the size of the holes shall not exceed the dimensions given in the Standard Details. Metal around the holes shall be thoroughly cleaned and painted with two coats of approved aluminum rust resistant paint. Holes shall not be burned.

<u>606.045 Offset Blocks</u> The same offset block material is to be provided for the entire project unless otherwise specified.

<u>606.05 Shoulder Widening</u> At designated locations the existing shoulder of the roadway shall be widened as shown on the plans. All grading, paving, seeding, and other necessary work shall be in accordance with the Specifications for the type work being done.

606.06 Mail Box Post Single wood post shall be installed at the designated location for the support of the mailbox. The multiple mailbox assemblies shall be installed at the designated location in accordance with the Standard Details and as recommended by the Manufacturer. Attachment of the mailbox to the post will be the responsibility of the home or business owner.

606.07 Abraded Surfaces All galvanized surfaces of new guardrail and posts, which have been abraded so that the base metal is exposed, and the threaded portions of all fittings and fasteners and cut ends of bolts shall be cleaned and painted with two coats of approved rust resistant paint.

<u>606.08 Method of Measurement</u> Guardrail will be measured by the linear foot from center to center of end posts along the gradient of the rail except where end connections are made to masonry or steel structures, in which case measurement will be as shown on the plans. When connected to radius rail, measurement will be to the end of the last tangent beam.

Guardrail terminal, reflectorized flexible guardrail marker, terminal end, anchorage assembly, bridge transition, bridge connection, multiple mailbox post, and single post will be measured by each unit of the kind specified and installed.

Widened shoulder will be measured as a unit of grading within the limits shown on the plans.

Excavation in solid rock for placement of posts will be paid under force account unless otherwise indicated in the Bid Documents.

Reflectorized beam guardrail reflectors ("butterfly" type or linear delineation system panels) when identified by pay item, will be measured for payment by each.

606.09 Basis of Payment The accepted quantities of guardrail will be paid for at the contract unit price per linear foot for the type specified, complete in place. Reflectorized beam guardrail ("butterfly"-type) delineators will not be paid for directly but will be considered incidental to guardrail items. Reflectorized flexible guardrail marker, terminal end, anchorage assembly, bridge transition, bridge connection, multiple mailbox post, and single post will be paid for at the contract unit price each for the kind specified complete in place.

Guardrail terminals will be paid for at the contract price each, complete in place which price shall be full payment for furnishing and installing all components including the terminal section, posts, offset blocks, "w" beam, cable foundation posts, plates and for all incidentals necessary to complete the installation within the limits as shown on the Standard Details or the Manufacturer's installation instructions. Pay limits for a flared terminal will be 37.5 feet. Pay limits for a tangent terminal will be 50 feet. Each guardrail terminal will be clearly marked with the Manufacturer's name and model number to facilitate any future needed repair. Such payment shall also be full compensation for furnishing all material, excavating, backfilling holes, assembling, and all incidentals necessary to complete the work, except that for excavation for posts or anchorages in solid ledge rock, payment will be made under 109.7.5 – Force Account. Type III Retroreflective Adhesive Sheeting shall be applied to the approach buffer end sections and sized to substantially cover the end section. On all roadways, the ends shall be marked with alternating black and retroreflective yellow stripes. The stripes shall be 3 in wide and sloped down at an angle of 45 degrees toward the side on which traffic is to pass the end section. Guardrail terminals shall also include a set of installation drawings supplied to the Resident.

Anchorages to bridge end posts will be part of the bridge work. Connections thereto will be considered included in the unit bid price for guardrail.

Guardrail to be placed on a radius of curvature of 150 ft or less will be paid for under the designated radius pay item for the type guardrail being placed.

Widened shoulder will be paid for at the contract unit price each complete in place and will be full compensation for furnishing and placing, grading and compaction of aggregate subbase and any required fill material.

Adjust guardrail will be paid for at the contract unit price per linear foot and will be full compensation for adjusting to grade. Payment shall also include adjusting guardrail terminals where required.

Modify guardrail will be paid for at the contract unit price per linear foot and will be full compensation for furnishing and installing offset blocks, additional posts, and other specified modifications; removing, modifying, installing, and adjusting to grade existing posts and beams; removing plate washers and backup plates, and all incidentals necessary to complete the work. Payment shall also include removing and resetting guardrail terminals where required.

Remove and Reset guardrail will be paid for at the contract unit price per linear foot and will be full compensation for removing, transporting, storing, reassembling all parts, necessary cutting, furnishing new parts when necessary, reinstalling at the new location, and all other incidentals necessary to complete the work. Payment shall also include removing and resetting guardrail terminals when required.

Remove, Modify, and Reset guardrail will be paid for at the contract unit price per foot and will be full compensation for the requirements listed in Modify guardrail and Remove and Reset guardrail.

Bridge Connections will be paid for at the contract unit price each. Payment shall include, attaching the connection to the endpost including furnishing and placing concrete and reinforcing steel necessary to construct new endposts if required, furnishing and installing the terminal connector, and all miscellaneous hardware, labor, equipment, and incidentals necessary to complete the work.

Bridge Transitions will be paid for at the contract unit price each. Payment shall include furnishing and installing the thrie beam or "w"-beam terminal connector, doubled beam section, and transition section, where called for, posts, hardware, precast concrete transition curb, and any other necessary materials and labor, including the bridge connection as stated in the previous paragraph.

No payment will be made for guardrail removed, but not reset and all costs for such removal shall be considered incidental to the various contract pay items.

Reflectorized beam guardrail reflectors ("butterfly" type and the linear delineation panels) will not be paid for directly but will be considered incidental to all new guardrail items. The Contractor shall furnish and install either the "butterfly" type or linear delineation panels, at its discretion, for new guardrail items.

Reflectorized beam guardrail reflectors (either "butterfly" type or linear delineation system panels) will be paid for under the applicable pay items for installation in conjunction with Adjust, Modify, Remove and Reset, Remove Modify and Reset guardrail items. The accepted quantity of "butterfly" type or linear delineation system panels will be paid for at the contract unit price each for all work and materials furnished to install, complete in place, including all incidentals necessary to complete the work.

Section 608.022Detectable Warning Materials Standard Revise this section by removing the last sentence of this section beginning with "Concrete..." and replacing it with "Concrete shall meet the requirements of Section 608.021, Sidewalk Materials, of this specification or may be a prepackaged concrete mix from the Department's Qualified Products List (QPL)."

SECTION 609 CURB

Remove this section in its entirety and replace with the following:

<u>609.01 Description</u> Construct or reset curb, gutter, or combination curb and gutter, paved ditch, and paved flume. The types of curb are designated as follows:

Type 1 - Stone curbing of quarried granite stone

Type 2 – Concrete Curbing

Type 3 - Bituminous curbing

Type 5 - Stone edging of quarried granite stone

<u>609.02 Materials</u> Except as provided below, the materials used shall meet the requirements of the following Sections of Division 700 - Materials:

Portland Cement and Portland Pozzolan Cement	701.01

Air Entraining Chemical Admixture	701.03
Fine Aggregate for Concrete	703.01
Coarse Aggregate for Concrete	703.02

Structural Precast Concrete Units (Concrete Curb)	712.061

The Contractor shall submit a concrete mix design for the Portland Cement Concrete to the Resident, for the uses specified below or in accordance with the Contract Documents.

Circular curb, terminal sections and transition sections shall be in reasonably close conformity with the shape and dimensions shown on the Plans and to the applicable material requirements herein for the type of curb specified.

Dowels shall be reinforcing steel deformed bars.

Concrete for Slipform Concrete Curb shall meet the requirements below:

- a. Class A, with the exception that permeability requirements shall be waived.
- b. Entrained air content of Slipform Concrete Curb shall be 4.0% to 7.0%
- c. Concrete temperature, prior to discharge, shall not exceed 90 F.
- d. Proposed mix designs may contain polypropylene fibers.
- e. Partially discharged loads may be retempered with water provided the maximum water to cement ratio is not exceeded.

609.03 Vertical Stone Curb, Terminal Section and Transition Sections and Portland Cement Concrete Curb, Terminal Sections and Transition Sections

- a. Installation The curb stone shall be set on a compacted foundation so that the front top arris line conforms to the lines and grades required. The foundation shall be prepared in advance of setting the stone by grading the proper elevation and shaping to conform as closely as possible to the shape of the bottom of the stone. The required spacing between stones shall be assured by the use of an approved spacing device to provide an open joint between stones of at least ½ inch and no greater than 5% inch.
- b. Backfilling All remaining spaces under the curb shall be filled with approved material and thoroughly hand tamped so the stones will have a firm uniform bearing on the foundation for the entire length and width. Any remaining excavated areas surrounding the curb shall be filled to the required grade with approved materials. This material shall be placed in layers not exceeding 8 inches in depth, loose measure and thoroughly tamped.

When backfill material infiltrates through the joints between the stones, small amounts of joint mortar or other approved material shall be placed in the back portion of the joint to prevent such infiltrating.

- c. Protection The curb shall be protected and kept in good condition. All exposed surfaces smeared or discolored shall be cleaned and restored to a satisfactory condition or the curb stone removed and replaced.
- d. Curb Inlets Curb placed adjacent to curb inlets shall be installed with steel dowels cemented into each stone with epoxy grout as shown in the Standard Details.

The epoxy grout shall be used in accordance with the manufacturer's instructions. The grout shall be forced into the hole, after which the dowel shall be coated with grout for one-half its length and inserted into the grout filled hole. The hole shall be completely filled with grout around the dowel. All tools and containers must be clean before using.

The Contractor may elect to substitute concrete to backfill Stone Curbing or Stone Edging at their option. If the concrete backfill option is elected, the Concrete Fill shall meet the requirements of 609.02. The Contractor shall submit a concrete design for the Portland Cement Concrete, with a minimum designated compressive strength of 3000 PSI meeting the requirements of Class S or Class Fill Concrete. The Contractor may elect to choose a Prepackaged Concrete Mix from the Departments Qualified Products list (QPL). Concrete backfill shall be completed in conformance with a Department supplied concrete backfill detail.

609.04 Bituminous Curb

- a. Preparation of Base Before placing the curb, the foundation course shall be thoroughly cleaned of all foreign and objectionable material. String or chalk lines shall be positioned on the prepared base to provide guidelines. The foundation shall be uniformly painted with tack coat at a rate of 0.04 to 0.14 gal/yd².
- b. Placing The curb shall be placed by an approved power operated extruding type machine using the shape mold called for. A tight bond shall be obtained between the base and the curb. The Resident may permit the placing of curbing by other than mechanical curb placing machines when short sections or sections with short radii are required. The resulting curbing shall conform in all respects to the curbing produced by the machine.
- c. When required, the curb shall be painted and coated with glass beads in accordance with Section 627 Pavement Marking. Curb designated to be painted shall not be sealed with bituminous sealing compound.
- d. Acceptance Curb may be accepted or rejected based on appearance concerning texture, alignment, or both. All damaged curb shall be removed and replaced at the Contractor's expense.
- e. Polyester fibers shall be uniformly incorporated into the dry mix at a rate of 0.25 percent of the total batch weight. Certification shall be provided from the supplier with each shipment meeting the following requirements:

Average Length $0.25 \text{ inches} \pm 0.005$ Average Diameter $0.0008 \text{ inches} \pm 0.0001$

Specific Gravity 1.32-1.40

Melting Temperature 480 °F Minimum

609.05 Slipform Concrete Curb

a. Preparation of Base Before placing the curb, the foundation course shall be thoroughly cleaned of all foreign and objectionable material. The Contractor shall not place Slipform Concrete Curb on a wet or frozen foundation. The foundation (HMA or concrete) may be in a Saturated Surface Dry condition, but no standing water shall be allowed. String or chalk lines shall be positioned on the prepared foundation to provide guidelines. Prior to placing the curb, the foundation shall be uniformly coated with an epoxy resin adhesive that

meets the requirements of AASHTO M 235, Type I, II, III, IV or V and has been tested by AASHTO Product Evaluation & Audit Solutions. The Contractor shall submit the epoxy resin adhesive that they propose to utilize with the concrete mix design. The epoxy resin adhesive must be approved prior to placement and used in accordance with manufacturer's recommendations.

- b. Placing Concrete shall be placed with an approved Slipform machine that will produce a finished product according to the design specified in the Plans. For cold weather slip forming, the outside temperature must be at least 36°F and rising. The curb shall be placed on a firm, uniform foundation, shall conform to the section profile specified in the Plans, and shall match the appropriate grade. Expansion joints shall be placed in the curb where it meets rigid structures such as but not limited to building foundations, catch basin headers or fire hydrants. Contraction joints will be placed at 10-foot intervals using sawing methods, which shall cut 1 to 3 inches into the concrete. Contraction joints shall be cut between 1 and 7 days after placement of the concrete. Joints shall be constructed perpendicular to the subgrade and match other joints in roadways, sidewalks, or other structures when applicable.
- c. Curing and Sealing Proper curing shall be provided using either a combination curing/sealing compound spray that meets ASTM 1315 Type 1-Class A, or a curing compound spray that meets ASTM 309 Type 1-D Class A. Curing may also be accomplished by the methods specified in Standard Specification Section 502.14, Curing Concrete.

If a combination curing/sealing compound spray is not used, a separate sealing compound from the MaineDOT Qualified Products List for a Type 1c sealer shall be applied after the concrete has cured.

- d. Protection Slipform curb must be adequately protected after placement. The concrete shall be allowed to cure for at least 72 hours. During cold weather conditions, when temperatures drop below the required temperature of 36°F after placement, curbing shall be protected by concrete blankets or a combination of plastic sheeting and straw. After any placement of Slipform curb, regardless of weather conditions, the placed curb shall be adequately protected by traffic control devices as necessary.
 - e. Marking When required, the curb shall be painted and coated with glass beads in accordance with Section 627 Pavement Marking. Curb designated to be painted shall not be sealed unless a combination curing/sealing compound is used.
 - <u>f. Acceptance</u> Curb shall be accepted or rejected based on finish, alignment, entrained air content, and compressive strength. Concrete Quality Control and Acceptance shall be done in accordance with Standard Specification Section 502, Method C. All damaged curb shall be removed and replaced at the Contractor's expense.

609.06 Stone Edging The curb shall be installed, backfilled and protected in accordance with Section 609.03, except as follows:

a. Slope The edging shall be set on a slope as shown on the Plans or as directed.

b. Joints Joints shall be open and not greater than 1½ inch in width.

609.07 Stone Bridge Curb

a. Installation Each stone and the bed upon which it is to be placed shall be cleaned and thoroughly wetted with water before placing the mortar for bedding and setting the stone. The stone shall be set on a fresh bed of joint mortar and well bedded before the mortar has set so that the front top arris line conforms to the line and grade required. Whenever temporary supporting wedges or other devices are used in setting the stones, they shall be removed before the mortar in the bed has become set, and the holes left by them shall be filled with mortar. Concrete behind the stones shall not be placed until the stones have been in place at least two days. Bedding and pointing mortar for joints shall be cured as required under Section 502 - Structural Concrete.

<u>b. Joints</u> Vertical joints shall be ½ inch in width plus or minus ⅓ inch. Whenever possible, the face and top of the joint shall be pointed with joint mortar to a depth of 1½ inch, before the bedding mortar has set. Joints which cannot be so pointed, shall be prepared for pointing by raking them to a depth of 1½ inch before the mortar has set. Joints not pointed at the time the stone is laid shall be thoroughly wetted with clean water and filled with mortar. The mortar shall be well driven into the joint and finished with an approved pointing tool, flush with the pitch line of the stones.

609.08 Resetting Stone or Portland Cement Concrete Curb, Including Terminal Sections and Transitions

The curb shall be installed, backfilled and protected in accordance with Section 609.03, except as follows:

<u>a. Removal of Curbing</u> The Contractor shall carefully remove and store curb specified on the Plans or designated for resetting. Curb damaged or destroyed, because of the Contractor's operations or because of their failure to store and protect it in a manner that would prevent its loss or damage, shall be replaced with curbing of equal quality at the Contractor's expense.

<u>b. Cutting and Fitting</u> Cutting or fitting necessary in order to install the curbing at the locations directed shall be done by the Contractor.

609.09 Method of Measurement Curb, both new and reset, will be measured by the linear foot along the front face of the curb at the elevation of the finished pavement, complete in place and accepted. Curb inlets at catch basins, including doweling, will not be measured for payment but shall be considered included in the cost of the catch basin. New transition sections and terminal curb will be measured by the unit. Reset transition sections and terminal curb will be included in the measurement for resetting curb.

Concrete Slipform Curb and terminal ends will be measured by the linear foot along the front face of the curb at the elevation of the finished pavement, complete in place and accepted.

<u>609.10 Basis of Payment</u> The accepted quantities of curbing will be paid for at the contract unit price per linear foot for each kind and type of curbing as specified.

Payment for terminal curb shall include only that portion of the curbing modified for installation at ends of curb runs shown in the Standard Details. Curb adjacent to terminal ends shall be paid for at the contract unit price per linear foot for the type of curb installed.

Vertical Curb Type 1 is required to have a radius of 60 feet or less, will be paid for as Vertical Curb Type 1 - Circular.

Curb, Type 5 required to have a radius of 30 feet or less will be paid for as Curb Type 5 - Circular.

There will be no separate payment for concrete fill, mortar, reinforcing steel, anchors, tack coat, drilling for and grouting anchors, pointing and bedding of curbing, and for cutting and fitting, but these will be considered included in the work of the related curb.

Removal of existing curb and necessary excavation for installing new or reset curbing will not be paid for directly but shall be considered to be included in the appropriate new or reset curb pay item. Base and Subbase material will be paid for under Section 304 - Aggregate Base and Subbase Course. Backing up bituminous curb is incidental to the curb items. Loam, as directed, will be paid under 615 – Loam.

619.03 General Amend this Section by adding the following sentence to the end: "Straw mulch shall be used in all wetland areas."

SECTION 626

FOUNDATIONS, CONDUIT, AND JUNCTION BOXES FOR HIGHWAY SIGNING, LIGHTING, AND SIGNALS

<u>Section 626.021 Miscellaneous Materials</u> Revise this section by removing the fourth paragraph beginning with "All Concrete for concrete encasement..." and replace it with "All concrete for concrete encasement of conduit shall be Class S or Class Fill concrete in accordance with the applicable requirements of Section 502 – Structural Concrete, or a Prepackaged Concrete Mix from the Department's Qualified Products List (QPL)."

Section 626.031Conduit Revise the fifth paragraph beginning with "After the trench has been..." by removing the last sentence beginning with "Where concrete encasement..." and replacing it with "Where concrete encasement is required around the conduit, the concrete shall meet Class S, Class Fill in accordance with the applicable requirements of Section 502 – Structural Concrete, or a Prepackaged Concrete Mix from the Department's Qualified Products List (QPL)."

<u>626.034 Concrete Foundations</u> Revise this Section by changing '626.037' to '**626.036**' in the Second Paragraph which begins with "Foundations shall consist of cast-in-place...".

Revise the 10th paragraph beginning with "Before placing concrete, the required elbows..." by removing "...in accordance with Standard Specification 633."

<u>626.036 Precast Foundations</u> Revise the last sentence of paragraph one so that it reads: "Construction of precast foundations shall conform to the Standard Details and all requirements of 712.061."

SECTION 627 PAVEMENT MARKINGS

627.02 Materials Amend this section by adding the following to the existing Specification:

"When pavement marking paint must be applied on pavement with an air temperature between 35 °F and 50 °F, a low temperature waterborne paint may be used upon the Department's approval as noted below.

The Contractor shall submit the following information for Department review and approval at least 10 calendar days prior to application:

The manufacturer and product name of the low temperature waterborne paint

The manufacturer's technical product data sheets

The product's SDS sheets

All required and recommended application specifications for the product

The manufacturer's requirements for temperature, surface preparation, paint thickness and the bead application shall be followed. No additional payment will be made for the use of low temperature waterborne paint. "

<u>627.06 Application</u> Revise this subsection by replacing the paragraph beginning with "On other final pavement markings…" with the following:

"On other final pavement markings and on curb, where the paint is applied by hand painting or spraying, application shall be one uniform covering coat at least 16 mils thick. Before the paint has dried, the glass beads shall be applied by a pressure system that will force the glass beads onto the undried paint as uniformly as possible.

Painted lines and markings shall be applied in accordance with the manufacturer's published recommendations. These recommendations will be supplied to the Resident prior to installation."

Revise this subsection by replacing the paragraph beginning with "If the final reflectivety values are less..." with the following:

The final reflectivity will be acceptable if 90 percent or more of the painted pavement lines and markings meet the specified minimum value. If less than 90 percent of the painted pavement lines and markings meet the specified minimum final reflectivity values, the Contractor shall repaint those areas not meeting required reflectivity at no cost to the Department.

If, after repainting, analysis of the final reflectivity values results in the need for a second repainting, the Contractor will submit in writing a plan of action to meet the reflectivity minimums prior to continuing any work. Once the plan has been reviewed and approved by the Department, the Contractor shall reapply at no cost to the Department.

SECTION 637 DUST CONTROL

Revise this section by removing it in its entirety.

SECTION 643 TRAFFIC SIGNALS

<u>643.021 Materials</u> Amend this subsection by adding the following at the end:

"MaineDOT is transitioning to MASH2016 criteria for Work Zone Traffic Control Devices on the following schedule:

Temporary Traffic Control Signals will be crash tested and/or evaluated to MASH2016 criteria by January 1, 2030. Current Category 4 devices in useful serviceable condition that are successfully tested to NCHRP Report 350 or MASH2009 criteria may be utilized through December 31, 2029."

643.023 Traffic Signal Structures Remove the third paragraph and replace it with the following:

"Traffic signal support structures shall be classified as Fatigue Category III if they are located on roads with a speed limit of 35 mph or less, Fatigue Category II if they are located on roads with a speed limit of greater than 35 mph, and Fatigue Category I if noted on the Contract Plans. Fatigue Importance Factors shall be as specified in Table 11.6-1 (Fatigue Importance Factors). Fatigue analyses are not required for span-wire (strain) pole traffic signal support structures with heights of 55 feet or less unless required by the current edition of AASHTO "LRFD Specifications for Structural Supports for Highway Signs, Luminaires, and Traffic Signals".

643.09 Service Connection Revise this subsection by removing the paragraph that begins with "Traffic signal services shall have...".

And by removing the paragraphs beginning with "A service ground rod shall be installed..." and "A total of 4, 10' service..." and replace them with "A total of 4, 10' service ground rods shall be installed and properly connected together on the outside of the cabinet foundation. One ground rod shall be located at each corner and shall be either flush or slightly below finished grade. The connection between the ground rod and the ground wire shall be an exothermic connection such as a Cadweld. The ground wire from the interconnected ground rods shall be routed through a conduit in the foundation and into the base of the cabinet".

SECTION 645 HIGHWAY SIGNING

<u>Section 645.023 Sign Support Structures</u>. Under letter "c.", revise the fifth paragraph beginning with "In addition to the required details..." by removing the words "and foundation" from the 5th sentence.

<u>Section 645.08 Method of Measurement</u>. Revise the second paragraph beginning with "Bridge-type, cantilever and…" by removing the words "**including the foundation**".

<u>Section 645.09 Basis of Payment</u>. Revise the third paragraph beginning with "The accepted bridge-type, cantilever and..." by removing the word "**foundation**" from the second sentence. Add the following sentence to the end of the paragraph "**Conduits, Junction Boxes, and Foundations will be paid for under Section 626.**"

SECTION 652 MAINTENANCE OF TRAFFIC

652.2.5 Portable Changeable Message Sign Revise the fifth paragraph so it reads:

"The control system shall include a display screen upon which messages can be reviewed before being displayed on the message sign. The control system shall be capable of maintaining memory when power is unavailable. Messages must be changeable with either a portable electronic device like a notebook computer or an on-board keypad. The controller shall have the capability to store a minimum of 200 user-defined and 200 pre-programmed messages. Controller and battery compartments shall be enclosed in lockable, weather-tight boxes. The cabinet shall be locked at all times that the Contractor is not actively changing the message. The Contractor shall change the password for the controller prior to stationing the PCMS and shall provide the password to the Resident. The password shall be unique per PCMS and secure and shall not be written anywhere in, on, around, or stored in the PCMS."

Amend this Section by adding the following new subsection:

<u>"652.2.6 Device Crashworthiness</u> MaineDOT is transitioning to MASH2016 criteria for Work Zone Traffic Control Devices on the following schedule:

Category 1 (Cones, Drums, Tubular Markers, Flexible Delineators, and similar devices that have little chance if causing windshield penetration, tire damage, or other significant effect on the control or trajectory of a vehicle) – All Category 1 devices will be manufacturer self-certified as MASH2016 by January 1, 2025. Current Category 1 devices in useful serviceable condition that are not self-certified as MASH2016 compliant may be utilized through December 31, 2024.

Category 2 (Barricades, Portable Sign Supports, Category 1 devices with attachments, and similar devices that are not expected to produce significant vehicular velocity change but may be otherwise hazardous) – All Category 2 devices will be crash tested and/or evaluated to MASH2016 criteria by January 1, 2025. Current Category 2 devices in useful serviceable condition that are successfully tested to NCHRP Report 350 or MASH2009 criteria may be utilized through December 31, 2024.

Category 3 (Portable Concrete Barrier, Portable Crash Cushions, Truck Mounted Attenuators, Category 2 devices weighing more than 100 pounds, and similar devices that are expected to produce significant vehicular velocity change or other harmful reactions) – All Category 3 devices will be crash tested and/or evaluated to MASH2016 criteria by January 1, 2030. Current Category 3 devices in useful serviceable condition that are successfully tested to NCHRP Report 350 or MASH2009 criteria may be utilized through December 31, 2029. (See Standard Specification 526 for additional Portable Concrete Barrier information).

Category 4 (Trailer Mounted Devices: Arrow Boards, Temporary Traffic Control Signals, Area Lighting, Portable Changeable Message Sign, and other similar devices.) – All Category 4 devices will be crash tested and/or evaluated to MASH2016 criteria by January 1, 2030. Current Category 4 devices in useful serviceable condition that are successfully tested to NCHRP Report 350 or MASH2009 criteria may be utilized through December 31, 2029."

652.3.3 Submittal of Traffic Control Plan Amend this section by adding:

"n. A security plan for any PCMS shall be included. The Contractor shall provide a plan for secure access to the PCMS and protection from unauthorized users. The plan shall have details on securing the cabinets via a lock and password from unauthorized users, password changing protocols, and where the access information will be kept so it can be used in the event of emergency. The Contractor shall not Identify or store passwords in the TCP."

<u>652.4 Flaggers</u> Revise the first paragraph of this section so that it reads:

"The Contractor shall furnish flaggers as required by the TCP or as otherwise specified by the Resident. All flaggers must have successfully completed a flagger test approved by the Department and administered by a Department-approved Flagger-Certifier who is employing that flagger. All flaggers must carry an official certification card with them while flagging that has been issued by their employer."

SECTION 681 PRECAST AGGREGATE-FILLED, CONCRETE BLOCK GRAVITY WALL

<u>681.08 Basis of Payment</u> Amend this section by adding the Item Number "**681.10**" in front of the item "Precast Aggregate-Filled Concrete Block Gravity Wall" at the end of the section.

SECTION 701 STRUCTURAL CONCRETE RELATED MATERIAL

701.01 Portland Cement and Portland Pozzolan Cement Amend the first sentence of Paragraph 3 by adding "or Type 1L Portland Limestone cement" so that it reads:

"A Type IP (MS) Portland-pozzolan cement (blended hydraulic cement with moderate sulfate resistance) or Type 1L Portland Limestone cement meeting the requirements of AASHTO M 240, may be used instead of Type II or where Type I Portland cement, meeting the requirements of AASHTO M 85, is allowed."

SECTION 703 AGGREGATES

Add the following to Section 703 - Aggregates

703.01 Fine Aggregate for Concrete Fine aggregate for concrete shall consist of natural sand or, when approved by the Resident, other inert materials with similar characteristics or combinations thereof, having strong, durable particles. Fine aggregate from different sources of supply shall not be mixed or stored in the same pile nor used alternately in the same class of construction or mix without permission of the Resident.

All fine aggregate shall be free from injurious amounts of organic impurities. Should the fine aggregate, when subjected to the colorimetric test for organic impurities, AASHTO T 21, produce a color darker than the reference standard color solution (laboratory designation Plate III), the fine aggregate shall be rejected.

Fine aggregate shall have a sand equivalent value of not less than 75 when tested in accordance with AASHTO T 176.

Fine aggregate sources shall meet the Alkali Silica Reactivity (ASR) requirements of Section 703.0201.

The fineness modulus shall not be less than 2.26 or more than 3.14. If this value is exceeded, the fine aggregate will be rejected unless suitable adjustments are made in proportions of coarse and fine aggregate. The fineness modulus of fine aggregate shall be determined by adding the cumulative percentages of material by weight retained on the following sieves: Nos. 4, 8, 16, 30, 50, 100 and dividing by 100.

Fine aggregate, from an individual source when tested for absorption as specified in AASHTO T 84, shall show an absorption of not more than 2.3 percent.

703.02 Coarse Aggregate for Concrete Coarse aggregate for concrete shall consist of crushed stone or gravel having hard, strong, durable pieces, free from adherent coatings and of which the composite blend retained on the 3/8 inch sieve shall contain no more than 15 percent, by weight of flat and elongated particles when performed in accordance with test method ASTM D 4791, Flat Particles, Elongated Particles, or Flat and Elongated Particles in Coarse Aggregate, using a dimensional ratio of 1:5.

The coarse aggregate from an individual source shall have an absorption no greater than 2.0 percent by weight determined in accordance with AASHTO T 85 modified for weight of sample.

The composite blend shall have a Micro-Deval value of 18.0 percent or less as determined by AASHTO T 327 or not exceed 40 percent loss as determined by AASHTO T 96.

Coarse aggregate sources shall meet the Alkali Silica Reactivity (ASR) requirements of Section 703.0201.

Coarse aggregate shall conform to the requirements of the following table for the size or sizes designated and shall be well graded between the limits specified.

703.0201 Alkali Silica Reactive Aggregates All coarse and fine aggregates proposed for use in concrete shall be tested for Alkali Silica Reactivity (ASR) potential under AASHTO T 303 (ASTM C 1260), Accelerated Detection of Potentially Deleterious Expansion of Mortar Bars Due to Alkali-Silica Reaction, prior to being accepted for use. Acceptance will be based on testing performed by an accredited independent lab submitted to the Department. Aggregate submittals will be required on a 5-year cycle, unless the source or character of the aggregate in question has changed within 5 years from the last test date.

As per AASHTO T 303 (ASTM C 1260): Use of a particular coarse or fine aggregate will be allowed with no restrictions when the mortar bars made with this aggregate expand less than or equal to 0.10 percent at 30 days from casting. Use of a particular coarse or fine aggregate will be classified as potentially reactive when the mortar bars made with this aggregate expand greater than 0.10 percent at 30 days from casting. Use of this aggregate will only be allowed with the use of cement-pozzolan blends and/or chemical admixtures that result in mortar bar expansion of less than 0.10 percent at 30 days from casting as tested under ASTM C 1567.

Acceptable pozzolans and chemical admixtures that may be used when an aggregate is classified as potentially reactive include, but are not limited to the following:

- a. Class F Coal Fly Ash meeting the requirements of AASHTO M 295
- b. Ground Granulated Blast Furnace Slag (Grade 100 or 120) meeting the requirements of AASHTO M 302
- c. Densified Silica Fume meeting the requirements of AASHTO M 307
- d. Lithium-based admixtures
- e. Metakaolin

Pozzolans or chemical admixtures required to offset the effects of potentially reactive aggregates will be incorporated into the concrete at no additional cost to the Department.

703.05 Aggregate for Sand Leveling Aggregate for sand leveling shall be sand of hard durable particles free from vegetable matter, lumps or balls of clay and other deleterious substances. The aggregate shall meet the grading requirements of the following table.

703.06 Aggregate for Base and Subbase The following shall apply to Sections (a.) and (c.) below. The material shall have a Micro-Deval value of 25.0 or less as determined by AASHTO T 327. If the Micro- Deval value exceeds 25.0, the Washington State Degradation DOT Test Method T113, Method of Test for Determination of Degradation Value (January 2009 version) shall be performed, except that the test shall be performed on the portion of the sample that passes the ½ in sieve and is retained on the No. 10 sieve. If the material has a Washington Degradation value of less than 15, the material shall be rejected.

The material used in Section (b.) below shall have a Micro-Deval value of 25.0 or less as determined by AASHTO T 327. If the Micro-Deval value exceeds 25.0 the material may be used if it does not exceed 25 percent loss on AASHTO T 96, Resistance to Degradation of Small-Size Coarse Aggregate by Abrasion and Impact in the Los Angeles Machine.

Recycled Asphalt Pavement (RAP) shall not be used for or blended with aggregate base or subbase.

a. Aggregate for base, Type A and B shall be crushed ledge or crushed gravel of hard durable particles free from vegetable matter, lumps or balls of clay and other deleterious substances. The gradation of the part that passes a 3 inch sieve shall meet the grading requirements of the following table:

At least 50 percent by weight of the material retained on the No. 4 sieve shall have at least one fractured face as tested by AASHTO T 335.

Type A aggregate for base shall only contain particles of rock that will pass the 2 inch square mesh sieve.

Type B aggregate for base shall only contain particles of rock that will pass the 4 inch square mesh sieve.

b. Aggregate for base, Type C shall be crushed ledge or crushed gravel of hard durable particles free from vegetable matter, lumps or balls of clay and other deleterious substances. The material shall meet the grading requirements of the following table:

At least 50 percent by weight of the material coarser than the No. 4 sieve shall have at least one fractured face as tested by AASHTO T 335.

c. Aggregate for subbase shall be sand or gravel of hard durable particles free from vegetable matter, lumps or balls of clay and other deleterious substances. The gradation of the part that passes a 3 inch sieve shall meet the grading requirements of the following table:

Type D aggregate for subbase gravel may contain up to 50 percent by weight Recycled Concrete Aggregate (RCA). When RCA is used, the portion of the resulting blend of gravel and RCA retained on a ½" square mesh sieve shall contain a total of no more than 5 percent by weight of other recycled materials such as brick, concrete masonry block, or asphalt pavement as determined by visual inspection.

RCA shall be substantially free of wood, metal, plaster, and gypsum board as defined in Note 9 in Section 7.4 of AASHTO M 319. RCA shall also be free of all substances that fall under the category of solid waste or hazardous materials.

Aggregate for subbase shall not contain particles of rock which will not pass the 6 inch square mesh sieve.

703.08 Recycled Asphalt Pavement Recycled asphalt pavement shall consist of salvaged asphalt materials from milled pavements or production waste that has been processed before use to meet the requirements of the job mix formula. It shall be free of winter sand, granular fill, construction debris, or other materials not generally considered asphalt pavement.

<u>703.081 RAP for Asphalt Pavement</u> Recycled Asphalt Pavement (RAP) may be introduced into hot-mix asphalt pavement at percentages approved by the Department according to the MaineDOT Policies and Procedures for HMA Sampling and Testing.

If approved by the Department, the Contractor shall provide documentation stating the source, test results for average residual asphalt content, and stockpile gradations showing RAP materials have been sized to meet the maximum aggregate size requirements of each mix designation. The Department will obtain samples for verification and approval prior to its use.

The maximum allowable percent of RAP shall be determined by the asphalt content, the percent passing the 0.075 mm sieve, the ratio between the percent passing the 0.075 mm sieve and the asphalt content, and Coarse Micro-Deval loss values as tested by the Department.

The maximum percentage of RAP allowable shall be the lowest percentage as determined according to Table 4 below:

The Department will monitor RAP asphalt content and gradation during production by testing samples from the stockpile at approximately 15,000 T intervals (in terms of mix production). The allowable variance limits (from the numerical average values used for mix designs) for this testing are determined based upon the maximum allowable RAP percentage and are shown below in Table 5.

For specification purposes, RAP will be categorized as follows:

Class III – A maximum of 10.0 percent of Class III RAP may be used in any base, intermediate base, surface, or shim mixture. A maximum of 20.0 percent of Class III RAP may be used in hand-placed mixes for item 403.209.

Class II – A maximum of 20.0 percent Class II RAP in any base, binder, surface, or shim course. Class I – A maximum of 20.0 percent Class I RAP may be used in any base, intermediate base, surface, or shim mixture without requiring a change to the specified asphalt binder. A maximum of 30.0 percent Class I RAP may be used in in any base or intermediate base mixture provided that a PG 58-28 or PG 58-34 asphalt binder is used. A maximum of 30.0 percent Class I RAP may be used in any surface or shim mixture provided that PG 58-34 asphalt binder is used. Mixtures exceeding 20.0 percent Class I RAP must be evaluated and approved by the Department.

The Contractor may use up to two different RAP sources in any one mix design. The total RAP percentage of the mix shall not exceed the maximum allowed for the highest classification RAP source used (i.e. if a Class I & Class III used, total RAP must not exceed 30.0%). The blended RAP material must meet all the requirements of the classification for which the RAP is entered (i.e. 10% Class III with 20% Class I, blend must meet Class I criteria). The Department may take belt cuts of the blended RAP to verify the material meets these requirements. If the Contractor elects to use more than one RAP source in a design, the Contractor shall provide an acceptable point of sampling blended RAP material from the feed belt.

In the event that RAP source or properties change, the Contractor shall notify the Department of the change and submit new documentation stating the new source or properties a minimum of 72 hours prior to the change to allow for obtaining new samples and approval.

SECTION 709 REINFORCING STEEL AND WELDED STEEL WIRE FABRIC

709.01 Reinforcing Steel Remove the second paragraph of Section 709.01 of the standard specification beginning with "Low-Carbon, Chromium,..." and replace with the following:

"Low-carbon, chromium, reinforcing steel shall be deformed bars conforming to the requirements of ASTM A1035. Bars shall be Grade 100 and alloy Type CS unless otherwise specified on the Plans."

SECTION 710 FENCE AND GUARDRAIL

710.06 Fence Posts and Braces Revise the first Paragraph so that it reads:

"Wood posts shall be of cedar, white oak, or tamarack or other AWPA approved species, of the diameter or section and length shown on the plans."

Remove the fourth paragraph which starts "That portion of wood posts...".

Revise the paragraph beginning with "Braces shall be of spruce, eastern hemlock ... so that it now reads:

"Braces shall be of spruce, eastern hemlock, Norway pine, pitch pine, or tamarack timbers or other AWPA approved species, or spruce, cedar, tamarack or other AWPA approved species round posts of sufficient length to make a diagonal brace between adjacent posts. All wood posts and braces shall be pressure-treated in accordance with AASHTO M 133 and AWPA U1, UC4A Commodity Specification B: Posts."

710.07 Guardrail Posts Revise this section so that the first sentence of section a. reads:

"a. Wood posts shall be of Norway pine, southern yellow pine, pitch pine, Douglas fir, red pine, white pine, or eastern hemlock or other AWPA approved species."

Revise the next paragraph so that it reads:

Wood posts and offset brackets shall be preservative treated in accordance with the requirements of AASHTO M 133 and AWPA U1, UC4A Commodity Specification B: Posts.

710.08 Guardrail Hardware Revise this subsection by replacing "AASHTO M 298" with "ASTM B695"

<u>SECTION 711</u> MISCELLANEOUS BRIDGE MATERIAL

711.06 Stud Shear Connector Anchors and Fasteners Amend this section by deleting it in its entirety and replacing it with:

"Shear connectors shall meet the dimensional tolerances of Figure 9.1 of the ANSI/AASHTO/AWS D1.5 Bridge Welding Code (D1.5 Code). Shear connectors, anchors and fasteners shall meet the material requirements of Section 9 of the D1.5 Code. Shear connectors shall meet the mechanical property requirements of Table 9.1, Type B of the D1.5 Code. Anchors and fasteners shall meet the mechanical property requirements of Table 9.1 of the D1.5 Code, Type A."

SECTION 712 MISCELLANEOUS HIGHWAY MATERIAL

<u>712.061 Structural Precast Units</u> Amend this section by adding the following sentence to the end of the first paragraph of the <u>Construction</u> subsection:

"Facilities certified by NPCA or PCI shall provide to the Fabrication Engineer a copy of their annual audit to include deficiency reports and corrective actions."

Revise this section by changing the letter "b" of ASTM C1611 of the <u>Concrete Testing</u> subsection so that it reads:

"b. Air content shall be 5.0% to 8.0%."

SECTION 713 STRUCTURAL STEEL AND RELATED MATERIAL

Section 713.02 High Strength Bolts

Revise the second sentence of this subsection so that it reads "Nuts shall meet the requirement of ASTM A563". Revise the third sentence of this subsection so that it reads "Circular and beveled washers shall conform to the requirement of ASTM F436".

SECTION 718 TRAFFIC SIGNALS MATERIAL

718.03 Signal Mounting Amend the paragraph beginning with "All trunions, brackets and..." by adding "For polycarbonate signal heads with more than 3 sections or requiring mounting extensions greater than 12 inches in length, reinforcing plates shall be used to reinforce the housings at the point of attachment." to the end of the paragraph.

718.08 Controller Cabinet Revise this subsection by replacing the paragraph beginning with "The cabinet shall be supplied with LED light panels..." on or about page 7-66 with "The cabinet shall be supplied with white LED light panels which shall automatically illuminate via a door open switch whenever one of the four main cabinet doors are opened for the ground mount cabinet or two main doors for the side of pole cabinet. The ground mounted cabinet shall contain four LED light panels per side totaling eight panels for the cabinet; one panel each at the top and bottom portion of the front side and back side on the Control side and Power/Auxiliary side of the cabinet. Each light panel shall produce a minimum of 250 lumens for a total minimum lumen output of 2000 lumens with all eight panels illuminated. The minimum output per side would be 1000 lumens. The LED panels shall be protected by a clear shatterproof shield. The side of pole mounted cabinet shall contain four light panels; one at the top of the rack assembly and one at the bottom rack assembly on each side of the cabinet.

A second door open status switch per door shall activate a controller input to log a report event that one of the doors was opened. All door open status switches shall be connected to the same controller input. For the ground mount cabinet, there shall be two switches on each of the four main doors. For the side-of-pole mount cabinet, there shall be two switches on each of the two main doors."

Revise this subsection by replacing the paragraph beginning with "The cabinet shall be supplied with a generator panel ..." on or about page 7-68 with:

"The cabinet shall be supplied with a generator panel. The generator panel shall consist of a manual transfer switch and a twist-lock connector for generator hookup. The transfer switch knob and twist-lock connector shall be located inside a stainless steel enclosure with a separate lockable door accessed with a Corbin #2 key. The unit shall be mounted on the left, exterior of the control side wall of the ground mount cabinet a minimum of 36" above the surrounding grade and on the lower left side of the pole mounted cabinet. The generator transfer switch shall be a Reliance C30A1N Signa Series or approved equal. "

Revise this subsection by removing the following from the paragraph beginning with "The ground mounted cabinet shall be supplied and installed with an electric service meter socket trim and electrical service disconnect switch ..." on or about page 7-69: "(removed: thus preventing that space from being used either by equipment supplied as part of the project, or future equipment that would be installed in the rack system. Joe indicated that he would add this language to the detail so it is covered.)".

Revise this subsection by replacing the following in the paragraph beginning with "The Contractor shall reconfigure the default user name..." on or around page 7-70; "MaineDOT IT" with "MaineDOT Traffic Division".

In the paragraph beginning with "Tests shall be conducted by the contractor..." on or around page 7-73, amend this subsection by removing "in the state of Maine and" after "The facility shall be".

Amend this Section by adding the following subsection:

<u>718.13 Field Monitoring Unit (FMU)</u> This item of work shall conform to this specification. This item shall consist of furnishing and installing a Field Monitoring Unit (FMU) and software, as well as all needed accessories required for a full and complete installation, including but not limited to power adapters, Ethernet cables, and interface cables, as described herein.

Where applicable, communications from MaineDOT's cloud-based Central Management System (CMS) to the on-street traffic signal controllers shall be made through fiber optic interconnect cable connected back to existing internet connections and/or the Field Monitoring Unit (FMU). The Contractor shall furnish and install all materials necessary for a complete and operational fiber optic interconnection to all project intersections as shown on the plans. All connections to the CMS cloud-based system shall be via a secure VPN network.

The FMU shall be the only remote connection device used by isolated intersections to connect to the cloud-based system. All connections shall be encrypted VPN tunnels. The Contractor shall coordinate all configuration settings with MaineDOT IT and the Engineer.

The FMU central web based interface shall be a separate element from the CMS.

MATERIALS: The materials for this work shall conform to the following requirements:

- 1. The work under this item specifies the requirements for the FMU. The FMU shall operate independent of the brand/type of intersection controller deployed in the ATC traffic cabinet.
- 2. The FMU shall conform to the following requirements:
 - 2.1 The FMU shall function correctly between -34 degrees C and +74 degrees C.
 - 2.2 The FMU shall be provided with appropriately rated connectors that allows the FMU to be exchanged by unplugging connectors, without tools.
 - 2.3 The FMU shall monitor and log all ATC Controller and ATC cabinet faults and or alarms.
 - 2.4 The FMU shall be wired directly to the ATC cabinet.
 - 2.5 The FMU shall have an internal cellular modem running at 4G LTE.
 - 2.5.1 The Cellular modem shall be designed to be replaced / upgraded to 5G service when available.
 - 2.6 The FMU shall incorporate an integrated GPS and cell modem.
 - 2.7 The configuration of the FMU shall be accomplished by accessing the internal web server with a browser. It shall be possible to configure the FMU without any special software.

- 2.8 The FMU shall be powered via a standard 120V input power.
- 2.9 The FMU shall allow for the routing of the controller configuration packets to and from the controller (either by Ethernet or serial communications) for any type of controller utilized by the MaineDOT. In this way it shall be possible to configure the controller and utilize the controller specific software to interrogate the controller, and the FMU shall provide the communications pipe which allows this to be accomplished.
- 2.10 The FMU shall, within the size limitations above, include a battery and battery charging/monitoring circuit, to allow the FMU to function correctly even when all power to the intersection has failed. The battery shall continue to power the FMU for a minimum of 5 hours after all power has failed to the intersection.
- 2.11 The FMU shall incorporate an integrated GPS which will allow the FMU to geolocate itself on the FMU management software map, without configuration.
- 2.12 The FMU shall operate without requiring a static IP address. The only configuration required at the FMU is to enter the URL of where the FMU management software is hosted.
- 2.13 In the event that the cell service is interrupted or is not available, the FMU shall store any events that occur in internal memory and forward these events automatically to the FMU management software when the cell service is restored. In this way, a complete record of events at the device can be maintained even if cell service is interrupted for a period. The system will store 5000 events.
- 2.14 The FMU shall utilize HTTP and HTTPS protocols, and XML data structures, for communication with the FMU management software. In this way the data will be open for future expansion and competition. The use of secret proprietary protocols is not permitted.
- 2.15 The FMU shall include Ethernet communications via an Ethernet Port with RJ45 connector.
- 2.16 The FMU shall include weather proof antennas.

3. Map Display FMU Management Software

- 3.1 The FMU shall include a scrollable, zoomable map display, with the intersections and other monitored devices shown as representative icons on the map. The map shall include the ability to see the intersections using Google Streetview.
- 3.2 The alarm status of the intersection shall be clearly indicated on the icon on the map, so that the user can see at a glance which intersections are in alarm.

- 3.3 The map display shall also include a list of intersections, with the number and priority of alarms indicated on the list. Intersections in high priority alarm shall be moved to the top of the list, followed by medium priority, low priority and then finally by intersections not in alarm.
- 3.4 The icons shall change to be able to clearly indicate if an intersection is offline.
- 3.5 Clicking on the icon on the map shall expose a box with the current parameters of the intersection shown.
- 3.6 The default map display position and zoom shall be configurable by user, so that the user's view will default to show the intersections that the user is responsible for managing.
- 3.7 The map view shall have the ability to show Google traffic overlays on the map.

4. Intersection Detail Display FMU Management Software

- 4.1 It shall be possible to drill down, either from the map icon or from the list, to a device level detail for the intersection, which as a minimum shall display the following parameters:
 - 4.1.1 The alarm status, with priority indicated, and a text description of the alarm (if an alarm is present for this device).
 - 4.1.2 The time since the last communication with the device
 - 4.1.3 The following parameters (real time now values, minimum for the day values, maximum for the day values, and average for the day values)
 - 4.1.3.1 The AC mains voltage (value)
 - 4.1.3.2 The battery back-up voltage (value)
 - 4.1.3.3 The cabinet temperature (value)
 - 4.1.3.4 The cabinet humidity (value)
 - 4.1.3.5 The presence of AC power (OK or Fail)
 - 4.1.3.6 The flashing status of the intersection (OK or Flashing)
 - 4.1.3.7 Stop Time status (OK or Stop Time Active)
 - 4.1.3.8 The cabinet door status (Open or Closed)
 - 4.1.3.9 The intersection fan status (Fan On or Fan off)

- 4.1.4 It shall be possible to view graphs of each of the value parameters in graphical form, over the recent two-week period. This includes real time graphs of:
 - 4.1.4.1 The AC mains voltage
 - 4.1.4.2 The battery back-up voltage
 - 4.1.4.3 The cabinet temperature
 - 4.1.4.4 The cabinet humidity

5. Diagnostics and Log Display FMU Management Software

- 5.1 From the device level detail within the FMU management software, it shall be possible to drill down to get the raw data; the error logs; and the communications logs to allow a technician to fault-find problems.
- 5.2 It shall be possible to filter the logs by Device; by Device Type and/or by Group as well as between dates.
- 5.3 It shall be possible to print these selected logs to a local printer or a PDF file.
- 5.4 It shall be possible to export these logs to Excel on the local computer for further analysis.

6. Alarms FMU Management Software

SECTION 720 STRUCTURAL SUPPORTS FOR HIGHWAY SIGNS, LUMINAIRES AND TRAFFIC SIGNALS

720.12 Wood Sign Posts Revise the first sentence so that it reads:

Wood sign posts shall be rectangular, straight and sound timber, cut from live growing native spruce, red pine, hemlock, cedar trees or other AWPA approved species, free from loose knots or other structurally weakening defects of importance, such as shake or holes or heart rot.

Revise the third paragraph that starts with "When pressure treated..." so that it reads:

All sign posts shall be pressure-treated in accordance with AASHTO M 133 and AWPA Standard U1, UC4A, Commodity Specification A: Sawn Products.

- 8. Contractors are encouraged to participate in voluntary associations which assist in fulfilling one or more of their affirmative action obligations (7 a through p.). The efforts of a contractor association, joint contractor-union, contractor-community, or other similar group of which the contractor is a member and participant, may be asserted as fulfilling any one or more of its obligations under 7 a through p. of these specifications provided that the contractor actively participates in the group, makes every effort to assure that the group has a positive impact on the employment of minorities and women in the industry, ensures that the concrete benefits of the program and reflected in the Contractor's minority and female work force participation, makes a good faith effort to meet its individual goals and timetables, and can provide access to documentation which demonstrates the effectiveness of actions take on behalf of the Contractor. The obligation to comply, however, is the Contractor's and failure of such a group to fulfill an obligation shall not be a defense for the Contractor's noncompliance.
- 9. A single goal for minorities and a separate single goal for women have been established. The Contractor, however, is required to provide equal employment opportunity and to take affirmative action for all minority groups, both make and female, and all women, both minority and non-minority. Consequently, the Contractor may be in violation of the Executive Order if a particular group is employed in a substantially disparate manner (for example, specific minority group of women is underutilized.)
- 10. The Contractor shall not use the goals and timetables or affirmative action even through the Contractor has achieved its goals for women generally, the Contractor may be in violation of the Executive Order if standards to discriminate against any person because of race, color, religion, sex, or national origin.
- 11. The Contractor shall not enter into any Subcontract with any person or firm debarred from Government contracts pursuant to Executive Order 11246.
- 12. The Contractor shall carry out such sanctions and penalties for violation of these specifications and of the Equal Opportunity Clause, including suspension, termination and cancellation of existing subcontracts as may be imposed or ordered pursuant to Executive Order 11246, as amended, and its implementation regulations by the Office of Federal Contract Compliance Programs. Any Contractor who fails to carry out such sanctions and penalties shall be in violation of these specifications and Executive Order 11246, as amended.
- 13. The Contractor, in fulfilling its obligations under these specifications, shall implement specific affirmative action steps, at least as extensive as those standards prescribed in paragraph 7 of these specifications, so as to achieve maximum results from its efforts to ensure equal employment opportunity. If the Contractor fails to comply with the

requirements of the Executive Order, the implementing regulations, or these specifications, the Director shall proceed in accordance with 41 CFR 60-4.6.

- 14. The Contractor shall designate a responsible official to monitor all employment related activity to ensure that the company EEO policy is being carried out, to submit reports relating to the provisions hereof as may be required by the Government and to keep records. Records shall at least include for each employee the name, address, telephone numbers, construction trade, union affiliation if any, employee identification number when assigned, social security number, race, sex, status (e.g. mechanic, apprentice, trainee, helper, or laborer), dates of changes in status, hours worked per week in the indicated trade, rate of pay, and location sat which the work was performed. Records be maintained in an easily understandable and retrievable form; however, to the degree that existing records satisfy this requirement, contractors shall not be required to maintain separate records.
- 15. Nothing herein provided shall be construed as a limitation upon the application of other laws which establish different standards of compliance or upon the application of requirements for the hiring of local or other area residents (e.g., those under the Public Works Employment Act of 1977 and the Community Development Block Grant Program).

D. Section '<u>D Disadvantaged Business Enterprise (DBE) Requirements</u>' is removed in its entirety. The DBE material is in:

Section 105.10 EQUAL OPPORTUNITY AND CIVIL RIGHTS.

SECTION 3 - OTHER FEDERAL REQUIREMENTS

Unless expressly otherwise provided in the Bid Documents, the provisions contained in this Section 3 of this "Federal Contract Provisions Supplement" are hereby incorporated into the Bid Documents and Contract.

A. Buy America

If the cost of products purchased for permanent use in this project which are manufactured of steel, iron or the application of any coating to products of these materials exceeds 0.1 percent of the contract amount, or \$2,500.00, whichever is greater, the products shall have been manufactured and the coating applied in the United States. The coating materials are not subject to this clause, only the application of the coating. In computing that amount, only the cost of the product and coating application cost will be included.

Ore, for the manufacture of steel or iron, may be from outside the United States; however, all other manufacturing processes of steel or iron must be in the United States to qualify as having been manufactured in the United States.

United States includes the 50 United States and any place subject to the jurisdiction thereof.

Products of steel include, but are not limited to, such products as structural steel, piles, guardrail, steel culverts, reinforcing steel, structural plate and steel supports for signs, luminaries and signals.

Products of iron include, but are not limited to, such products as cast iron grates.

Application of coatings include, but are not limited to, such applications as epoxy, galvanized and paint.

To assure compliance with this section, the Contractor shall submit a certification letter on its letterhead to the Department stating the following:

"This is to certify that products made of steel, iron or the application of any coating to products of these materials whose costs are in excess of \$2,500.00 or 0.1 percent of the original contract amount, whichever is greater, were manufactured and the coating, if one was required, was applied in the United States."

B. Materials

a. Convict Produced Materials References: 23 U.S.C. 114(b)(2), 23 CFR 635.417

Applicability: FHWA's prohibition against the use of convict material only applies to Federal-aid highways. Materials produced after July 1, 1991, by convict labor may only be incorporated in a Federal-aid highway construction project if: 1) such materials have been produced by convicts who are on parole, supervised release, or probation from a prison; or 2) such material has been produced in a qualified prison facility, e.g., prison industry, with the amount produced during any 12-month period, for use in Federal-aid projects, not exceeding the amount produced, for such use, during the 12-month period ending July 1, 1987.

Materials obtained from prison facilities (e.g., prison industries) are subject to the same requirements for Federal-aid participation that are imposed upon materials acquired from other sources. Materials manufactured or produced by convict labor will be given no preferential treatment.

The preferred method of obtaining materials for a project is through normal contracting procedures which require the contractor to furnish all materials to be incorporated in the work. The contractor selects the source, public or private, from which the materials are to be obtained (23 CFR 635.407). Prison industries are prohibited from bidding on projects directly (23 CFR 635.112e), but may act as material supplier to construction contractors.

Prison materials may also be approved as State-furnished material. However, since public agencies may not bid in competition with private firms, direct acquisition of materials from a prison industry for use as State-furnished material is subject to a public interest finding with the Division Administrator's concurrence (23 CFR 635.407d). Selection of materials produced by convict labor as State-furnished materials for mandatory use should be cleared prior to the submittal of the Plans Specifications & Estimates (PS&E).

b. Patented/Proprietary Products References: 23 U.S.C. 112, 23 CFR 635.411

FHWA will not participate, directly or indirectly, in payment for any premium or royalty on any patented or proprietary material, specification, or process specifically set forth in the plans and specifications for a project, unless:

- the item is purchased or obtained through competitive bidding with equally suitable unpatented items,
- the STA certifies either that the proprietary or patented item is essential for synchronization with the existing highway facilities or that no equally suitable alternative exists, or
- the item is used for research or for a special type of construction on relatively short sections of road for experimental purposes. States should follow FHWA's procedures for "Construction Projects Incorporating Experimental Features" (experimental for the submittal of work plans and evaluations.

The primary purpose of the policy is to have competition in selection of materials and allow for development of new materials and products. The policy further permits materials and products that are judged equal may be bid under generic specifications. If only patented or proprietary products are acceptable, they shall be bid as alternatives with all, or at least a reasonable number of, acceptable materials or products listed; and the Division Administrator may approve a single source if it can be found that its utilization is in the public interest.

Trade names are generally the key to identifying patented or proprietary materials. Trade name examples include 3M, Corten, etc. Generally, products identified by their brand or trade name are not to be specified without an "or equal" phrase, and, if trade names are used, all, or at least a reasonable number of acceptable "equal" materials or products should be listed. The licensing of several suppliers to produce a product does not change the fact that it is a single product and should not be specified to the exclusion of other equally suitable products.

c. State Preference References: 23 U.S.C. 112, 23 CFR 635.409

Materials produced within Maine shall not be favored to the exclusion of comparable materials produced outside of Maine. State preference clauses give particular advantage to the designated source and thus restrict competition. Therefore, State preference provisions shall not be used on any Federal-aid construction projects.

This policy also applies to State preference actions against materials of foreign origin, except as otherwise permitted by Federal law. Thus, States cannot give preference to in-State material sources over foreign material sources. Under the Buy America provisions, the States are permitted to expand the Buy America restrictions provided that the STA is legally authorized under State law to impose more stringent requirements.

d. <u>State Owned/Furnished/Designated Materials</u> References: 23 U.S.C. 112, 23 CFR 635.407

Current FHWA policy requires that the contractor must furnish all materials to be incorporated in the work, and the contractor shall be permitted to select the sources from which the materials are to be obtained. Exceptions to this requirement may be made when there is a definite finding, by MaineDOT and concurred in by Federal Highway Administration's (FHWA) Division Administrator, that it is in the public interest to require the contractor to use materials furnished by the MaineDOT or from sources designated by MaineDOT. The exception policy can best be understood by separating State-furnished materials into the categories of manufactured materials and local natural materials.

Manufactured Materials When the use of State-furnished manufactured materials is approved based on a public interest finding, such use must be made mandatory. The optional use of State-furnished manufactured materials is in violation of our policy prohibiting public agencies from competing with private firms. Manufactured materials to be furnished by MaineDOT must be acquired through competitive bidding, unless there is a public interest finding for another method, and concurred in by FHWA's Division Administrator.

<u>Local Natural Materials</u> When MaineDOT owns or controls a local natural materials source such as a borrow pit or a stockpile of salvaged pavement material, etc., the materials may be designated for either optional or mandatory use; however, mandatory use will require a public interest finding (PIF) and FHWA's Division Administrator's concurrence.

In order to permit prospective bidders to properly prepare their bids, the location, cost, and any conditions to be met for obtaining materials that are made available to the contractor shall be stated in the bidding documents.

Mandatory Disposal Sites Normally, the disposal site for surplus excavated materials is to be of the contractor's choosing; although, an optional site(s) may be shown in the contract provisions. A mandatory site shall be specified when there is a finding by MaineDOT, with the concurrence of the Division Administrator, that such placement is the most economical or that the environment would be substantially enhanced without excessive cost. Discussion of the mandatory use of a disposal site in the environmental document may serve as the basis for the public interest finding.

Summarizing FHWA policy for the mandatory use of borrow or disposal sites:

- mandatory use of either requires a public interest finding and FHWA's Division Administrator's concurrence,
- mandatory use of either may be based on environmental consideration where the environment will be substantially enhanced without excessive additional cost, and
- where the use is based on environmental considerations, the discussion in the environmental document may be used as the basis for the public interest finding.

Factors to justify a public interest finding should include such items as cost effectiveness, system integrity, and local shortages of material.

C. Standard FHWA Contract Provisions - FHWA 1273

Unless expressly otherwise provided in the Bid Documents, the following "Required Contract Provisions, Federal Aid Construction Contracts", FHWA-1273, are hereby incorporated into the Bid Documents and Contract.

Cargo Preference Act: Contractor and Subcontractor Clauses. "Use of United States-flag vessels: The contractor agrees—"(1) To utilize privately owned United States-flag commercial vessels to ship at least 50 percent of the gross tonnage (computed separately for dry bulk carriers, dry cargo liners, and tankers) involved, whenever shipping any equipment, material, or commodities pursuant to this contract, to the extent such vessels are available at fair and reasonable rates for United States-flag commercial vessels."(2) To furnish within 20 days following the date of loading for shipments originating within the United States or within 30 working days following the date of loading for shipments originating outside the United States, a legible copy of a rated, 'on-board' commercial ocean bill-of-lading in English for each shipment of cargo described in paragraph (1) of this section to both the Contracting Officer (through the prime contractor in the case of subcontractor bills-of-lading) and to the Division of National Cargo, Office of Market Development, Maritime Administration, Washington, DC 20590."(3) To insert the substance of the provisions of this clause in all subcontracts issued pursuant to this contract." (Reorganization Plans No. 21 of 1950 (64 Stat. 1273) and No. 7 of 1961 (75 Stat. 840) as amended by Pub. L. 91-469 (84 Stat. 1036) and Department of Commerce Organization Order 10-8 (38 FR 19707, July 23, 1973)) [42 FR 57126, Nov. 1, 1977]

The Cargo Preference Act requirements apply to materials or equipment that are acquired for a specific Federal-aid highway project. In general, the requirements are not applicable to goods or materials that come into inventories independent of an FHWA funded-contract. For example, the requirements would not apply to shipments of Portland cement, asphalt cement, or aggregates, as industry suppliers and contractors use these materials to replenish existing inventories. In general, most of the materials used for highway construction originate from existing inventories and are not acquired solely for a specific Federal-aid project. However, if materials or equipment are acquired solely for a Federal-aid project, then the Cargo Preference Act requirements apply."

ATTACHMENTS

A. Employment and Materials Preference for Appalachian Development Highway System or Appalachian Local Access Road Contracts (included in Appalachian contracts only)

I. GENERAL

1. Form FHWA-1273 must be physically incorporated in each construction contract funded under title 23, United States Code, as required in 23 CFR 633.102(b) (excluding emergency contracts solely intended for debris removal). The contractor (or subcontractor) must insert this form in each subcontract and further require its inclusion in all lower tier subcontracts (excluding purchase orders, rental agreements and other agreements for supplies or services). 23 CFR 633.102(e).

The applicable requirements of Form FHWA-1273 are incorporated by reference for work done under any purchase order, rental agreement or agreement for other services. The prime contractor shall be responsible for compliance by any subcontractor, lower-tier subcontractor or service provider. 23 CFR 633.102(e).

Form FHWA-1273 must be included in all Federal-aid designbuild contracts, in all subcontracts and in lower tier subcontracts (excluding subcontracts for design services, purchase orders, rental agreements and other agreements for supplies or services) in accordance with 23 CFR 633.102. The design-builder shall be responsible for compliance by any subcontractor, lower-tier subcontractor or service provider.

Contracting agencies may reference Form FHWA-1273 in solicitation-for-bids or request-for-proposals documents, however, the Form FHWA-1273 must be physically incorporated (not referenced) in all contracts, subcontracts and lower-tier subcontracts (excluding purchase orders, rental agreements and other agreements for supplies or services related to a construction contract). 23 CFR 633.102(b).

2. Subject to the applicability criteria noted in the following sections, these contract provisions shall apply to all work

performed on the contract by the contractor's own organization and with the assistance of workers under the contractor's immediate superintendence and to all work performed on the contract by piecework, station work, or by subcontract. 23 CFR 633.102(d).

- 3. A breach of any of the stipulations contained in these Required Contract Provisions may be sufficient grounds for withholding of progress payments, withholding of final payment, termination of the contract, suspension / debarment or any other action determined to be appropriate by the contracting agency and FHWA.
- 4. Selection of Labor: During the performance of this contract, the contractor shall not use convict labor for any purpose within the limits of a construction project on a Federal-aid highway unless it is labor performed by convicts who are on parole, supervised release, or probation. 23 U.S.C. 114(b). The term Federal-aid highway does not include roadways functionally classified as local roads or rural minor collectors. 23 U.S.C. 101(a).
- II. NONDISCRIMINATION (23 CFR 230.107(a); 23 CFR Part 230, Subpart A, Appendix A; EO 11246)

The provisions of this section related to 23 CFR Part 230, Subpart A, Appendix A are applicable to all Federal-aid construction contracts and to all related construction subcontracts of \$10,000 or more. The provisions of 23 CFR Part 230 are not applicable to material supply, engineering, or architectural service contracts.

In addition, the contractor and all subcontractors must comply with the following policies: Executive Order 11246, 41 CFR Part 60, 29 CFR Parts 1625-1627, 23 U.S.C. 140, Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. 794), Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 2000d et seq.), and related regulations including 49 CFR Parts 21, 26, and 27; and 23 CFR Parts 200, 230, and 633.

The contractor and all subcontractors must comply with: the requirements of the Equal Opportunity Clause in 41 CFR 60-1.4(b) and, for all construction contracts exceeding \$10,000, the Standard Federal Equal Employment Opportunity Construction Contract Specifications in 41 CFR 60-4.3.

Note: The U.S. Department of Labor has exclusive authority to determine compliance with Executive Order 11246 and the policies of the Secretary of Labor including 41 CFR Part 60, and 29 CFR Parts 1625-1627. The contracting agency and the FHWA have the authority and the responsibility to ensure compliance with 23 U.S.C. 140, Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. 794), and Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 2000d et seq.), and related regulations including 49 CFR Parts 21, 26, and 27; and 23 CFR Parts 200, 230, and 633.

The following provision is adopted from 23 CFR Part 230, Subpart A, Appendix A, with appropriate revisions to conform to the U.S. Department of Labor (US DOL) and FHWA requirements.

- 1. Equal Employment Opportunity: Equal Employment Opportunity (EEO) requirements not to discriminate and to take affirmative action to assure equal opportunity as set forth under laws, executive orders, rules, regulations (see 28 CFR Part 35, 29 CFR Part 1630, 29 CFR Parts 1625-1627, 41 CFR Part 60 and 49 CFR Part 27) and orders of the Secretary of Labor as modified by the provisions prescribed herein, and imposed pursuant to 23 U.S.C. 140, shall constitute the EEO and specific affirmative action standards for the contractor's project activities under this contract. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) set forth under 28 CFR Part 35 and 29 CFR Part 1630 are incorporated by reference in this contract. In the execution of this contract, the contractor agrees to comply with the following minimum specific requirement activities of EEO:
- a. The contractor will work with the contracting agency and the Federal Government to ensure that it has made every good faith effort to provide equal opportunity with respect to all of its terms and conditions of employment and in their review of activities under the contract. 23 CFR 230.409 (g)(4) & (5).
- b. The contractor will accept as its operating policy the following statement:

"It is the policy of this Company to assure that applicants are employed, and that employees are treated during employment, without regard to their race, religion, sex, sexual orientation, gender identity, color, national origin, age or disability. Such action shall include: employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship, pre-apprenticeship, and/or on-the-job training."

- 2. **EEO Officer:** The contractor will designate and make known to the contracting officers an EEO Officer who will have the responsibility for and must be capable of effectively administering and promoting an active EEO program and who must be assigned adequate authority and responsibility to do so.
- 3. Dissemination of Policy: All members of the contractor's staff who are authorized to hire, supervise, promote, and discharge employees, or who recommend such action or are substantially involved in such action, will be made fully cognizant of and will implement the contractor's EEO policy and contractual responsibilities to provide EEO in each grade and classification of employment. To ensure that the above agreement will be met, the following actions will be taken as a minimum:
- a. Periodic meetings of supervisory and personnel office employees will be conducted before the start of work and then not less often than once every six months, at which time the contractor's EEO policy and its implementation will be reviewed and explained. The meetings will be conducted by the EEO Officer or other knowledgeable company official.
- b. All new supervisory or personnel office employees will be given a thorough indoctrination by the EEO Officer, covering all major aspects of the contractor's EEO obligations within thirty days following their reporting for duty with the contractor.
- c. All personnel who are engaged in direct recruitment for the project will be instructed by the EEO Officer in the contractor's procedures for locating and hiring minorities and women

- d. Notices and posters setting forth the contractor's EEO policy will be placed in areas readily accessible to employees, applicants for employment and potential employees.
- e. The contractor's EEO policy and the procedures to implement such policy will be brought to the attention of employees by means of meetings, employee handbooks, or other appropriate means.
- **4. Recruitment:** When advertising for employees, the contractor will include in all advertisements for employees the notation: "An Equal Opportunity Employer." All such advertisements will be placed in publications having a large circulation among minorities and women in the area from which the project work force would normally be derived.
- a. The contractor will, unless precluded by a valid bargaining agreement, conduct systematic and direct recruitment through public and private employee referral sources likely to yield qualified minorities and women. To meet this requirement, the contractor will identify sources of potential minority group employees and establish with such identified sources procedures whereby minority and women applicants may be referred to the contractor for employment consideration.
- b. In the event the contractor has a valid bargaining agreement providing for exclusive hiring hall referrals, the contractor is expected to observe the provisions of that agreement to the extent that the system meets the contractor's compliance with EEO contract provisions. Where implementation of such an agreement has the effect of discriminating against minorities or women, or obligates the contractor to do the same, such implementation violates Federal nondiscrimination provisions.
- c. The contractor will encourage its present employees to refer minorities and women as applicants for employment. Information and procedures with regard to referring such applicants will be discussed with employees.
- **5. Personnel Actions:** Wages, working conditions, and employee benefits shall be established and administered, and personnel actions of every type, including hiring, upgrading, promotion, transfer, demotion, layoff, and termination, shall be taken without regard to race, color, religion, sex, sexual orientation, gender identity, national origin, age or disability. The following procedures shall be followed:
- a. The contractor will conduct periodic inspections of project sites to ensure that working conditions and employee facilities do not indicate discriminatory treatment of project site personnel.
- b. The contractor will periodically evaluate the spread of wages paid within each classification to determine any evidence of discriminatory wage practices.
- c. The contractor will periodically review selected personnel actions in depth to determine whether there is evidence of discrimination. Where evidence is found, the contractor will promptly take corrective action. If the review indicates that the discrimination may extend beyond the actions reviewed, such corrective action shall include all affected persons.
- d. The contractor will promptly investigate all complaints of alleged discrimination made to the contractor in connection with its obligations under this contract, will attempt to resolve such complaints, and will take appropriate corrective action

within a reasonable time. If the investigation indicates that the discrimination may affect persons other than the complainant, such corrective action shall include such other persons. Upon completion of each investigation, the contractor will inform every complainant of all of their avenues of appeal.

6. Training and Promotion:

- a. The contractor will assist in locating, qualifying, and increasing the skills of minorities and women who are applicants for employment or current employees. Such efforts should be aimed at developing full journey level status employees in the type of trade or job classification involved.
- b. Consistent with the contractor's work force requirements and as permissible under Federal and State regulations, the contractor shall make full use of training programs (i.e., apprenticeship and on-the-job training programs for the geographical area of contract performance). In the event a special provision for training is provided under this contract, this subparagraph will be superseded as indicated in the special provision. The contracting agency may reserve training positions for persons who receive welfare assistance in accordance with 23 U.S.C. 140(a).
- c. The contractor will advise employees and applicants for employment of available training programs and entrance requirements for each.
- d. The contractor will periodically review the training and promotion potential of employees who are minorities and women and will encourage eligible employees to apply for such training and promotion.
- 7. Unions: If the contractor relies in whole or in part upon unions as a source of employees, the contractor will use good faith efforts to obtain the cooperation of such unions to increase opportunities for minorities and women. 23 CFR 230.409. Actions by the contractor, either directly or through a contractor's association acting as agent, will include the procedures set forth below:
- a. The contractor will use good faith efforts to develop, in cooperation with the unions, joint training programs aimed toward qualifying more minorities and women for membership in the unions and increasing the skills of minorities and women so that they may qualify for higher paying employment.
- b. The contractor will use good faith efforts to incorporate an EEO clause into each union agreement to the end that such union will be contractually bound to refer applicants without regard to their race, color, religion, sex, sexual orientation, gender identity, national origin, age, or disability.
- c. The contractor is to obtain information as to the referral practices and policies of the labor union except that to the extent such information is within the exclusive possession of the labor union and such labor union refuses to furnish such information to the contractor, the contractor shall so certify to the contracting agency and shall set forth what efforts have been made to obtain such information.
- d. In the event the union is unable to provide the contractor with a reasonable flow of referrals within the time limit set forth in the collective bargaining agreement, the contractor will, through independent recruitment efforts, fill the employment vacancies without regard to race, color, religion, sex, sexual orientation, gender identity, national origin, age, or disability; making full efforts to obtain qualified and/or qualifiable minorities and women. The failure of a union to provide

sufficient referrals (even though it is obligated to provide exclusive referrals under the terms of a collective bargaining agreement) does not relieve the contractor from the requirements of this paragraph. In the event the union referral practice prevents the contractor from meeting the obligations pursuant to Executive Order 11246, as amended, and these special provisions, such contractor shall immediately notify the contracting agency.

- 8. Reasonable Accommodation for Applicants / Employees with Disabilities: The contractor must be familiar with the requirements for and comply with the Americans with Disabilities Act and all rules and regulations established thereunder. Employers must provide reasonable accommodation in all employment activities unless to do so would cause an undue hardship.
- 9. Selection of Subcontractors, Procurement of Materials and Leasing of Equipment: The contractor shall not discriminate on the grounds of race, color, religion, sex, sexual orientation, gender identity, national origin, age, or disability in the selection and retention of subcontractors, including procurement of materials and leases of equipment. The contractor shall take all necessary and reasonable steps to ensure nondiscrimination in the administration of this contract.
- a. The contractor shall notify all potential subcontractors, suppliers, and lessors of their EEO obligations under this contract.
- b. The contractor will use good faith efforts to ensure subcontractor compliance with their EEO obligations.

10. Assurances Required:

- a. The requirements of 49 CFR Part 26 and the State DOT's FHWA-approved Disadvantaged Business Enterprise (DBE) program are incorporated by reference.
- b. The contractor, subrecipient or subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The contractor shall carry out applicable requirements of 49 CFR part 26 in the award and administration of DOT-assisted contracts. Failure by the contractor to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as the recipient deems appropriate, which may include, but is not limited to:
 - (1) Withholding monthly progress payments;
 - (2) Assessing sanctions;
 - (3) Liquidated damages; and/or
- (4) Disqualifying the contractor from future bidding as non-responsible.
- c. The Title VI and nondiscrimination provisions of U.S. DOT Order 1050.2A at Appendixes A and E are incorporated by reference. 49 CFR Part 21.
- 11. Records and Reports: The contractor shall keep such records as necessary to document compliance with the EEO requirements. Such records shall be retained for a period of three years following the date of the final payment to the contractor for all contract work and shall be available at reasonable times and places for inspection by authorized representatives of the contracting agency and the FHWA.
- a. The records kept by the contractor shall document the following:

- (1) The number and work hours of minority and nonminority group members and women employed in each work classification on the project;
 - (2) The progress and efforts being made in cooperation with unions, when applicable, to increase employment opportunities for minorities and women; and
 - (3) The progress and efforts being made in locating, hiring, training, qualifying, and upgrading minorities and women.
- b. The contractors and subcontractors will submit an annual report to the contracting agency each July for the duration of the project indicating the number of minority, women, and non-minority group employees currently engaged in each work classification required by the contract work. This information is to be reported on Form FHWA-1391. The staffing data should represent the project work force on board in all or any part of the last payroll period preceding the end of July. If on-the-job training is being required by special provision, the contractor will be required to collect and report training data. The employment data should reflect the work force on board during all or any part of the last payroll period preceding the end of July.

III. NONSEGREGATED FACILITIES

This provision is applicable to all Federal-aid construction contracts and to all related construction subcontracts of more than \$10,000. 41 CFR 60-1.5.

As prescribed by 41 CFR 60-1.8, the contractor must ensure that facilities provided for employees are provided in such a manner that segregation on the basis of race, color, religion, sex, sexual orientation, gender identity, or national origin cannot result. The contractor may neither require such segregated use by written or oral policies nor tolerate such use by employee custom. The contractor's obligation extends further to ensure that its employees are not assigned to perform their services at any location under the contractor's control where the facilities are segregated. The term "facilities" includes waiting rooms, work areas, restaurants and other eating areas, time clocks, restrooms, washrooms, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing provided for employees. The contractor shall provide separate or single-user restrooms and necessary dressing or sleeping areas to assure privacy between sexes.

IV. DAVIS-BACON AND RELATED ACT PROVISIONS

This section is applicable to all Federal-aid construction projects exceeding \$2,000 and to all related subcontracts and lower-tier subcontracts (regardless of subcontract size), in accordance with 29 CFR 5.5. The requirements apply to all projects located within the right-of-way of a roadway that is functionally classified as Federal-aid highway. 23 U.S.C. 113. This excludes roadways functionally classified as local roads or rural minor collectors, which are exempt. 23 U.S.C. 101. Where applicable law requires that projects be treated as a project on a Federal-aid highway, the provisions of this subpart will apply regardless of the location of the project. Examples include: Surface Transportation Block Grant Program projects funded under 23 U.S.C. 133 [excluding recreational trails projects], the Nationally Significant Freight and Highway

Projects funded under 23 U.S.C. 117, and National Highway Freight Program projects funded under 23 U.S.C. 167.

The following provisions are from the U.S. Department of Labor regulations in 29 CFR 5.5 "Contract provisions and related matters" with minor revisions to conform to the FHWA-1273 format and FHWA program requirements.

1. Minimum wages (29 CFR 5.5)

- a. Wage rates and fringe benefits. All laborers and mechanics employed or working upon the site of the work (or otherwise working in construction or development of the project under a development statute), will be paid unconditionally and not less often than once a week, and without subsequent deduction or rebate on any account (except such payroll deductions as are permitted by regulations issued by the Secretary of Labor under the Copeland Act (29 CFR part 3)), the full amount of basic hourly wages and bona fide fringe benefits (or cash equivalents thereof) due at time of payment computed at rates not less than those contained in the wage determination of the Secretary of Labor which is attached hereto and made a part hereof, regardless of any contractual relationship which may be alleged to exist between the contractor and such laborers and mechanics. As provided in paragraphs (d) and (e) of 29 CFR 5.5, the appropriate wage determinations are effective by operation of law even if they have not been attached to the contract. Contributions made or costs reasonably anticipated for bona fide fringe benefits under the Davis-Bacon Act (40 U.S.C. 3141(2)(B)) on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of paragraph 1.e. of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. Such laborers and mechanics must be paid the appropriate wage rate and fringe benefits on the wage determination for the classification(s) of work actually performed, without regard to skill, except as provided in paragraph 4. of this section. Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein: Provided, That the employer's payroll records accurately set forth the time spent in each classification in which work is performed. The wage determination (including any additional classifications and wage rates conformed under paragraph 1.c. of this section) and the Davis-Bacon poster (WH-1321) must be posted at all times by the contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers.
- b. Frequently recurring classifications. (1) In addition to wage and fringe benefit rates that have been determined to be prevailing under the procedures set forth in 29 CFR part 1, a wage determination may contain, pursuant to § 1.3(f), wage and fringe benefit rates for classifications of laborers and mechanics for which conformance requests are regularly submitted pursuant to paragraph 1.c. of this section, provided that:
 - (i) The work performed by the classification is not performed by a classification in the wage determination for which a prevailing wage rate has been determined;

- (ii) The classification is used in the area by the construction industry; and
- (iii) The wage rate for the classification bears a reasonable relationship to the prevailing wage rates contained in the wage determination.
- (2) The Administrator will establish wage rates for such classifications in accordance with paragraph 1.c.(1)(iii) of this section. Work performed in such a classification must be paid at no less than the wage and fringe benefit rate listed on the wage determination for such classification.
- c. Conformance. (1) The contracting officer must require that any class of laborers or mechanics, including helpers, which is not listed in the wage determination and which is to be employed under the contract be classified in conformance with the wage determination. Conformance of an additional classification and wage rate and fringe benefits is appropriate only when the following criteria have been met:
 - (i) The work to be performed by the classification requested is not performed by a classification in the wage determination; and
 - (ii) The classification is used in the area by the construction industry; and
 - (iii) The proposed wage rate, including any bona fide fringe benefits, bears a reasonable relationship to the wage rates contained in the wage determination.
- (2) The conformance process may not be used to split, subdivide, or otherwise avoid application of classifications listed in the wage determination.
- (3) If the contractor and the laborers and mechanics to be employed in the classification (if known), or their representatives, and the contracting officer agree on the classification and wage rate (including the amount designated for fringe benefits where appropriate), a report of the action taken will be sent by the contracting officer by email to DBAconformance@dol.gov. The Administrator, or an authorized representative, will approve, modify, or disapprove every additional classification action within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30–day period that additional time is necessary.
- (4) In the event the contractor, the laborers or mechanics to be employed in the classification or their representatives, and the contracting officer do not agree on the proposed classification and wage rate (including the amount designated for fringe benefits, where appropriate), the contracting officer will, by email to <code>DBAconformance@dol.gov</code>, refer the questions, including the views of all interested parties and the recommendation of the contracting officer, to the Administrator for determination. The Administrator, or an authorized representative, will issue a determination within 30 days of receipt and so advise the contracting officer or will notify the contracting officer within the 30–day period that additional time is necessary.
- (5) The contracting officer must promptly notify the contractor of the action taken by the Wage and Hour Division

- under paragraphs 1.c.(3) and (4) of this section. The contractor must furnish a written copy of such determination to each affected worker or it must be posted as a part of the wage determination. The wage rate (including fringe benefits where appropriate) determined pursuant to paragraph 1.c.(3) or (4) of this section must be paid to all workers performing work in the classification under this contract from the first day on which work is performed in the classification.
- d. Fringe benefits not expressed as an hourly rate. Whenever the minimum wage rate prescribed in the contract for a class of laborers or mechanics includes a fringe benefit which is not expressed as an hourly rate, the contractor may either pay the benefit as stated in the wage determination or may pay another bona fide fringe benefit or an hourly cash equivalent thereof.
- e. Unfunded plans. If the contractor does not make payments to a trustee or other third person, the contractor may consider as part of the wages of any laborer or mechanic the amount of any costs reasonably anticipated in providing bona fide fringe benefits under a plan or program, Provided, That the Secretary of Labor has found, upon the written request of the contractor, in accordance with the criteria set forth in § 5.28, that the applicable standards of the Davis-Bacon Act have been met. The Secretary of Labor may require the contractor to set aside in a separate account assets for the meeting of obligations under the plan or program.
- f. *Interest.* In the event of a failure to pay all or part of the wages required by the contract, the contractor will be required to pay interest on any underpayment of wages.

2. Withholding (29 CFR 5.5)

- a. Withholding requirements. The contracting agency may, upon its own action, or must, upon written request of an authorized representative of the Department of Labor, withhold or cause to be withheld from the contractor so much of the accrued payments or advances as may be considered necessary to satisfy the liabilities of the prime contractor or any subcontractor for the full amount of wages and monetary relief, including interest, required by the clauses set forth in this section for violations of this contract, or to satisfy any such liabilities required by any other Federal contract, or federally assisted contract subject to Davis-Bacon labor standards, that is held by the same prime contractor (as defined in § 5.2). The necessary funds may be withheld from the contractor under this contract, any other Federal contract with the same prime contractor, or any other federally assisted contract that is subject to Davis-Bacon labor standards requirements and is held by the same prime contractor, regardless of whether the other contract was awarded or assisted by the same agency, and such funds may be used to satisfy the contractor liability for which the funds were withheld. In the event of a contractor's failure to pay any laborer or mechanic, including any apprentice or helper working on the site of the work all or part of the wages required by the contract, or upon the contractor's failure to submit the required records as discussed in paragraph 3.d. of this section, the contracting agency may on its own initiative and after written notice to the contractor. take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds until such violations have ceased.
- b. Priority to withheld funds. The Department has priority to funds withheld or to be withheld in accordance with paragraph

- 2.a. of this section or Section V, paragraph 3.a., or both, over claims to those funds by:
- (1) A contractor's surety(ies), including without limitation performance bond sureties and payment bond sureties;
 - (2) A contracting agency for its reprocurement costs;
- (3) A trustee(s) (either a court-appointed trustee or a U.S. trustee, or both) in bankruptcy of a contractor, or a contractor's bankruptcy estate;
 - (4) A contractor's assignee(s);
 - (5) A contractor's successor(s); or
- (6) A claim asserted under the Prompt Payment Act, <u>31</u> U.S.C. 3901–3907.

3. Records and certified payrolls (29 CFR 5.5)

- a. Basic record requirements (1) Length of record retention. All regular payrolls and other basic records must be maintained by the contractor and any subcontractor during the course of the work and preserved for all laborers and mechanics working at the site of the work (or otherwise working in construction or development of the project under a development statute) for a period of at least 3 years after all the work on the prime contract is completed.
- (2) Information required. Such records must contain the name; Social Security number; last known address, telephone number, and email address of each such worker; each worker's correct classification(s) of work actually performed; hourly rates of wages paid (including rates of contributions or costs anticipated for bona fide fringe benefits or cash equivalents thereof of the types described in 40 U.S.C. 3141(2)(B) of the Davis-Bacon Act); daily and weekly number of hours actually worked in total and on each covered contract; deductions made; and actual wages paid.
- (3) Additional records relating to fringe benefits. Whenever the Secretary of Labor has found under paragraph 1.e. of this section that the wages of any laborer or mechanic include the amount of any costs reasonably anticipated in providing benefits under a plan or program described in 40 U.S.C. 3141(2)(B) of the Davis-Bacon Act, the contractor must maintain records which show that the commitment to provide such benefits is enforceable, that the plan or program is financially responsible, and that the plan or program has been communicated in writing to the laborers or mechanics affected, and records which show the costs anticipated or the actual cost incurred in providing such benefits.
- (4) Additional records relating to apprenticeship. Contractors with apprentices working under approved programs must maintain written evidence of the registration of apprenticeship programs, the registration of the apprentices, and the ratios and wage rates prescribed in the applicable programs.
- b. Certified payroll requirements (1) Frequency and method of submission. The contractor or subcontractor must submit weekly, for each week in which any DBA- or Related Acts-covered work is performed, certified payrolls to the contracting

- agency. The prime contractor is responsible for the submission of all certified payrolls by all subcontractors. A contracting agency or prime contractor may permit or require contractors to submit certified payrolls through an electronic system, as long as the electronic system requires a legally valid electronic signature; the system allows the contractor, the contracting agency, and the Department of Labor to access the certified payrolls upon request for at least 3 years after the work on the prime contract has been completed; and the contracting agency or prime contractor permits other methods of submission in situations where the contractor is unable or limited in its ability to use or access the electronic system.
- (2) Information required. The certified payrolls submitted must set out accurately and completely all of the information required to be maintained under paragraph 3.a.(2) of this section, except that full Social Security numbers and last known addresses, telephone numbers, and email addresses must not be included on weekly transmittals. Instead, the certified payrolls need only include an individually identifying number for each worker (e.g., the last four digits of the worker's Social Security number). The required weekly certified payroll information may be submitted using Optional Form WH-347 or in any other format desired. Optional Form WH-347 is available for this purpose from the Wage and Hour Division website at https://www.dol.gov/sites/dolgov/files/WHD/ legacy/files/wh347/.pdf or its successor website. It is not a violation of this section for a prime contractor to require a subcontractor to provide full Social Security numbers and last known addresses, telephone numbers, and email addresses to the prime contractor for its own records, without weekly submission by the subcontractor to the contracting agency.
- (3) Statement of Compliance. Each certified payroll submitted must be accompanied by a "Statement of Compliance," signed by the contractor or subcontractor, or the contractor's or subcontractor's agent who pays or supervises the payment of the persons working on the contract, and must certify the following:
 - (i) That the certified payroll for the payroll period contains the information required to be provided under paragraph 3.b. of this section, the appropriate information and basic records are being maintained under paragraph 3.a. of this section, and such information and records are correct and complete;
 - (ii) That each laborer or mechanic (including each helper and apprentice) working on the contract during the payroll period has been paid the full weekly wages earned, without rebate, either directly or indirectly, and that no deductions have been made either directly or indirectly from the full wages earned, other than permissible deductions as set forth in 29 CFR part 3; and
 - (iii) That each laborer or mechanic has been paid not less than the applicable wage rates and fringe benefits or cash equivalents for the classification(s) of work actually performed, as specified in the applicable wage determination incorporated into the contract.
- (4) Use of Optional Form WH–347. The weekly submission of a properly executed certification set forth on the reverse side of Optional Form WH–347 will satisfy the requirement for submission of the "Statement of Compliance" required by paragraph 3.b.(3) of this section.

- (5) Signature. The signature by the contractor, subcontractor, or the contractor's or subcontractor's agent must be an original handwritten signature or a legally valid electronic signature.
- (6) Falsification. The falsification of any of the above certifications may subject the contractor or subcontractor to civil or criminal prosecution under 18 U.S.C. 1001 and 31 U.S.C. 3729.
- (7) Length of certified payroll retention. The contractor or subcontractor must preserve all certified payrolls during the course of the work and for a period of 3 years after all the work on the prime contract is completed.
- c. Contracts, subcontracts, and related documents. The contractor or subcontractor must maintain this contract or subcontract and related documents including, without limitation, bids, proposals, amendments, modifications, and extensions. The contractor or subcontractor must preserve these contracts, subcontracts, and related documents during the course of the work and for a period of 3 years after all the work on the prime contract is completed.
- d. Required disclosures and access (1) Required record disclosures and access to workers. The contractor or subcontractor must make the records required under paragraphs 3.a. through 3.c. of this section, and any other documents that the contracting agency, the State DOT, the FHWA, or the Department of Labor deems necessary to determine compliance with the labor standards provisions of any of the applicable statutes referenced by § 5.1, available for inspection, copying, or transcription by authorized representatives of the contracting agency, the State DOT, the FHWA, or the Department of Labor, and must permit such representatives to interview workers during working hours on the job.
- (2) Sanctions for non-compliance with records and worker access requirements. If the contractor or subcontractor fails to submit the required records or to make them available, or refuses to permit worker interviews during working hours on the job, the Federal agency may, after written notice to the contractor, sponsor, applicant, owner, or other entity, as the case may be, that maintains such records or that employs such workers, take such action as may be necessary to cause the suspension of any further payment, advance, or guarantee of funds. Furthermore, failure to submit the required records upon request or to make such records available, or to permit worker interviews during working hours on the job, may be grounds for debarment action pursuant to § 5.12. In addition, any contractor or other person that fails to submit the required records or make those records available to WHD within the time WHD requests that the records be produced will be precluded from introducing as evidence in an administrative proceeding under 29 CFR part 6 any of the required records that were not provided or made available to WHD. WHD will take into consideration a reasonable request from the contractor or person for an extension of the time for submission of records. WHD will determine the reasonableness of the request and may consider, among other things, the location of the records and the volume of production.
- (3) Required information disclosures. Contractors and subcontractors must maintain the full Social Security number and last known address, telephone number, and email address

of each covered worker, and must provide them upon request to the contracting agency, the State DOT, the FHWA, the contractor, or the Wage and Hour Division of the Department of Labor for purposes of an investigation or other compliance action.

4. Apprentices and equal employment opportunity (29 CFR 5.5)

- a. Apprentices (1) Rate of pay. Apprentices will be permitted to work at less than the predetermined rate for the work they perform when they are employed pursuant to and individually registered in a bona fide apprenticeship program registered with the U.S. Department of Labor, Employment and Training Administration, Office of Apprenticeship (OA), or with a State Apprenticeship Agency recognized by the OA. A person who is not individually registered in the program, but who has been certified by the OA or a State Apprenticeship Agency (where appropriate) to be eligible for probationary employment as an apprentice, will be permitted to work at less than the predetermined rate for the work they perform in the first 90 days of probationary employment as an apprentice in such a program. In the event the OA or a State Apprenticeship Agency recognized by the OA withdraws approval of an apprenticeship program, the contractor will no longer be permitted to use apprentices at less than the applicable predetermined rate for the work performed until an acceptable program is approved.
- (2) Fringe benefits. Apprentices must be paid fringe benefits in accordance with the provisions of the apprenticeship program. If the apprenticeship program does not specify fringe benefits, apprentices must be paid the full amount of fringe benefits listed on the wage determination for the applicable classification. If the Administrator determines that a different practice prevails for the applicable apprentice classification, fringe benefits must be paid in accordance with that determination.
- (3) Apprenticeship ratio. The allowable ratio of apprentices to journeyworkers on the job site in any craft classification must not be greater than the ratio permitted to the contractor as to the entire work force under the registered program or the ratio applicable to the locality of the project pursuant to paragraph 4.a.(4) of this section. Any worker listed on a payroll at an apprentice wage rate, who is not registered or otherwise employed as stated in paragraph 4.a.(1) of this section, must be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed. In addition, any apprentice performing work on the job site in excess of the ratio permitted under this section must be paid not less than the applicable wage rate on the wage determination for the work actually performed.
- (4) Reciprocity of ratios and wage rates. Where a contractor is performing construction on a project in a locality other than the locality in which its program is registered, the ratios and wage rates (expressed in percentages of the journeyworker's hourly rate) applicable within the locality in which the construction is being performed must be observed. If there is no applicable ratio or wage rate for the locality of the project, the ratio and wage rate specified in the contractor's registered program must be observed.
- b. Equal employment opportunity. The use of apprentices and journeyworkers under this part must be in conformity with

the equal employment opportunity requirements of Executive Order 11246, as amended, and 29 CFR part 30.

c. Apprentices and Trainees (programs of the U.S. DOT).

Apprentices and trainees working under apprenticeship and skill training programs which have been certified by the Secretary of Transportation as promoting EEO in connection with Federal-aid highway construction programs are not subject to the requirements of paragraph 4 of this Section IV. 23 CFR 230.111(e)(2). The straight time hourly wage rates for apprentices and trainees under such programs will be established by the particular programs. The ratio of apprentices and trainees to journeyworkers shall not be greater than permitted by the terms of the particular program.

- **5. Compliance with Copeland Act requirements.** The contractor shall comply with the requirements of 29 CFR part 3, which are incorporated by reference in this contract as provided in 29 CFR 5.5.
- **6. Subcontracts**. The contractor or subcontractor must insert FHWA-1273 in any subcontracts, along with the applicable wage determination(s) and such other clauses or contract modifications as the contracting agency may by appropriate instructions require, and a clause requiring the subcontractors to include these clauses and wage determination(s) in any lower tier subcontracts. The prime contractor is responsible for the compliance by any subcontractor or lower tier subcontractor with all the contract clauses in this section. In the event of any violations of these clauses, the prime contractor and any subcontractor(s) responsible will be liable for any unpaid wages and monetary relief, including interest from the date of the underpayment or loss, due to any workers of lower-tier subcontractors, and may be subject to debarment, as appropriate. 29 CFR 5.5.
- **7. Contract termination: debarment.** A breach of the contract clauses in 29 CFR 5.5 may be grounds for termination of the contract, and for debarment as a contractor and a subcontractor as provided in 29 CFR 5.12.
- 8. Compliance with Davis-Bacon and Related Act requirements. All rulings and interpretations of the Davis-Bacon and Related Acts contained in 29 CFR parts 1, 3, and 5 are herein incorporated by reference in this contract as provided in 29 CFR 5.5.
- 9. Disputes concerning labor standards. As provided in 29 CFR 5.5, disputes arising out of the labor standards provisions of this contract shall not be subject to the general disputes clause of this contract. Such disputes shall be resolved in accordance with the procedures of the Department of Labor set forth in 29 CFR parts 5, 6, and 7. Disputes within the meaning of this clause include disputes between the contractor (or any of its subcontractors) and the contracting agency, the U.S. Department of Labor, or the employees or their representatives.
- **10. Certification of eligibility**. a. By entering into this contract, the contractor certifies that neither it nor any person or firm who has an interest in the contractor's firm is a person or firm ineligible to be awarded Government contracts by virtue of <u>40 U.S.C. 3144(b)</u> or § 5.12(a).

- b. No part of this contract shall be subcontracted to any person or firm ineligible for award of a Government contract by virtue of 40 U.S.C. 3144(b) or § 5.12(a).
- c. The penalty for making false statements is prescribed in the U.S. Code, Title 18 Crimes and Criminal Procedure, <u>18</u> U.S.C. 1001.
- **11. Anti-retaliation**. It is unlawful for any person to discharge, demote, intimidate, threaten, restrain, coerce, blacklist, harass, or in any other manner discriminate against, or to cause any person to discharge, demote, intimidate, threaten, restrain, coerce, blacklist, harass, or in any other manner discriminate against, any worker or job applicant for:
- a. Notifying any contractor of any conduct which the worker reasonably believes constitutes a violation of the DBA, Related Acts, this part, or 29 CFR part 1 or 3;
- b. Filing any complaint, initiating or causing to be initiated any proceeding, or otherwise asserting or seeking to assert on behalf of themselves or others any right or protection under the DBA, Related Acts, this part, or 29 CFR part 1 or 3;
- c. Cooperating in any investigation or other compliance action, or testifying in any proceeding under the DBA, Related Acts, this part, or 29 CFR part 1 or 3; or
- d. Informing any other person about their rights under the DBA, Related Acts, this part, or 29 CFR part 1 or 3.

V. CONTRACT WORK HOURS AND SAFETY STANDARDS ACT

Pursuant to 29 CFR 5.5(b), the following clauses apply to any Federal-aid construction contract in an amount in excess of \$100,000 and subject to the overtime provisions of the Contract Work Hours and Safety Standards Act. These clauses shall be inserted in addition to the clauses required by 29 CFR 5.5(a) or 29 CFR 4.6. As used in this paragraph, the terms laborers and mechanics include watchpersons and guards.

- 1. Overtime requirements. No contractor or subcontractor contracting for any part of the contract work which may require or involve the employment of laborers or mechanics shall require or permit any such laborer or mechanic in any workweek in which he or she is employed on such work to work in excess of forty hours in such workweek unless such laborer or mechanic receives compensation at a rate not less than one and one-half times the basic rate of pay for all hours worked in excess of forty hours in such workweek. 29 CFR 5.5
- 2. Violation; liability for unpaid wages; liquidated damages. In the event of any violation of the clause set forth in paragraph 1. of this section the contractor and any subcontractor responsible therefor shall be liable for the unpaid wages and interest from the date of the underpayment. In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages shall be computed with respect to each individual laborer or

mechanic, including watchpersons and guards, employed in violation of the clause set forth in paragraph 1. of this section, in the sum currently provided in 29 CFR 5.5(b)(2)* for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of forty hours without payment of the overtime wages required by the clause set forth in paragraph 1. of this section.

* \$31 as of January 15, 2023 (See 88 FR 88 FR 2210) as may be adjusted annually by the Department of Labor, pursuant to the Federal Civil Penalties Inflation Adjustment Act of 1990.

3. Withholding for unpaid wages and liquidated damages

- a. Withholding process. The FHWA or the contracting agency may, upon its own action, or must, upon written request of an authorized representative of the Department of Labor, withhold or cause to be withheld from the contractor so much of the accrued payments or advances as may be considered necessary to satisfy the liabilities of the prime contractor or any subcontractor for any unpaid wages; monetary relief, including interest; and liquidated damages required by the clauses set forth in this section on this contract, any other Federal contract with the same prime contractor, or any other federally assisted contract subject to the Contract Work Hours and Safety Standards Act that is held by the same prime contractor (as defined in § 5.2). The necessary funds may be withheld from the contractor under this contract, any other Federal contract with the same prime contractor, or any other federally assisted contract that is subject to the Contract Work Hours and Safety Standards Act and is held by the same prime contractor, regardless of whether the other contract was awarded or assisted by the same agency, and such funds may be used to satisfy the contractor liability for which the funds were withheld.
- b. *Priority to withheld funds*. The Department has priority to funds withheld or to be withheld in accordance with Section IV paragraph 2.a. or paragraph 3.a. of this section, or both, over claims to those funds by:
- (1) A contractor's surety(ies), including without limitation performance bond sureties and payment bond sureties;
 - (2) A contracting agency for its reprocurement costs;
- (3) A trustee(s) (either a court-appointed trustee or a U.S. trustee, or both) in bankruptcy of a contractor, or a contractor's bankruptcy estate:
 - (4) A contractor's assignee(s);
 - (5) A contractor's successor(s); or
- (6) A claim asserted under the Prompt Payment Act, <u>31</u> U.S.C. 3901–3907.
- **4. Subcontracts.** The contractor or subcontractor must insert in any subcontracts the clauses set forth in paragraphs 1. through 5. of this section and a clause requiring the subcontractors to include these clauses in any lower tier subcontracts. The prime contractor is responsible for compliance by any subcontractor or lower tier subcontractor with the clauses set forth in paragraphs 1. through 5. In the

event of any violations of these clauses, the prime contractor and any subcontractor(s) responsible will be liable for any unpaid wages and monetary relief, including interest from the date of the underpayment or loss, due to any workers of lower-tier subcontractors, and associated liquidated damages and may be subject to debarment, as appropriate.

- **5. Anti-retaliation.** It is unlawful for any person to discharge, demote, intimidate, threaten, restrain, coerce, blacklist, harass, or in any other manner discriminate against, or to cause any person to discharge, demote, intimidate, threaten, restrain, coerce, blacklist, harass, or in any other manner discriminate against, any worker or job applicant for:
- a. Notifying any contractor of any conduct which the worker reasonably believes constitutes a violation of the Contract Work Hours and Safety Standards Act (CWHSSA) or its implementing regulations in this part;
- b. Filing any complaint, initiating or causing to be initiated any proceeding, or otherwise asserting or seeking to assert on behalf of themselves or others any right or protection under CWHSSA or this part;
- c. Cooperating in any investigation or other compliance action, or testifying in any proceeding under CWHSSA or this part: or
- d. Informing any other person about their rights under CWHSSA or this part.

VI. SUBLETTING OR ASSIGNING THE CONTRACT

This provision is applicable to all Federal-aid construction contracts on the National Highway System pursuant to 23 CFR 635.116.

- 1. The contractor shall perform with its own organization contract work amounting to not less than 30 percent (or a greater percentage if specified elsewhere in the contract) of the total original contract price, excluding any specialty items designated by the contracting agency. Specialty items may be performed by subcontract and the amount of any such specialty items performed may be deducted from the total original contract price before computing the amount of work required to be performed by the contractor's own organization (23 CFR 635.116).
- a. The term "perform work with its own organization" in paragraph 1 of Section VI refers to workers employed or leased by the prime contractor, and equipment owned or rented by the prime contractor, with or without operators. Such term does not include employees or equipment of a subcontractor or lower tier subcontractor, agents of the prime contractor, or any other assignees. The term may include payments for the costs of hiring leased employees from an employee leasing firm meeting all relevant Federal and State regulatory requirements. Leased employees may only be included in this term if the prime contractor meets all of the following conditions: (based on longstanding interpretation)
- (1) the prime contractor maintains control over the supervision of the day-to-day activities of the leased employees:
 - (2) the prime contractor remains responsible for the quality of the work of the leased employees;

- (3) the prime contractor retains all power to accept or exclude individual employees from work on the project; and
 - (4) the prime contractor remains ultimately responsible for the payment of predetermined minimum wages, the submission of payrolls, statements of compliance and all other Federal regulatory requirements.
- b. "Specialty Items" shall be construed to be limited to work that requires highly specialized knowledge, abilities, or equipment not ordinarily available in the type of contracting organizations qualified and expected to bid or propose on the contract as a whole and in general are to be limited to minor components of the overall contract. 23 CFR 635.102.
- 2. Pursuant to 23 CFR 635.116(a), the contract amount upon which the requirements set forth in paragraph (1) of Section VI is computed includes the cost of material and manufactured products which are to be purchased or produced by the contractor under the contract provisions.
- 3. Pursuant to 23 CFR 635.116(c), the contractor shall furnish (a) a competent superintendent or supervisor who is employed by the firm, has full authority to direct performance of the work in accordance with the contract requirements, and is in charge of all construction operations (regardless of who performs the work) and (b) such other of its own organizational resources (supervision, management, and engineering services) as the contracting officer determines is necessary to assure the performance of the contract.
- 4. No portion of the contract shall be sublet, assigned or otherwise disposed of except with the written consent of the contracting officer, or authorized representative, and such consent when given shall not be construed to relieve the contractor of any responsibility for the fulfillment of the contract. Written consent will be given only after the contracting agency has assured that each subcontract is evidenced in writing and that it contains all pertinent provisions and requirements of the prime contract. (based on long-standing interpretation of 23 CFR 635.116).
- 5. The 30-percent self-performance requirement of paragraph (1) is not applicable to design-build contracts; however, contracting agencies may establish their own self-performance requirements. 23 CFR 635.116(d).

VII. SAFETY: ACCIDENT PREVENTION

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts.

- 1. In the performance of this contract the contractor shall comply with all applicable Federal, State, and local laws governing safety, health, and sanitation (23 CFR Part 635). The contractor shall provide all safeguards, safety devices and protective equipment and take any other needed actions as it determines, or as the contracting officer may determine, to be reasonably necessary to protect the life and health of employees on the job and the safety of the public and to protect property in connection with the performance of the work covered by the contract. 23 CFR 635.108.
- 2. It is a condition of this contract, and shall be made a condition of each subcontract, which the contractor enters into pursuant to this contract, that the contractor and any subcontractor shall not permit any employee, in performance of the contract, to work in surroundings or under conditions which are unsanitary, hazardous or dangerous to his/her health or safety, as determined under construction safety and

health standards (29 CFR Part 1926) promulgated by the Secretary of Labor, in accordance with Section 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C. 3704). 29 CFR 1926.10.

3. Pursuant to 29 CFR 1926.3, it is a condition of this contract that the Secretary of Labor or authorized representative thereof, shall have right of entry to any site of contract performance to inspect or investigate the matter of compliance with the construction safety and health standards and to carry out the duties of the Secretary under Section 107 of the Contract Work Hours and Safety Standards Act (40 U.S.C. 3704).

VIII. FALSE STATEMENTS CONCERNING HIGHWAY PROJECTS

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts.

In order to assure high quality and durable construction in conformity with approved plans and specifications and a high degree of reliability on statements and representations made by engineers, contractors, suppliers, and workers on Federal-aid highway projects, it is essential that all persons concerned with the project perform their functions as carefully, thoroughly, and honestly as possible. Willful falsification, distortion, or misrepresentation with respect to any facts related to the project is a violation of Federal law. To prevent any misunderstanding regarding the seriousness of these and similar acts, Form FHWA-1022 shall be posted on each Federal-aid highway project (23 CFR Part 635) in one or more places where it is readily available to all persons concerned with the project:

18 U.S.C. 1020 reads as follows:

"Whoever, being an officer, agent, or employee of the United States, or of any State or Territory, or whoever, whether a person, association, firm, or corporation, knowingly makes any false statement, false representation, or false report as to the character, quality, quantity, or cost of the material used or to be used, or the quantity or quality of the work performed or to be performed, or the cost thereof in connection with the submission of plans, maps, specifications, contracts, or costs of construction on any highway or related project submitted for approval to the Secretary of Transportation; or

Whoever knowingly makes any false statement, false representation, false report or false claim with respect to the character, quality, quantity, or cost of any work performed or to be performed, or materials furnished or to be furnished, in connection with the construction of any highway or related project approved by the Secretary of Transportation; or

Whoever knowingly makes any false statement or false representation as to material fact in any statement, certificate, or report submitted pursuant to provisions of the Federal-aid Roads Act approved July 11, 1916, (39 Stat. 355), as amended and supplemented;

Shall be fined under this title or imprisoned not more than 5 years or both."

IX. IMPLEMENTATION OF CLEAN AIR ACT AND FEDERAL WATER POLLUTION CONTROL ACT (42 U.S.C. 7606; 2 CFR 200.88; EO 11738)

This provision is applicable to all Federal-aid construction contracts in excess of \$150,000 and to all related subcontracts. 48 CFR 2.101; 2 CFR 200.327.

By submission of this bid/proposal or the execution of this contract or subcontract, as appropriate, the bidder, proposer, Federal-aid construction contractor, subcontractor, supplier, or vendor agrees to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act (42 U.S.C. 7401-7671q) and the Federal Water Pollution Control Act, as amended (33 U.S.C. 1251-1387). Violations must be reported to the Federal Highway Administration and the Regional Office of the Environmental Protection Agency. 2 CFR Part 200, Appendix II.

The contractor agrees to include or cause to be included the requirements of this Section in every subcontract, and further agrees to take such action as the contracting agency may direct as a means of enforcing such requirements. 2 CFR 200.327.

X. CERTIFICATION REGARDING DEBARMENT, SUSPENSION, INELIGIBILITY AND VOLUNTARY EXCLUSION

This provision is applicable to all Federal-aid construction contracts, design-build contracts, subcontracts, lower-tier subcontracts, purchase orders, lease agreements, consultant contracts or any other covered transaction requiring FHWA approval or that is estimated to cost \$25,000 or more – as defined in 2 CFR Parts 180 and 1200. 2 CFR 180.220 and 1200.220.

1. Instructions for Certification – First Tier Participants:

- a. By signing and submitting this proposal, the prospective first tier participant is providing the certification set out below.
- b. The inability of a person to provide the certification set out below will not necessarily result in denial of participation in this covered transaction. The prospective first tier participant shall submit an explanation of why it cannot provide the certification set out below. The certification or explanation will be considered in connection with the department or agency's determination whether to enter into this transaction. However, failure of the prospective first tier participant to furnish a certification or an explanation shall disqualify such a person from participation in this transaction. 2 CFR 180.320.
- c. The certification in this clause is a material representation of fact upon which reliance was placed when the contracting agency determined to enter into this transaction. If it is later determined that the prospective participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the contracting agency may terminate this transaction for cause of default. 2 CFR 180.325.
- d. The prospective first tier participant shall provide immediate written notice to the contracting agency to whom this proposal is submitted if any time the prospective first tier participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances. 2 CFR 180.345 and 180.350.

- e. The terms "covered transaction," "debarred,"
 "suspended," "ineligible," "participant," "person," "principal,"
 and "voluntarily excluded," as used in this clause, are defined
 in 2 CFR Parts 180, Subpart I, 180.900-180.1020, and 1200.
 "First Tier Covered Transactions" refers to any covered
 transaction between a recipient or subrecipient of Federal
 funds and a participant (such as the prime or general contract).
 "Lower Tier Covered Transactions" refers to any covered
 transaction under a First Tier Covered Transaction (such as
 subcontracts). "First Tier Participant" refers to the participant
 who has entered into a covered transaction with a recipient or
 subrecipient of Federal funds (such as the prime or general
 contractor). "Lower Tier Participant" refers any participant who
 has entered into a covered transaction with a First Tier
 Participant or other Lower Tier Participants (such as
 subcontractors and suppliers).
- f. The prospective first tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency entering into this transaction. 2 CFR 180.330.
- g. The prospective first tier participant further agrees by submitting this proposal that it will include the clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Lower Tier Covered Transactions," provided by the department or contracting agency, entering into this covered transaction, without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions exceeding the \$25,000 threshold. 2 CFR 180.220 and 180.300.
- h. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. 2 CFR 180.300; 180.320, and 180.325. A participant is responsible for ensuring that its principals are not suspended, debarred, or otherwise ineligible to participate in covered transactions. 2 CFR 180.335. To verify the eligibility of its principals, as well as the eligibility of any lower tier prospective participants, each participant may, but is not required to, check the System for Award Management website (https://www.sam.gov/). 2 CFR 180.300, 180.320, and 180.325.
- i. Nothing contained in the foregoing shall be construed to require the establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of the prospective participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- j. Except for transactions authorized under paragraph (f) of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency may terminate this transaction for cause or default. 2 CFR 180.325.

* * * * *

2. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – First Tier Participants:

- a. The prospective first tier participant certifies to the best of its knowledge and belief, that it and its principals:
- (1) Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in covered transactions by any Federal department or agency, 2 CFR 180.335;.
- (2) Have not within a three-year period preceding this proposal been convicted of or had a civil judgment rendered against them for commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, State, or local) transaction or contract under a public transaction; violation of Federal or State antitrust statutes or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, or receiving stolen property, 2 CFR 180.800;
- (3) Are not presently indicted for or otherwise criminally or civilly charged by a governmental entity (Federal, State or local) with commission of any of the offenses enumerated in paragraph (a)(2) of this certification, 2 CFR 180.700 and 180.800: and
- (4) Have not within a three-year period preceding this application/proposal had one or more public transactions (Federal, State or local) terminated for cause or default. 2 CFR 180.335(d).
- (5) Are not a corporation that has been convicted of a felony violation under any Federal law within the two-year period preceding this proposal (USDOT Order 4200.6 implementing appropriations act requirements); and
- (6) Are not a corporation with any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted, or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability (USDOT Order 4200.6 implementing appropriations act requirements).
- b. Where the prospective participant is unable to certify to any of the statements in this certification, such prospective participant should attach an explanation to this proposal. 2 CFR 180.335 and 180.340.

* * * * *

3. Instructions for Certification - Lower Tier Participants:

(Applicable to all subcontracts, purchase orders, and other lower tier transactions requiring prior FHWA approval or estimated to cost \$25,000 or more - 2 CFR Parts 180 and 1200). 2 CFR 180.220 and 1200.220.

- a. By signing and submitting this proposal, the prospective lower tier participant is providing the certification set out below.
- b. The certification in this clause is a material representation of fact upon which reliance was placed when this transaction was entered into. If it is later determined that the prospective lower tier participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the department, or agency with which

this transaction originated may pursue available remedies, including suspension and/or debarment.

- c. The prospective lower tier participant shall provide immediate written notice to the person to which this proposal is submitted if at any time the prospective lower tier participant learns that its certification was erroneous by reason of changed circumstances. 2 CFR 180.365.
- d. The terms "covered transaction," "debarred," "suspended," "ineligible," "participant," "person," "principal," and "voluntarily excluded," as used in this clause, are defined in 2 CFR Parts 180, Subpart I, 180.900 - 180.1020, and 1200. You may contact the person to which this proposal is submitted for assistance in obtaining a copy of those regulations. "First Tier Covered Transactions" refers to any covered transaction between a recipient or subrecipient of Federal funds and a participant (such as the prime or general contract). "Lower Tier Covered Transactions" refers to any covered transaction under a First Tier Covered Transaction (such as subcontracts). "First Tier Participant" refers to the participant who has entered into a covered transaction with a recipient or subrecipient of Federal funds (such as the prime or general contractor). "Lower Tier Participant" refers any participant who has entered into a covered transaction with a First Tier Participant or other Lower Tier Participants (such as subcontractors and suppliers).
- e. The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency with which this transaction originated. 2 CFR 1200.220 and 1200.332.
- f. The prospective lower tier participant further agrees by submitting this proposal that it will include this clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion-Lower Tier Covered Transaction," without modification, in all lower tier covered transactions and in all solicitations for lower tier covered transactions exceeding the \$25,000 threshold. 2 CFR 180.220 and 1200.220.
- g. A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. A participant is responsible for ensuring that its principals are not suspended, debarred, or otherwise ineligible to participate in covered transactions. To verify the eligibility of its principals, as well as the eligibility of any lower tier prospective participants, each participant may, but is not required to, check the System for Award Management website (https://www.sam.gov/), which is compiled by the General Services Administration. 2 CFR 180.300, 180.320, 180.330, and 180.335.
- h. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- i. Except for transactions authorized under paragraph e of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily

excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment. 2 CFR 180.325.

* * * * *

4. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion--Lower Tier Participants:

- a. The prospective lower tier participant certifies, by submission of this proposal, that neither it nor its principals:
- (1) is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participating in covered transactions by any Federal department or agency, 2 CFR 180.355;
- (2) is a corporation that has been convicted of a felony violation under any Federal law within the two-year period preceding this proposal (USDOT Order 4200.6 implementing appropriations act requirements); and
- (3) is a corporation with any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted, or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability. (USDOT Order 4200.6 implementing appropriations act requirements)
- b. Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant should attach an explanation to this proposal.

* * * * *

XI. CERTIFICATION REGARDING USE OF CONTRACT FUNDS FOR LOBBYING

This provision is applicable to all Federal-aid construction contracts and to all related subcontracts which exceed \$100,000. 49 CFR Part 20, App. A.

- 1. The prospective participant certifies, by signing and submitting this bid or proposal, to the best of his or her knowledge and belief. that:
- a. No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
- b. If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any Federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or

cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.

- 2. This certification is a material representation of fact upon which reliance was placed when this transaction was made or entered into. Submission of this certification is a prerequisite for making or entering into this transaction imposed by 31 U.S.C. 1352. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.
- 3. The prospective participant also agrees by submitting its bid or proposal that the participant shall require that the language of this certification be included in all lower tier subcontracts, which exceed \$100,000 and that all such recipients shall certify and disclose accordingly.

XII. USE OF UNITED STATES-FLAG VESSELS:

This provision is applicable to all Federal-aid construction contracts, design-build contracts, subcontracts, lower-tier subcontracts, purchase orders, lease agreements, or any other covered transaction. 46 CFR Part 381.

(MARAD requires copies of the ocean carrier's (master) bills of lading, certified onboard, dated, with rates and charges. These bills of lading may contain business sensitive information and therefore may be submitted directly to MARAD by the Ocean Transportation Intermediary on behalf of the contractor). 46 CFR 381.7.

ATTACHMENT A - EMPLOYMENT AND MATERIALS PREFERENCE FOR APPALACHIAN DEVELOPMENT HIGHWAY SYSTEM OR APPALACHIAN LOCAL ACCESS ROAD CONTRACTS (23 CFR 633, Subpart B, Appendix B) This provision is applicable to all Federal-aid projects funded under the Appalachian Regional Development Act of 1965.

- 1. During the performance of this contract, the contractor undertaking to do work which is, or reasonably may be, done as on-site work, shall give preference to qualified persons who regularly reside in the labor area as designated by the DOL wherein the contract work is situated, or the subregion, or the Appalachian counties of the State wherein the contract work is situated, except:
- a. To the extent that qualified persons regularly residing in the area are not available.
- b. For the reasonable needs of the contractor to employ supervisory or specially experienced personnel necessary to assure an efficient execution of the contract work.
- c. For the obligation of the contractor to offer employment to present or former employees as the result of a lawful collective bargaining contract, provided that the number of nonresident persons employed under this subparagraph (1c) shall not exceed 20 percent of the total number of employees employed by the contractor on the contract work, except as provided in subparagraph (4) below.
- 2. The contractor shall place a job order with the State Employment Service indicating (a) the classifications of the laborers, mechanics and other employees required to perform the contract work, (b) the number of employees required in each classification, (c) the date on which the participant estimates such employees will be required, and (d) any other pertinent information required by the State Employment Service to complete the job order form. The job order may be placed with the State Employment Service in writing or by telephone. If during the course of the contract work, the information submitted by the contractor in the original job order is substantially modified, the participant shall promptly notify the State Employment Service.
- 3. The contractor shall give full consideration to all qualified job applicants referred to him by the State Employment Service. The contractor is not required to grant employment to any job applicants who, in his opinion, are not qualified to perform the classification of work required.
- 4. If, within one week following the placing of a job order by the contractor with the State Employment Service, the State Employment Service is unable to refer any qualified job applicants to the contractor, or less than the number requested, the State Employment Service will forward a certificate to the contractor indicating the unavailability of applicants. Such certificate shall be made a part of the contractor's permanent project records. Upon receipt of this certificate, the contractor may employ persons who do not normally reside in the labor area to fill positions covered by the certificate, notwithstanding the provisions of subparagraph (1c) above
- 5. The provisions of 23 CFR 633.207(e) allow the contracting agency to provide a contractual preference for the use of mineral resource materials native to the Appalachian region
- 6. The contractor shall include the provisions of Sections 1 through 4 of this Attachment A in every subcontract for work which is, or reasonably may be, done as on-site work.

- 4. The Recipient will insert the clauses of Appendix B of this Assurance, as a covenant running with the land, in any deed from the United States effecting or recording a transfer of real property, structures, use, or improvements thereon or interest therein to a Recipient.

- 1. NOW, THEREFORE, the U.S. Department of Transportation as authorized by law and upon the condition that the Maine Department of Transportation will accept title to the lands and maintain the project constructed thereon in accordance with all requirements imposed by Title 49, Code of Federal Regulations, Department of Transportation, subtitle A, Office of the Secretary, part 21, Non-discrimination in Federally-assisted Programs of the Department of Transportation pertaining to and effectuating the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252; 42 U.S.C. § 2000d to 2000d-4), the Regulations for the Administration of Federal Highway Administration (FHWA) Program, and the policies and procedures prescribed by the FHWA of the U.S. Department of Transportation in accordance and in compliance with all requirements imposed by Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non-discrimination in Federally-assisted programs of the U.S Department of Transportation pertaining to and effectuating the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252; 42 U.S.C. § 2000d to 2000d-4), does hereby remise, release, quitclaim and convey unto the Maine Department of Transportation all the right, title and interest of the U.S. Department of Transportation in and to said lands described in Exhibit A attached hereto and made a part hereof.

(HABENDUM CLAUSE)

TO HAVE AND TO HOLD said lands and interests therein unto Maine Department of Transportation and its successors forever, subject, however, to the covenants, conditions, restrictions and reservations herein contained as follows, which will remain in effect for the period during which the real property or structures are used for a purpose for which Federal financial assistance is extended or for another purpose involving the provision of similar services or benefits and will be binding on the Maine Department of Transportation, its successors and assigns.

The Maine Department of Transportation, in consideration of the conveyance of said lands and interests in lands, does hereby covenant and agree as a covenant running with the land for itself, its successors and assigns, that (1) no person will on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination with regard to any facility located wholly or in part on, over, or under such lands hereby conveyed [,] [and]* (2) that the Maine Department of Transportation will use the lands and interests in lands and interests in lands so conveyed, in compliance with all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non- discrimination in Federally-assisted programs of the U.S. Department of Transportation, Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations and Acts may be amended[, and (3) that in the event of breach of any of the above-mentioned non-discrimination conditions, the Department will have a right to enter or reenter said lands and facilities on said land, and that above described land and facilities will thereon revert to and vest in and become the absolute property of the U.S. Department of Transportation

and its assigns as such interest existed prior to this instruction].*

- B.
