Make the following changes to the Bid Document:

In the Bid Book (page 23) **REMOVE** the State of Maine Wage Rates for “Hutchins Bridge Replacement – Arundel”, “2011 Fair Minimum Wage Rates, Heavy & Bridge York County” and **REPLACE** with the attached new wage rates for “Hutchins Bridge Replacement – Arundel 17867.00”, “2012 Fair Minimum Wage Rates, Heavy & Bridge York County”.

In the Bid Book (page 63) “SPECIAL PROVISION, SECTION 403, HOT MIX ASPHALT”, **DELETE** in its entirety note 1. under “COMPLEMENTARY NOTES” which reads as follows “1. The use of Recycled Asphalt Pavement (RAP) will not be permitted.” Also **DELETE** all references to “Note 1.” under “Comp. Notes”. Make this change in pen and ink.

The following questions have been received:

**Question:** Special Provision Section 403 Hot Mix Asphalt Complementary Note #1 states that the use of Recycled Asphalt Pavement (RAP) will not be permitted. Will the Department consider allowing the use of RAP material in all mixes?

**Response:** Yes. The Department will allow the use of RAP on this project. Please see the above change.

**Question:** Special Provision Section 403 Hot Mix Asphalt Complementary Note #4 states that the design, verification, quality control, and acceptance tests for this mix be performed at 50 gyrations. Would the Department allow the 9.5mm wearing course to be changed to 75 gyrations?

**Response:** No.

Welders are classified in the trade to which the welding is incidental.

Apprentices - The minimum wage rate for registered apprentices are those set forth in the standards and policies of the Maine State Apprenticeship and Training Council for approved apprenticeship programs.

Posting of Schedule - Posting of this schedule is required in accordance with 26 MRSA §1301 et. seq., by any contractor holding a State contract for construction valued at \$50,000 or more and any subcontractors to such a contractor.

Appeal - Any person affected by the determination of these rates may appeal to the Commissioner of Labor by filing a written notice with the Commissioner stating the specific grounds of the objection within ten (10) days from the filing of these rates with the Secretary of State.
