Please make the following changes to the Bid Documents:

In the Bid Book:

REMOVE pages 78 - 81, Federal Wage Rates for Knox county, 4 pages, dated 01/05/2018, and **REPLACE** with the attached, revised Federal Wage Rates for Knox county, 6 pages, dated 03/16/2018.

REMOVE pages 82 - 85, Federal Wage Rates for Lincoln county, 4 pages, dated 01/05/2018, and **REPLACE** with the attached, revised Federal Wage Rates for Lincoln county, 6 pages, dated 03/16/2018.

The following questions have been received:

Question: Item 204.42 calls that any material necessary for shimming the shoulder must meet the 703.10 - Agg. for Untreated Surface Course and Leveling Course. Could the Department specify which gradation is needed, Type A or B?

Response: Type A or B is acceptable for this item. The contractor shall declare which Type shall be used and complete all work using Item 204.42 with the declared Type.

Question: Will the Department allow the contractor to keep 20% of the RAP from the milling operation to go back into the hot mix for this project?

Response: No, the Department will retain all millings.
