**Question:** Why is the current DBE/Subcontractor form being replaced?

**Response:** The Disadvantaged Business Enterprise (DBE) rules of the U.S. Department of Transportation at 49 CFR §26 have been amended.

The new regulations require that MaineDOT obtain specific information pertaining to every bid from each prime contractor and its subcontractors, regardless of certified DBE status. MaineDOT has replaced its <u>DBE Utilization</u> form with a new form called the <u>Commitment Confirmation</u>. The required information is on the Commitment Confirmation form and needs to be completed with your bid.

Consider these changes and information prior to submitting your bid on June 26, 2024.
