

**STATE OF MAINE DEPARTMENT OF TRANSPORTATION
NOTICE TO CONTRACTORS**

Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper "Bids for Pavement Milling, Hot Mix Asphalt Overlay, Drainage and Safety Improvements in the city of Portland" will be received from contractors at the Reception Desk, Maine DOT Building, Capitol Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on May 16, 2012 and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction, Paving or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Description: Maine Federal Aid Project Nos. STP-1733(700)X, WIN 17337.00, STP-1813(300)X, WIN 18133.00, AC-STP-1907(800)X, WIN 19078.00, AC-STP-1908(200)X, WIN 19082.00, and AC-STP-1909(400)X, WIN 19094.00.

Location: The sections of highway under construction in Cumberland County are:

Project No. STP-1733(700)X is on Baxter Boulevard, beginning at Forest Ave. and extending northeasterly 0.15 miles to Preble Street Extension.

Project No. STP-1813(300)X is on Vannah Ave, beginning at Clifton Street and extending westerly 0.29 miles to Forest Ave.

Project No. AC-STP-1907(800)X is located on Route 22, beginning at Stevens Ave. and extending westerly 1.61 miles to 0.01 mi. easterly of Johnson Road (Route 9).

Project No. AC-STP-1908(200)X is on Capisic Street, beginning at Stevens Ave. and extending westerly 1.27 miles to Brighton Ave.

Project No. AC-STP-1909(400)X is on Congress Street, beginning at Eastern Promenade and extending southwesterly 0.52 miles to Washington Ave.

Outline of Work: Pavement Milling, Hot Mix Asphalt Overlay, Drainage and Safety Improvements and other incidental work.

The basis of award will be Section 1 only.

They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m Bid Book \$10 (\$13 by mail), Single Sheets \$2, payment in advance, all non-refundable.

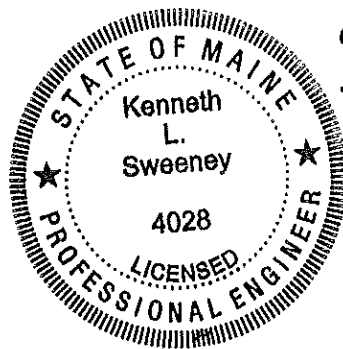
Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$60,000 payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.


This Contract is subject to all applicable Federal Laws. This contract is subject to compliance with the Disadvantaged Business Enterprise program requirements as set forth by the Maine Department of Transportation.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$10 [\$13 by mail], and Standard Details, Revision of December 2002, price \$20 [\$25 by mail].
