NOTICE TO CONTRACTORS

PROJECT: UNION BRANCH MULTIUSE PATHWAY

Sealed bids for the Union Branch Multiuse Pathway Project shall be submitted electronically to bidsubmit@portlandmaine.gov with the name of the Bidder, Contract Name and Bid number in the subject line until 3:30 p.m., Wednesday, September 10, 2025, at which time they will be opened and read. Proposals may also be submitted via USPS, UPS, FedEx, or in person to the City of Portland, Purchasing Rm. 103, 389 Congress St., Portland ME 04101. It is the bidder's sole responsibility to ensure that their bid is submitted prior to the date and time specified. Late or unsigned bids shall not be accepted.

PROJECT LOCATION: The project area includes the following locations:

- 1. The Union Branch railroad corridor from the parking lot adjacent to Hadlock Field to where the corridor meets State Street.
- 2. Several connecting pathways from the rail corridor into Deering Oaks.

OUTLINE OF WORK: The project includes, but is not limited to the following items:

- 1. Construction of an ADA compliant 12' wide asphalt multiuse pathway along approximately 3,400 LF of the Union Branch corridor.
- 2. Construction of several ADA compliant asphalt and concrete pathways connecting the Union Branch to Deering Oaks and other adjacent facilities.
- 3. Repaying/reconstruction of existing parking area(s).
- 4. Installation of stone dust between the existing rails to create a jogging path.
- 5. Installation of new shrubs, trees, and other landscape features along the pathway.
- 6. Placement of marker layer and clean fill to cover existing soils in accordance with existing VRAP Plan.
- 7. Associated storm drain piping, bioretention areas and drainage ditching work

BID FORM AND CONTRACT DOCUMENTS:

Only those firms represented at this meeting may bid on the project. **Anyone arriving late will not be allowed to attend the pre-bid nor submit a bid for this project.**

Construction under this contract will be funded by Federal Grants under the Federal Highway Administration and will be subject to all applicable requirements of the U.S Department of Transportation. It will be administered locally by the City of Portland in conjunction with the Maine Department of Transportation and will also be subject to all of their applicable documents.
