NOTICE TO CONTRACTORS**

Sealed bids addressed to the Maine Department of Transportation (Department), 16 SHS Augusta, Maine 04333-0016, and endorsed on the wrapper "**Bid for Demolition/Removal of one (1) Building Unit and any additions located at 17 Bridge Street in the Town of Gardiner, Maine**" will be received from contractors at the Reception Desk, Maine DOT Building, Capitol Street, Augusta, Maine, until **11:00 o'clock A.M.** (prevailing time) on **December 20, 2017** and at that time and place publicly opened and read. Bids will be accepted from contractors and building movers/wreckers that can demonstrate previous successful completion of projects of a similar size and scope. All other Bids may be rejected. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Description: State Funded Project No. WIN 018735.10D

Location: In Kennebec County, the building is located at 17 Bridge Street, in Gardiner, ME.

Outline of Work: Demolition/Removal of a 3-story wood frame structure with concrete/stone foundation, slab and any out buildings located at 17 Bridge Street in Gardiner. The building may be inspected by contacting Matthew Rodrigue of Maine DOT Property Office at (207) 462-5211 to arrange entry.

They also may be viewed and obtained digitally at no cost on the Department's website at <http://www.maine.gov/mdot/contractors/> or may be purchased from the Department between the hours of 8:00 A.M. to 4:30 P.M. by cash, credit card (Visa/Mastercard) or check payable to Treasurer, State of Maine sent to Maine Department of Transportation, Attn.: Mailroom, 16 State House Station, Augusta, Maine 04333-0016. They may also be purchased by telephone at (207)624-3536 between the hours of 8:00 A.M. to 4:30 P.M. Bid Book \$10.00 (\$13.00 by mail) single sheets \$2, payment in advance, all non-refundable.

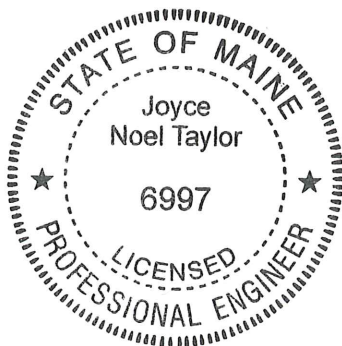
Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$750.00 payable to Treasurer, State of Maine, as a bid guarantee. If the low bid exceeds \$100,000.00, a Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the number of 100 percent of the Contract price, will be required of the successful bidder. If a bid indicates a credit to the State, the Department requires a bidder to forward a separate credit amount for the credit bid in the form set forth in the Special Provisions.

This contract is subject to all applicable State laws.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, November 2014 Edition", price \$10.00 [\$15.00 by mail], and "Standard Details, November 2014 Edition", priced at \$10.00 [\$15.00 by mail].
