

NOTICE TO CONTRACTORS

Sealed Bids addressed to the Municipality of Lewiston and endorsed on the wrapper “Bids for 2024-063 WIN 23669.00 Main Street Improvements and WIN 23669.10 Main Street Mill & Overlay in the Municipality of Lewiston” will be received from contractors at the municipal building, located at 27 Pine Street, Lewiston, ME 04240, at **2:00 o’clock PM (prevailing time) on January 7th, 2025** and at that time and place publicly opened and read.

The lowest responsive bidder must demonstrate to the Municipality that it is qualified to undertake the work to be considered for the award of this contract. Current pre-qualification by the Maine Department of Transportation in an appropriate category may fulfill this requirement.

Description: BID NUMBER 2024-063 Federal Aid Project No. 2366900 & 2366910, WIN 23669.00 & WIN 23669.10

Location: Projects are located in Lewiston, in Androscoggin County.

Outline of Work: Main Street Improvements includes 1.4 miles of variable depth mill shim and overlay, signal improvements, pedestrian ramp reconstruction, and other incidental work. Main Street Mill & Overlay includes 0.2 miles of a variable depth mill shim and overlay with pedestrian ramp reconstruction and ADA improvements.

The basis of award will be lowest sum of Section 0001 & Section 0002.

All bidders are required to attend a virtual on-line meeting scheduled for 12/10/24 at 9:30 A.M. A meeting notice and link will be sent prior to the meeting date and time. Attendance at this meeting by the Bidder or his/her qualified representative is a mandatory prerequisite for the acceptance of a bid from that Contractor. Meeting registration information shall be sent to all registered bidders.

Each Bid must be made upon blank forms provided by the Municipality and must be accompanied by a bid bond of 5% of the bid amount or an official bank check, cashier’s check, certified check, certificate of deposit, or United States postal money order for 5% of the bid amount, payable to Municipality of Lewiston, as a Bid Guaranty. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each for 100% of the Contract price, shall be required of the successful Bidder.

This Contract is subject to all applicable federal laws, as well as Disadvantaged Business Enterprise Program requirements as set forth by the Maine Department of Transportation (MaineDOT).

All work shall be governed by the MaineDOT’s Standard Specifications (March 2020) and Standard Details (March 2020), available online: www.maine.gov/mdot/contractors/publications/.
