NOTICE TO CONTRACTORS**

Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper “**Light Capital Paving** in the towns of **Brooks, Burnham, Dixmont, Jackson, Knox, Plymouth, Thorndike, Troy, Unity, and Waldo** and the city of **Belfast**” will be received from contractors at the Reception Desk, Maine DOT Building, Capitol Street, Augusta, Maine, until 11:00 o’clock A.M. (prevailing time) on **March 6, 2024** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Prequalification, or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening. Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.**

Location: In Waldo and Penobscot Counties, project is located:

Map ID 1 & 2 are in Belfast, Waldo, Brooks, Jackson, Dixmont, and Plymouth on Route 7 beginning at Route 137 and extending north 27.59 miles.

Includes paving shoulders and milling and paving Bridge #s 2894, 2287 & 5960.

Map ID 3 is in Belfast and Waldo on Route 137 beginning at Doak Road and extending northwest 5.96 miles to Route 131. Includes paved shoulders.

Map ID 4 is in Knox on Route 137 beginning 0.80 of a mile northwest of the Brooks town line and extending northwest 6.58 miles to Route 220.

Includes paving shoulders, truck lanes, and milling and paving Bridge #2440.

Map ID 5 is in Knox, Thorndike, and Unity on Route 220 beginning at Route 137 and extending north 7.42 miles to Route 9. Includes paving shoulders.

Map ID 6 is in Knox and Brooks on Webb Road beginning at Route 137 and extending east 4.02 miles to Route 139.

Map ID 7 is in Unity on Prairie Road beginning at Route 139 and extending north 1.67 miles to the Burnham town line. Includes milling and paving Bridge #s 2637 & 2641.

Map ID 8 is in Troy on Burnham Road beginning at the Burnham town line and extending east 1.07 miles to Route 220. Includes milling and paving Bridge #5569.

Map ID 9 is in Burnham on Troy Road beginning at Route 11 and extending east 6.08 miles to the Troy town line. Includes milling and paving Bridge #5144.

Map ID 10 is in Burnham on South Horseback Road beginning at the Unity town line and extending north 3.99 miles to Troy Road.

Outline of Work: Light Capital Paving and other incidental work.

Total length is 64.38 miles.

They may be purchased from the Department between the hours of 8:00 a.m. to 4:30 p.m. by cash, credit card (Visa/Mastercard) or check payable to Treasurer, State of Maine sent to Maine Department of Transportation, Attn.: Mailroom, 16 State House Station, Augusta, Maine 04333-0016. They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 (\$13 by mail), Single Sheets \$2, payment in advance, all non-refundable.

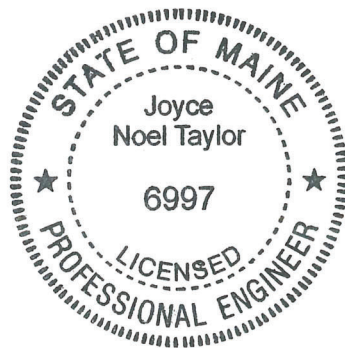
Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of 5% of the bid amount, payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.

This Contract is subject to all applicable State Laws.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, March 2020 Edition", price \$10 [\$15 by mail], and Standard Details, March 2020 Edition, price \$20 [\$25 by mail].
