

NOTICE TO CONTRACTORS

Sealed Bids addressed to the Municipality of Madawaska and endorsed on the wrapper “Bids for U.S. Route 1 Sidewalk Project in the Municipality of Madawaska” will be received from contractors at the municipal building, located at 328 St. Thomas Street, Suite 101, in the Boardroom, at **1:00 pm (prevailing time) on June 29, 2023** and at that time and place publicly opened and read.

The lowest responsive bidder must demonstrate to the Municipality that it is qualified to undertake the work to be considered for the award of this contract. Current pre-qualification by the Maine Department of Transportation in an appropriate category may fulfill this requirement.

Description: Federal Aid Project No. 2221800, WIN 22218.00

Location: Project is located Madawaska, in Aroostook County.

Outline of Work: The scope of work includes the installation of sidewalks and pedestrian crossings as well as the installation of catch basins, storm drain, and other incidental work.

The basis of award will be based on the lowest most responsive and responsible bid.

A Contract Performance Surety Bond and a Contract Payment Surety Bond, each for 100% of the Contract price, shall be required of the successful Bidder.

This Contract is subject to all applicable federal laws, as well as Disadvantaged Business Enterprise Program requirements as set forth by the Maine Department of Transportation.
